# Hassle, harassment-the other Ethnic girl abducted in name of land record office

People coming to the district land record office to get parcha (survey document) of their land are forced to give bribe for the purpose as a syndicate of employees and their brokers cause intentional delay and harass the service seekers in different ways.

During a recent visit to the record office at night, this correspondent found several people lying, some of them sleeping, under the open sky on the premises of the deputy commissioner's office, beside the record

Hearing arrival of a journalist, they got up to narrate their sufferings.

They alleged that the record room employees have made an unofficial 'rule' to take Tk 500 for delivery of a parcha and adopt different tricks to realise the bribe.

Md Ratan Mia, a poor farmer of Angurpara village under Baliakhora union of Ghior upazila, came to the record room of the deputy commissioner's office at around 4:00am for standing in a queue to take parcha from there.

"My serial number was The office closed at around 1:00pm after completing serial No 49. Now I am staying here at night along with some other people like me to get the parcha the next day," he said.

During the last Ramadan, private company employee Afzal Hossain, son of Nurul Islam of Kafatia village of Manikganj Sadar upazila, came to the record room at 4:00am to be at the head of the long line to get the parcha of his land. He stood in the line, his serial number

being 40.

"But a broker demanded Tk 3,000 from me for delivery of six parchas. As I declined, the broker made my serial No 60 instead of 40," he alleged.

Even after staying there for two days under the open sky while observing fast amid problem to take sehri and iftar, he failed to get parcha, he said.

Quite a few others have similar tales to tell.

Deputy Commissioner Munshi Shahabuddin Ahmed came to the record room premises to see for himself that several people were staying there, with hope to avail the front places in the line to get parcha the next day.

Overall situation, however, did not improve much even after that, said several sufferers.

"After failing to get my

record room employees and they provided it to me immediately," said Abdar Hossain, son of Helal Uddin of Gobindal village in Singair upazila.

Dewan Mizanur Rahman, a lawyer of Manikganj District Judge's Court, said, "My chamber is situated beside the record room. Many people are seen in front of the room even late at night as people coming from At around 10:00pm one parcha, I gave Tk 500 to different parts of the district

When contacted, Deputy Commissioner Munshi Shahabuddin Ahmed said he has already directed the official concerned to solve the matter soon.

The official concerned Executive Magistrate Kamrul Hasan said, "We are trying to find out the brokers and ensure smooth delivery of parcha to the people concerned."

### Road blockade in Dighinala

A 12-hour road blockade from 6:00am yesterday was enforced in Dighinala upazila of Kharachhari district demanding immediate arrest and exemplary punishment of the culprit, who raped a hill woman in Nalkata area of the upazila, on Tuesday.

Pahari Chhatra Parishad (PCP), Democratic Youth Forum (DYF) and Hill Women's Federation (HWF), front organisations of United People's Democratic Front (UPDF), staged the blockade programme at Larma Square on Khagrachhari-Dighinala Road.

Leaders and activists of the three organisations took out a procession at the upazila headquarters and then held a rally at Larma Square.

The rally was addressed, among others, by UPDF leader Kishor Chakma, PCP

leader Ankan Chakma, DYF leader Jiban Chakma and HWF leader Daizy Chakma. The speakers demanded

immediate arrest of the rapist. Otherwise, they threatened to launch a tougher agitation programme. A protest rally was also held in Khagrachhari Sadar upazila yesterday. The 25-year-old hill

woman was raped allegedly by a Bangalee settler in Nalkata area under Dighinala upazila at around 5:30pm on Tuesday.

Police quoted locals as saying that the woman was raped by one Azhar Ali of the area. Azhar had gone into hiding soon after the incident.

Officer in-Charge (OC) Sahadat Hossaion Tito of Dighinala Police Station said the victim's husband filed a case with the police station yesterday morning, accusing Azhar. "We are trying to arrest the accused," the OC said.

In Rangpur, a minor girl was killed by lightning at Badarganj upazila on Tuesday evening, reports our correspondent.

The deceased was identified as Khadija Khatun, 9, daughter of Hashem Ali of Dakkhin Baochandi Bottala village in the upazila. She was a student of Class II at Dakkhin Baochandi Bottala Government Primary School.

Nuruzzaman Chowdhury, Officer in-Charge of Baderganj police station said Khadija was struck by lightning while she was returning home from a crop field.

## Over 150 metres of Hazirhat dyke in Gaibandha damaged

More than 150 metres of the flood protection embankment at Hazirhat in Phulchhari upazila were seriously damaged by the swelling Jamuna following heavy rain in the last couple of days.

People of Singria, Udakhali, Ratanpur, Kathur, Uria, Katlamari, Haripur and Chandia areas near the embankment started leaving their homesteads for safer places.

Erosion by the river also rendered around 50 families of Namapara and Kamarpara villages in a number of villagers at

A dawn-to-dusk hartal protesting the attack on a local Awami League leader passed off peacefully in Panchhari upazila yesterday.

Bangalee settlers announced the hartal on Tuesday night protesting the attack on Abu Taher, general secretary of the upazila unit AL.

All kinds of vehicles went off the road and shops at markets of the town kept their shutter down as pickets took position in different areas since morning.

Acting police superintend Joynal Abadin said no untoward situation took place during the daylong shutdown.

Criminals attacked Abu Tahar in Baroitali area of the upazila at around 8:30pm, leaving him critically injured.

Following the incident, Pahari Banglaee Chhtra Parishad brought out a procession protesting the attack, said Alamgir Hossain, officer incharge at Panchhari police station.

The victim blamed the men of United People's Democratic Front (UPDF) for the attack.

Press and information secretary of UPDF Niron Chakma refuted the allegation, adding that the incident might be a sequel to the internal conflict of AL.
