Weeklong rain keeps aman farmers' hopes alive in Rangpur division

MEHEDY HASAN, Rangpur

Long expected rainfall at the end of rainy season has come as a relief for the farmers of transplanted aman (Taman) paddy in eight districts of Rangpur division.

In absence of sufficient rain during the peak period of the monsoon, farmers in this region had to depend on irrigation with electricitydriven deep tube-wells and diesel-run shallow pumps to save their crops but many farmers, especially the small and marginal ones, could not afford it.

However, the last one week saw a good amount of rainfall due to the depression in the Bay and Rangpur Met office recorded 301.3 millimetre rainfall from 6:00am on September 14 to 6:00am on September 20.

Against the backdrop of a drought-like situation, the rain has greatly benefited the farmers who had to count additional cost for irrigating their T-aman paddy fields, said Md Firoz Ahmed, deputy director of the Department of Agriculture Extension (DAE) in Rangpur.

adding that some of the late varieties can also be cultivated with this water.

With prospect of good yield now, the T-aman farmers in Rangpur division have urged the government to ensure fair prices of the crop.

The trouble soon spread to other places of the town. A restaurant and a few motorbikes were damaged. The rival factions also locked in clash in Shaistanagar area where they pelted brickbats on police as the law enforcers resorted to baton charge.

There had been a longstanding rivalry between the factions, one led by the Habiganj district BNP general secretary GK Gous, also Habiganj municipal mayor and the other by former state minister Syed Mohammad Faisal, also district BNP chief.

A human chain was formed in the city yesterday demanding rehabilitation of 44 poor Christian families who were evicted from a slum at Baptist Mission Road by a realtor on September 8.

Organised by Barisal Sangskritik Sangathan Samonnay Parishad, leaders of different socio-cultural organisations, professional bodies and human rights activists joined the programme on the premises of Ashwani Kumar Hall

speakers alleged that the hired goons of Olympic Properties (OPL) Limited forcibly evicted 44 poor Christian families from the land, violating a court injunction.

They demanded that the authorities concerned bring the land grabber to book, recover the land and rehabilitate the poor Christian families. The speakers also demanded withdrawal of the 'false' cases filed against the poor Christian families by the realtor and his men.

Later, they handed over a memorandum to the deputy commissioner demanding punishment to the land grabber and rehabilitation of the evicted families.


