### Court rejects family's plea against charge sheet

A Sylhet court yesterday rejected the "naraji" (no confidence) petition of the victim's family against the charge sheet in college teacher Harun ur Rashid murder case.

Sylhet Government Women's College teacher Harun was stabbed to death in front of his house at Goura Govinda Tila in the town on March 21, 2010 as he reprimanded his college student Sujina Akhtar Munni over her relationship with one Abdul LatifKawsar.

On May 3, 2011, the criminal investigation department (CID) filed the charge sheet with the court against Alimul Islam, Russel Ahmed, Kawsar, college students Munni and Safia Khatun Lipi and hotel manager Lokman Ahmed. Later, Harun's wife Afroza

Harun filed the naraji petition. The court also rejected the

prayer for fresh investigation by Rapid Action Batalion (Rab) and fixed October 23 for nexthearing of the case. The victim's family will

## Keep Subhan in jail

Simon said Subhan had been involved in the killing of eight Hindus of Kustiapara and Shakharipara of Pabna on April 17, 1971.

"About 1,000 people of Demra of Faridpur of Pabna were killed in early May 1971, by the Pakistani army. In that month, about 400 people of Nazirganj and Satbaria union of Sujanagar were also killed. Subhan was allegedly involved in the killing missions," the prosecutor said.

Simon said after the Liberation War, a case was lodged against him but he escaped to Pakistan along with war crimes accused Ghulam Azam.

The prosecutor feared he may flee again.

Tribunal-2 Chairman Justice Md Nizamul Huq then said, "Why do you want a warrant now?

"We are concerned about his allegations. He [Subhan] is Jamaat's nayeb-e-ameer and has been trying to hinder the war crimes trial in various ways.

"Subhan was leading propagation inside and outside the country and he may flee the country once charges are made under the International Crimes Tribunal Act," Simon explained.

The tribunal chairman said the accused was arrested in a case filed with the Pabna Police Station. He then issued the order to have him produced before the tribunal.

Meanwhile, a Pabna court denied Subhan bail in the vandalism case yester-

Pabna Superintendent of Police Jahangir Hossain said he had been informed of the tribunal's order to produce him before it and they would take steps accordingly.

Earlier, Tribunal-1 in the war crimes case against Ghulam Azam recorded the depositions of two witnesses from whom the investigation team collected evidence. The defence would cross-

examine them today. The Tribunal-2 yesterday

directed the authorities concerned to publish an ad in two national dailies asking war crimes accused Abul Kalam Azad to appear before it within 10 days of the ad publication. The tribunal headed by

its Chairman Justice ATM Fazle Kabir delivered the order as the accused could not be arrested. According to a police report the accused was on the run.

In the formal charges, the prosecution said the former leader of Islami Chhatra Sangha, student wing of Jamaat-e-Islami in 1971, was involved in the killing of at least 14 people and in two acts of genocide in Faridpur.

Azad went into hiding around seven hours before Tribunal-2 issued an arrest warrant against him on April 3. Meanwhile, Tribunal-2

adjourned the crossexamination of Syed Abdul Kaium, the 10th prosecution witness in the war crimes case against Jamaat leader Abdul Quader Mollah, as the defence counsels "could not" appear before the court "due to countrywide hartal".

When yesterday's court proceedings began around 10:50am, Gazi MH Tamim, a junior member of the defence team, told the tribunal that senior members of the team could not come due to the hartal and sought adjournment until today.

#### Wait is over for Snow White fibre crop species including jute and "Now that we traced out all to the deadly fungus --

macrophomina phaseolina. BJRI breeders told The Daily Star that unlike other jute fibres, the fibres derived from Snow White variety do not require bleaching, and it has got all the potentials of being commercially used in threads, fabrics and garments.

"Its (Snow White) fibres could have been used alongside cotton at a 30-70 percent ratio and it would 've greatly reduced our import dependency for cotton. But after the invention of this special breeding line (Snow White), we found out that the variety is highly susceptive to macrophomina phaseolina,' explained, biotechnologist Dr Shahidul Islam of BJRI.

Dr Islam, who was in the core team that Maqsudul Alam led in decoding the fungus genome, said despite all the potentials of the new jute variety, "We had to withhold its release to farmers because of fungi-susceptibility.

the protein tools of macrophomina phaseolina and how it causes colossal damage to jute, in general, and this (Snow White) variety, in particular, we'll be able to engineer an immune system in the plant so that Snow White

withstandsthefungaldamage."

Dr Islam went on, "We at BJRI even tried to develop a line (pre-variety stage) by crossbreeding Snow White with another line so that it no longer remains susceptive to macrophomina phaseolina. But that experiment in 2007 did notwork as we ended up getting a line comparatively much less susceptive to the fungus but at the same time it lost many of the expected characteristics of SnowWhiteline."

On Wednesday, Prime Minister Sheikh Hasina announced in parliament that Dr Alam and his team decoded the genome of the most deadly fungus that causes seedling blight, root rot and charcoal rot and enhance, reduce or add of more than 500 crop and non-

soybean. The gene sequencing of

macrophomina phaseolina would particularly help Bangladeshi scientists to develop jute varieties capable of fighting the fungus that causes an annual yield loss of around Tk 4,000 crore damaging 30 percent of the country's precious natural fibre, experts

Jute is the second biggest fibre crop next to cotton. And Bangladesh is the world's second-biggest producer of jute, next to India, and the biggest exporter of the natural Genome sequencing helps

scientists find genes much more easily and quickly. It allows scientists identify and understand how genes work together on a plant's various features like growth, development and maintenance as an entire organism. This allows them to manipulate the genes certain features of the plant.
