DoE fines textile factory Tk 29 lakh in Dhamrai

The Department o Environment (DoE) yesterday fined a textile mill Tk 29 lakhs in Dhamrai on the outskirts of the capital for polluting river Bangshai with untreated chemical effluent.

An enforcement team of the DoE found that the effluent treatment plant of "The Immaculate Textile Ltd" was grossly defective and unable to treat the waste matter of the factory, said a DoE press release.

The factory has been releasing untreated effluents into the river through a concealed bypass drain, said DoE Director Mohammad Munir Chowdhury who handed down the penalty and ordered to seal the factory off.

An instant examination revealed that the untreated liquid effluent contained no dissolved oxygen though required level is 4.5 to 8 milligrams per litre, he said.

Such effluent is deadly for aquatic life and overall environment, he said adding that the factory has released nine crore litres of liquid effluent into the river in past one year.

The factory's managing director Kazi Iftekhar Ahmed made a formal pledge to the DoE to rectify the factory's fault within a month, said Munir.

Contacted, Iftekhar Ahmed said there was no bypass drain of the factory for releasing liquid effluent. But it had drain to discharge other waste water.

He, however, admitted that required oxygen kevel was not present in the effluent and that he gave an undertaking to resolve the problem.

INDIGENOUS PEOPLE'S LANDS Law minister for ban on sale to outsiders

Law Minister Shafique Ahmed yesterday said there should be a law that prevents the indigenous community from selling their lands to people outside their community.

The minister was addressing a seminar styled "Land problems and legal rights of the ethnic group/indigenous community in greater Mymensingh", organised by Caritas Perlam-MJF project, a joint initiative of Caritas and Manusher Jonno Foundation, at Jatiya Press Club in the capital.

He suggested the plain land indigenous people draft districtwise lists of indigenous community lands, which have been occupied illegally or declared as vested property.

If lands of indigenous community are declared as vested property, the land ownership claimants should file their claims with tribunals that have been set up to deal with this issue, Shafique said.

"We will extend maximum legal support to protect your (indigenous) lands," he said.

State Minister for Social Welfare Promode Mankin said the parliamentary caucus on indigenous people is working on formulating indigenous people's rights act to protect their rights.

Presenting a paper, Bangladesh Adivasi Forum General Secretary Sanjeeb Drong placed a 10-point recommendation to protect land rights of indigenous people.

The recommendations include -- formulation of separate land commission for plain land indigenous people, formation of national indigenous commission, constitutional recognition of indigenous people, and punishment to illegal land occupiers.

Rina Roy, director (rights) of Manusher Jonno Foundation, also spoke on the occasion.

New plant in Munshiganj to treat Padma water

Dhaka Water Supply and Sewerage Authority (Wasa) is going to set up a water treatment plant at Jasholdia point of Munshiganj, with a capacity of supplying 45 crore litres of water per An agreement was signed yesterday

between Dhaka Wasa and China CAMC Engineer Com Ltd in this regard. CAMC will construct the plant in 42 months. The plant would reduce to a large

extent city people's dependency on ground water, said Abu Alam Mohammad Shahid Khan, local government secretary, while delivering a speech as the chief guest at the signing ceremony at Sonargaon Hotel in the capital.

Water from the Padma river would get treated at the plant and then pass through 33-km long pipe lines to the distribution lines near Mitford Hospital

before it is supplied in Dhaka city.

The Chinese government will provide around Tk 2,500 crore out of the estimated cost of Tk 3,500 crore in soft loans and the remaining expense of the Padma Water Treatment Plant will be borne by Bangladesh.

This is the first time China is financing a treatment plant, Shahid said. The process of land acquisition for the

plant is underway and the construction work will start this year. The plant will be constructed on 94 acres of land, a Wasa official said. Currently, Wasa can supply around 210

crore litres of water per day, 87 percent of which comes from ground water and the rest from surface water treated by four treatment plants.

Excessive extraction of water legally and illegally by deep tube wells is lowering the ground water level in the capital, posing a risk to the city's future.

Two JMB men arrested

On information that some fugitive JMB activists returned to villages and trying to reorganise the outfit, the Rab arrested them raiding Taherpur area.

Arrest warrants were issued against them and they are charge sheeted in extortion and torture cases, said ASP Mirza Golam Sarwar of Rab-5.

CARETAKER GOVERNMENT SC verdict reflects govt's will

Says JAF president

Jatiyatabadi Ainjibi Forum (JAF) President Rafiqul Islam Mia yesterday said the Supreme Court verdict "given by former chief justice ABM Khairul Haque declaring the caretaker government system illegal is a reflection of the present government's will".

Khairul Haque has given the verdict in order to satisfy the ruling Awami League and bring this party to the state power again, he said, while addressing a press conference organised by JAF, a body of pro-BNP lawyers, on the Supreme Court Bar Association premises.

Rafiqul said Khairul Haque in his verdict had suggested formation of a caretaker government comprising elected representatives, which he had not said in the short order.

The inconsistency between the short order and the full verdict is unprecedented, he said, adding that the recent verdict

given by Khairul was the most controversial one in the world. Replying to a question, Rafiqul said three other judges, who agreed with Khairul Haque's opinion in the judgement, were also responsible for the disputes created over the verdict.

Minimum educational qualification sought

Speakers at a roundtable yesterday called for fixing a minimum education qualification for the members and chairmen of the governing bodies of non-government schools and colleges.

The people who have at least obtained the Secondary Schoo Certificate should be selected as members, while the chairmen should have a bachelor degree, they said.

Education Minister Nurul Islam Nahid slightly differed with the recommendation, saying the qualification would have to be fixed considering all educational institutions of the country.

Many people want to be in the governing bodies for personal interests but one should have a mindset for serving the institutions, he told the roundtable, "Governing bodies of nongovernment educational institutions: Experience and responsibilities", at a hotel in the capital.

Parliamentary Standing Committee on Ministry of Education organised the programme. Urging the members and chairmen of the governing bodies

to work impartially, Nahid said, "Schools or colleges do not belong to a particular party. Everyone's children study there." Prof Fahima Khatun, chairman, Dhaka Education Board pointed out the issue of lawmakers' interference in the forma-

tion of governing bodies and school managing committees.

Man killed, girl found dead in capital

A man was killed and a girl was found dead in the capital's Lalbagh and East Shewrapara areas yesterday.

Mohammed Mofiz, 40, a security guard at Anwar Polimar Factory in Raj Narayan Dhor Road area of Lalbagh, was killed by miscreants as he tried to prevent them from entering the factory area around 7:00pm.

With several injuries in his body, Mofiz was rushed to Dhaka Medical College Hospital where doctors declared him dead.

Police suspect the incident of killing might have been occurred following an ongoing feud between the factory owner Delwar Hossain and his brother Badal. Contacted, Delwar said some local extortionists

demanded Tk 1 lakh from him about one and a half months

There might have a link between the attack on Mofiz and the threats he received from the extortionists, he said. In another incident, the body of an unidentified girl was

recovered from a narrow alley behind a four-story building

in East Shewrapara area. The body was sent to the Dhaka Medical College morgue

for autopsy.
