Flood hits over 2.5 lakh in Gaibandha, Kurigram

Flash flood caused by heavy rain in the last few days in Gaibandha and Kurigram districts has left over 2.5 lakh people marooned.

Downpour in the last two days followed by onrush of water from the upstream flooded three upazilas of Gaibandha, reports our correspondent.

Low lying areas of Jamuna river basin in Sadar, Phulchhari and Shaghata upazilas went under water affecting over 1.5 lakh people, said Water Development Board (WDB) sources.

At least 15 villages in Sadar, 18 in Phulchhari and 13 in Shaghata have been flooded. Phulchhari and Kamarjani markets went under water.

Crops including aman paddy, pulse and vegetables on about 4,030 hectares of land were washed away by the floodwater, said Mir Abdur Razzak, deputy director of agriculture extension department, Gaibandha.

A flood control embankment at Ratanpur in Phulchhari upazila faces a serious threat of collapse due to erosion, he said.

During a visit, this correspondent found a number of villagers leaving their homesteads and cattle for safer places in fear of erosion.

Hafizur Rahman of Kabilpur village in Pulchhari said the floodwater damaged aman paddy on two bighas of his land.

Mosharraf Hossain, chairman of Shaghata union, said the flood affected people in this union have taken shelter on road and embankment.

Away in Kurigram, more than one lakh people remained marooned due to flood in 20 unions of six upazilas, reports our correspondent.

The flood, caused by heavy rain, has affected the people of over 300 chars and villages of Brahmaputra River basin in Nageswari, Sadar, Ulipur, Chilmari, Roumari and Rajibpur upazilas.

The water o Brahmaputra was flowing 35 centimeters above danger mark yesterday afternoon, said Kurigram WDB sources.

Subhan sent to central jail from Pabna

Detained Jamaat leader Moulana Abdus Subhan was sent to Dhaka on Tuesday night amid the tight security. Earlier the International

Crimes Tribunal issued a warrant on Sunday to produce the Jamaat leader in the court.

The law enforcers arrested nayeb-e-ameer of Jamaat-e-Islami Maulana Abdus Subhan from Bangabandhu Bridge toll plaza in Tangail on September 20 in connection with a case filed on charge of violence. He was sent to jail on the same night.

Subhan's counsel submitted a bail prayer on Sunday but it was turned down. Later the tribunal issued a warrant to produce him before it within September 30.

Pabna Police Superintendent Jahangir Hossain Matobbar said, following the warrant of the tribunal Subhan was shifted to Dhaka Central Jail from the Pabna jail on Tuesday night.

Man gets life for killing wife

A court here on Monday sentenced a man to life term imprisonment for killing his wife in 2007.

The convict, Abdul Malek, 36, son of Abu Hossain Sarker of Khudromonohara village of Ullapara upazila, was also fined Tk one lakh, in default to suffer one more year in jail.

According to the prosecution, Malek beat up and set on fire his wife Marium Khatun, 30, mother of two children, causing her death on April 3 2007 as she protested his extramarital relation with a woman.

Schoolboys kidnapped from Dhaka city rescued in Noakhali

Rapid Action Battalion (Rab) yesterday rescued three schoolboys from Babunagar village in Begumganj upazila of the district.

The three were kidnapped from capital Dhaka on September 18 for ransom.

Assistant Commissioner of Rab-11 Kamrul Islam, who led the drive, said a gang abducted Ashique Mahmud, 12, son of advocate Bhuiyan Alamgir Hossain, Md Amir Hossain, 12, son of Abul Hossain and Md Rafique Hossain, 13, son of Abul Kashem.

All the victims were students of Cambrian School and residents of Court State House in Judge Court area of Dhaka.

The kidnappers took the boys to Babunagar village under Begumganj upazila in the district and phoned the families, demanding Tk 10 lakh as ransom for release of each victim.

The guardians of the boys lodged general diaries and the cases were later transferred to Rapid Action Battalion (Rab-11).

Tracking the mobiles, Rab located the spot and rescued the boys with the help of Begumganj police.

The abductors fled the scene but Abdul Gofran, a former union parishad member, was detained in this connection.

Ashique's father Alamgir Hossain told UNB that some unidentified criminals abducted his son at 9:30am from Mohakhali area in the capital while he was going to school.

He said the kidnappers took Ashique to different places including Pubail in Dhaka and then to Noakhali. They also demanded Tk 10 lakh as ransom

from his family over mobile phone, he said.

Youth gets life for patricide

A court here yesterday sentenced a youth to life term imprisonment for killing his father. Additional District and Session Judge in Tangail Bazlur Rahman handed down the verdict against Samimi Fuad Hridoy, 20, a second year student of the Government MM Ali College in the town. The judge also fined the convict Tk 50,000, in default, to suffer one more year's imprisonment. According to prosecution, Hridoy shot his father Abul Kalam Azad, 50, at their Paradise Para residence in the town on January 3 on 2010 as Azad refused to buy him a motorbike. Seriously injured, Abul Kalam Azad, owner of 'Book Land' bookstall at Victoria Road in the town, succumbed to his injuries on the same day at Tangail General Hospital.

Suspected killer arrested

Rapid Action Battalion (Rab) yesterday arrested one of the suspected killers of union parishad (UP) chairman Nur Islam from Kumrkhali upazila and recovered two light guns from his possession. The arrestee was identified as Abu Daud alias Kanon, 22, son of Ashraf Pramanik of Sengram village under Pangsha upazila in Rajbari district. Captain Musudur Rahman, Company Commander of Rab-2, Kushtia unit told newsmen that they raided the Kumarkhali bus stand area on information that Kanon, one of the suspected killers of Nur Islam, was in the area at about 9.30am and arrested him. Kanon confessed to his involvement in the killing of Nur Islam on August 28 on a boat in Padma River, he said.

Two arrested with bombs

Rab men arrested the two when they were keeping it at a shop owned by local UP member. Rab Commander MA Ashraf Ali of Jhenidah said that the two men were trying to trap UP member Abdul Bari Jana by keeping the bombs at his shop. Jana is UP member of 6 No. ward in Ganna union under Sadar upazila.

Boy drowns in pond

A four-year old boy drowned in a pond adjacent to their dwelling house at Sukhnagar in Gaibandha Sader upazila yesterday. Gaibandha firefighters said Shiban, son of Fariduddin of the village was playing on the bank of pond. Suddenly he fell into the water and drowned as he was too young to swim ashore. Divers rescued the victim from water and sent him to Gaibandha Sadar Hospital but it was too late.
