



ICAB recognizes through National Award for Best Presented Annual Reports not only based on the accountability, transparency, and good governance which are the basic features of quality financial reporting but also disclosing their contribution to the nation by evaluating the economic, environmental, and social performance of the entities towards the goal of sustainable development. It is the effort of the Institute to appreciate the practice of sustainable reporting by the entities. On the eve of celebrating the 12th ICAB National Awards for Best Presented Annual Reports 2011, it is obvious to enunciate that

this Award Giving Ceremony brings forth much enthusiastic exuberance to the Accounting professionals and their splendid contribution to the business entities highlighting the key traits of Good Corporate Governance as evidenced in their annual reports. We believe this process helps generating and expediting national revenue collection, good governance, and last but not the least a corruption free society. Since 2001, ICAB started this process, and then onward Bangladeshi Entities were encouraged and were able to get the SAFA awards.

With a view to search out the timely, relevant, objectively comparable, and credible information of the audited financial statements and annual reports, the ICAB-Review Committee for Published Accounts and Reports (RCPAR) evaluates the submitted Annual Reports of different entities. Therefore, the ICAB National Award encourages and implements Best Practices in Financial Reporting within the realm of International Accounting Standards and Financial Reporting Standards. It reflects ICAB's firm commitment in promoting a global accountancy profession and thereby accelerating the sustainable economic growth in Bangladesh.

The award competition is expected to improve and enhance the level of harmonization in financial reporting and auditing practices through adequate application of International Auditing and Financial Reporting Standards as adopted by ICAB. The Review Committee for Published Accounts and Reports selected the winners through a meticulous process of competent, fair and transparent evaluation. To make it more credit worthy, we have incorporated the participation of the representatives of the relevant regulatory bodies like Bangladesh Bank, SEC, NBR, etc. in the evaluation system. Due to significant improvements in presentation of annual reports 2011, some entities awarded better position than that of the previous years, which entails a healthy competition among the entities promoting accountability, transparency, and good governance. Consequently, the Annual Reports of the winners of first, second and third positions in different categories have already been nominated for participation in the SAFA Forum to compete with those of SAFA Countries. It is noteworthy that, the ICAB nominated Annual Reports from Bangladesh are significantly qualifying for the SAFA Awards over the years with the continuous improvement. Hopefully, in this year the ICAB nomination will occupy significant positions for its excellence to receive the SAFA Awards.

ICAB is the learning partner of the institute of the Chartered Accountant in England and Wales (ICAEW). ICAB qualifications are recognised by ICAEW through a MoU between the two Institutes. ICAB is very strong compliant of the IFAC SMOs which covers quality assurance, international education, financial reporting and auditing standards, professional code of ethics etc. ICAB is also working with the National Board of Revenue, Bangladesh Bank, Office of Comptroller and Auditor

General (OCAG) of Bangladesh on professional issues, training, and knowledge sharing to enhance the quality of financial reporting and auditing in private and public sector to bring synergy in the national development.

To add more value to our economic development through the CA Profession, ICAB is working to open up and create new avenue for the professionals. With that aim, ICAB is at the final stage to sign a MoU with CGA Canada. ICAB also held several discussions with other Professional

Accounting Bodies like CICA, CPA Ireland, Australia etc. As a major initiative, on 27 June 2012, an agreement of the Project on "Promoting Public Private Partnership for Improved Audit Quality Assurance" was signed between World Bank and ICAB and for the first time ICAB has been appointed as the consultant of the Project. The main objective of the concerned Project is to develop a partnership framework enabling the Institute of Chartered Accountants of Bangladesh and the Office of the Comptroller and Auditor General to collaborate

Being the custodian of International Accounting and Auditing Standards, ICAB is not only involving with the review, adoption, publication and dissemination process but also make these standards understandable and user friendly through training and workshops. Moreover, during the year ICAB is going to launch an online IFRS Certification Program jointly with ICAEW through a contract signed between ICAB and ICAEW on 12 July 2012, which will adequately educate the preparers of these

and strengthen their capacity to minimize the knowledge gap of the professionals involved to enhance the effectiveness and quality of the public and private sector

In April 2012, ICAB organized a 3-day International Workshop on IFRS for SME in Dhaka jointly with IFRS Foundation and SAFA for its members and different stakeholders. From June 2012, ICAB has been conducting training on Tax Audit of Financial Statements in compliance of IFRSs and ISAs as adopted by ICAB. ICAB is also going to organize an extensive training for Bangladesh Bank Officials on application of IFRS in preparation of Financial Statements. Besides, ICAB has been organizing different training on financial reporting, corporate laws and regulation and other professional issues to Microcredit Regulatory Authority, Power

Development Board, etc. At this inspiring moment, I sincerely convey my heartiest congratulation to the winners of the 12th ICAB National Awards for Best Presented Annual Reports 2011 and wish their success in future. At the same time, my sincere thanks to all other participant entities to make this competition challenging and meaningful and hope that they will put their best endeavor to high level of performance in the coming years.
