BEGGARS' REHABILITATION 'ANOMALIES'

JS committee wants expenditure details

Members of the parliamentary standing committee on social welfare ministry yesterday expressed dissatisfaction over anomalies regarding the expenditure of around Tk 7 crore government funding for the rehabilitation of the capital's beggars.

Beggar numbers did not go down through the use of the Tk 7 crore last fiscal year, said the parliamentary body, asking the ministry to provide a report at its next meeting detailing the money's expenditure and the beneficiaries.

"Beggars were not rehabilitated. We still see their usual presence on the streets. We sought to know how the money was spent but the ministry's officials could not give a

satisfactory reply," said one member, Apu Ukil, after a meeting at Jatiya Sangsad Bhaban.

The ministry spent Tk 6.70 crore out of

the Tk7 crore to implement a rehabilitation project for beggars by providing them alternative employment. The parliament secretariat, in a press

release, said the committee asked the ministry to investigate the alleged irregularities in the expenditure and the money's distribution among non-government organisations.

The committee also asked the ministry to come up with the list of 10,000 beggars, surveyed in the pilot project, with their photographs and bio-data.

The government allocated Tk 10 crore in the current fiscal year to rehabilitate beggars.

Qamrul's nephew burnt to death

A nephew of State Minister for Law Md Qamrul Islam was burnt to death at his West Kazipara residence in the capital yesterday morning.

Neighbours broke open the door to the flat of Ahmed Shawkat Masud, 39, at about 8:00am after they saw smoke emanating from it.

He was first taken to a local hospital and later shifted to Dhaka Medical College Hospital (DMCH) where doctors declared him dead. Nazrul Islam, security guard of the build-

ing where Masud lived, said after seeing smoke, residents of neighbouring houses and locals rushed to the building. They knocked on Masud's door and after receiving no response they broke it down.

They took Masud, who was critically he said.

injured, to the hospital.

Visiting the spot, The Daily Star found part of Masud's bed completely burnt and the whole flat blackened due to smoke.

Sources at DMCH said the body from the waist down had deep burn marks. Mohammad Rasel, victim's cousin, said

Masud had been frustrated recently.

Masud had left his job at a bank to manage a family business and had been living alone for a year as he and his wife were estranged, Rasel said.

He said Masud's family believes either Masud committed suicide or the fire started accidentally. They do not think it was a case of arson, he added.

Nasimuddin, station officer at Mirpur Fire Station, said they visited the spot and found a burnt laptop but it did not burst.

The reason for the fire is still unknown,

200 shanties gutted in Sattola slum
