Another issue the operators have is with the size of the spectrum they are obliged to purchase via the auction. The draft guidelines say it

is 10 MHz spectrum from the

2100 MHz frequency band,

but the operators would like B a n g l a d e s h to purchase 5MHz of the spectrum -- to save costs.

Given the exponential rise in demand for internet data and the fact that Bangladesh is a highly populated country, 5MHz spectrum bands would vield poor quality of service, according to Bose. "The ministry is considering

the matter, though. We shall sit with the operators again after compiling their suggestions and the requirements of the government," he said. The operators also

requested for extension of the tenure of the 3G licence to 20 years from the 15 years put in the draft.

The BTRC forwarded the draft guideline for the 3G spectrum auction to the telecom ministry in March.

A total of five 3G licences are available, of which three have been assigned for the current private operators, one for the state-owned Teletalk, and one for a new entrant.

3G, short for 3rd generation, is a term used to represent the 3rd generation of mobile telecommunications technology, which allows video telephony and broadband-speed internet access.

FROM PAGE 20 investigation agency's probe reports on the alleged war crimes committed by the two men, particularly the killing of intellectuals on the eve of liberation in December 1971.

Earlier yesterday, Ataur Rahman and Shahjahan Kabir, members of the investigation agency of international crimes tribunal, submitted the probe reports to the prosecution at its office in the old High Court building in the capital.

Prosecutor AKM Saiful Islam told reporters that his team would scrutinise the reports as part of its preparation for formal charges.

He said the prosecution would take at least one month time to scrutinise the reports and hoped to submit formal charges within one or one and a half months. The investigation agency

finished its probe Tuesday and claimed that it had found evidence linking the two with torture and the killing of at least 18 intellectuals between December 10 and 15, 1971.

Nine of the killed were

Dhaka University teachers, six were journalists and three were doctors.

Mueen-Uddin, of Feni, has been living in London for decades while Ashrafuzzaman, of Gopalganj, is now in New York, USA, the agency officials had said.

As per the last amendment to the International Crimes (Tribunals) Act, 1973, the war crimes trial against the two could begin in their absence, Saiful said yesterday.

Mueen's lawyer Toby Cadman yesterday told the BBC Bangla Service that they would respond accordingly if prosecutors of the tribunal urged the British government to hand Mueen over to Bangladesh to face trial.

led by Justice ATM Fazle Kabir fixed the date after Sahidur Rahman, a prosecutor in the case, informed the court that it had delivered the charges and other documents for Azad's state-appointed defence.

Azad, also known as Bachchu Razakar, went into hiding around seven hours before Tribunal-2 issued an arrest warrant against him on April 3.

On October 7, the tribunal

decided to hold the trial of the expelled Jamaat-e-Islami member in absentia as he did not appear before it even after publication of newspaper advertisements asking him to do so.

Yesterday, Tribunal-2 completed recording the testimonies of three prosecution witnesses behind closed doors in the war crimes case against Jamaat leader Muhammad Kamaruzzaman.

It also completed recording the cross-examination of one of the three female witnesses in the case. On Tuesday, the tribunal

allowed four out of eight additional witnesses to give their testimonies behind closed doors. In line with the court's directives, accused Kamaruzzaman

and three lawyers from the prosecution and three from the defence were present in the courtroom during the proceedings, Prosecutor Nurjahan BegumMuktatoldTheDailyStar. Cross-examination of two

witnesses will be held on October 14, she added.

Following a petition of another war crimes accused, Jamaat leader Abdul Quader Mollah, the tribunal directed the jail authorities to make necessary arrangements for his medical treatment.
