# Suicide blast hits Pak market; 16 killed

A suicide bomber yesterday blew up a car at a crowded market in a northwestern Pakistani tribal town, killing at least 16 people and wounding 30 others, officials said.

The blast ripped through the main market in Darra Adam Khel near to a local antiinsurgent peace committee office, which officials said was the target of the attack.

"The death toll has risen to 16 and 30 others were wounded," local government official Fakhar-ud-Din told AFP.

He said it was not immediately clear how many peace committee members were killed or wounded because the bombing occurred in a crowded street and many shoppers were victims.

Information minister for Khyber the capture of her attackers. Pakhtunkhwa province Mian Iftikhar Hussain said: "It was a suicide attack and the target was the local peace committee."

Two other officials confirmed the bombing and the death toll and said some of the wounded were shifted to other cities for treatment as local health facilities were not sufficient.

Nobody immediately claimed responsibility for the attack, the officials said.

The peace committee comprised a breakaway group of former militants who ditched their Taliban colleagues and formed a militia supporting local elders and government efforts against militancy, a local intelligence official said.

Semi-autonomous Darra Adam Khel lies between the northwestern towns of Peshawar and Kohat and has experienced several suicide attacks and bombings blamed on Taliban militants.

Taliban on Tuesday shot schoolgirl rights activist Malala Yousafzai, 14, in the head as she boarded a school bus in the former Taliban stronghold of Swat. Authorities offered a reward of more than \$100,000 for

Prayers were held in schools across Pakistan yesterday for Malala. The girl, who had campaigned for the right to an education, was picked out by name by an armed man on a bus, and shot in the head.

A military spokesman said she was still on a ventilator in hospital on Saturday and that the next 36 to 48 hours would be critical.

Omar Faruk, a youth of Ramu, claimed his friend Abdul Moktadir alias Alif, student of a private polytechnic institute in Chittagong, came to his mobile repairing shop in the evening of September

According to Faruk, his friend signed in to his facebook account and made a scene finding Uttam's profile page bearing the anti-Islam photo.

Moktadir and Faruk claimed they had taken screenshots of the "profile page belonging to Uttam".

The fabrication of screenshot could be the first part of the plan behind the mayhem and bringing rioters from outside Ramu

the second part. Why the plotters chose Uttam's profile is not clear yet. Uttam, an underprivileged assistant deed writer, has been on the run along with his wife and child

since the night of the incident. One thing is evident in the screenshot that some-

one called "Abdul Muktadir" had entered Uttam's profile though he was not a facebook friend. Uttam's profile was not restricted.

The facebook account of "Abdul Muktadir" is not accessible anymore.

But Faruk's friend who came to the shop in September 29 evening is registered at Chittagong Polytechnic Institute as Abdul Moktadir.

He was detained by

police on October 9. "My son is a very bright student. He got stipend when he was in school. He has hearing problem but his memory is very sharp," said his mother Sajeda Begum at his house at Fakirabazar on October 6.

She refused to help The Daily Star meet his son Moktadir and repeatedly requested this correspondent to drop the idea of writing about the matter.

"He can fix mobile phone problems and he has very good computer knowledge as he studies computer engineering in

facebook account. They did this as two strangers in his shop were unhappy seeing the pictures on their facebook, he said.

They saved the pictures after the strangers left, said Faruk, adding that they had to download some software to do it.

Faruk said they created the files to prove to the locals that the picture insulting the Quran did not belong to them and was

from Uttam's profile. He also added that Uttam's account suddenly disappeared within a short time after they saved the images. Faruk's claim was very confusing as no one else, except the account holder, can deactivate a facebook account.

And, moments after the departure of the two strangers, there was a continuous flow of people curious to see the pictures. All of them were shown images stored in Faruk's computer.

The people with no knowledge about social networking site facebook believed that was Uttam's facebook page with the anti-Islam image.

Faruk and Moktadir not only exhibited fabricated screenshots of Uttam's facebook profile, but also stored many pictures downloaded from "Insult allah" and the Quran-insulting photo, which was later circulated from mobile phones to mobile phones via Bluetooth.

She defended Moktadir and vigorously discouraged the correspondent to write about him.

WHO IS ALIF? Moktadir is known as Alif in Ramu Bazar area. His mother said Alif was his nickname.

The nick was not used in the facebook account of "Abdul Muktadir".

However, The Daily Star found a facebook account of "Abdul Muktadir Alif".

Very little information was found the profile as it is restricted to non-facebook friends of "Abdul Muktadir Alif". It said "Abdul Muktadir Alif" studied at Ramu High School. The profile picture was of a boy but sex was mentioned as

female. Interestingly, Faruk also uses the nick Alif for his facebook account even though it is not his name.

Asked on October 3, Faruk said he just used it for his facebook account as he liked this nickname of his friend.

## Hope of Palestine state fading

A renewed Palestinian bid to seek upgraded UN status may be aimed at saving the "two-state solution" but many believe the idea of an independent Palestine alongside Israel is looking increasingly unrealistic.

"The two-state solution is the only sustainable option. Yet the door may be closing for good," UN Secretary General Ban Ki-moon warned last month just days before Palestinian president Mahmud Abbas launched a fresh bid for upgraded status at the United Nations.

"We have reached a critical point," senior Palestinian official Hanan Ashrawi recently told reporters in Ramallah.

"Israel has been allowed to undermine the two-state solution to the point where this is a last-ditch effort to try to rescue the chances of peace and the two-state solution by the Palestinians," she said.

With the peace process deadlocked for more than two years, the concept of the one-state solution -- a bi-national entity on land encompassing Israel and the Palestinian territories -- is gaining ground. In recent months, the idea has become a hot topic of

discussion across the Palestinian territories, its merits and shortcomings taking up an increasing number of column inches in the local and international press.

A survey published in May by JMCC, a Jerusalem-based Palestinian research centre, showed that one in four Palestinians -- or 25.9 percent -- were in favour of a bi-national

state, compared with 22.3 percent six months earlier. And a more recent joint Israeli-Palestinian survey conducted last month found that 30 percent of and 31 per-

"Creating two neighbouring states for two peoples that respect one another would be the best solution," wrote Israel's former parliament speaker Avraham Burg in the New York Times. "However, if our shortsighted leaders miss this opportunity, the same fair and equal principles should be applied to one state

for both peoples," said Burg, a longtime proponent of the idea. The concept of a bi-national state is not new. Until the 1980s, the Palestine Liberation Organisation (PLO) campaigned for a "democratic" Palestinian state on

the territory that comprised mandatory Palestine prior to the establishment of the Jewish state in 1948. When Israel and the Palestinians signed the 1993 Oslo Accords, there were 193,000 settlers living in the territories.

That number now stands at more than 310,000 and the number is growing. Another 200,000 or so live in a dozen settlement neighbourhoods in east Jerusalem, which was captured by Israel

in 1967 and annexed in a move never recognised by the inter-

PLO statistics show that since Abbas's historic bid to seek full UN state membership in September 2011, the number of settlers has risen by more than 20,000. "The only ethical solution is a (single) democratic, secular and civic state in historic Palestine," says Omar Barghouti, founder member of the Boycott, Divestment and Sanctions

(BDS) campaign, which is modelled on the South Africa's fight against apartheid. "There is no such a thing as a one-state solution," negoti-

ator Saeb Erakat said last month. "There is a one-state reality being created by the Israeli actions of settlements, dictations, facts on the ground, and with that comes apartheid."
