AL men sued for tree felling

Two activists of ruling Awami League have been sued on charge of felling trees worth Tk 1.2 lakh in Patgram upazila town.

Senior sub-assistant engineer of Lalmonirhat railway division Sayeedur

Rahman filed the case against Abu Bakkor Siddique, 45, and Rafiqul Islam, 47, members of AL town unit on Monday.

Police and railway sources said the duo felled a jackfruit and two mahogany trees near Patgram railway station showing false auc-

tion papers on Saturday and Sunday.

Sirajul Islam, officer in-charge at Lalmonirhat Railway police station, said they recovered two pieces of the jackfruit tree from a local sawmill on Tuesday.

They were raiding different areas to arrest the accused, said the OC.

Oil tanker derails in Kushtia

Another oil tanker train derailed on Tuesday, this time near Khoksa Railway Station in the district. Six tankers of the train heading for Goalando from Ishwardi derailed at about 5.30pm, disrupting railway communications between Kushtia-Khulna-Rajbari for eight hours. However, there was no report of oil spilling, railway sources said. Momiul Islam, driver of the train said that the train derailed due to damaged railway line. Later, a rescue train from Ishwardi went to the spot at about 8.00pm and rail communications resumed at about 1.30am. Earlier on Monday, an Ishwardi bound oil tanker train from Khulna derailed near Chuadanga Railway Station.

Criminal held with arms

Rapid Action Battalion (Rab-9) arrested a 'criminal' with two firearms at Shyamgonj Bazar under Purbadhola upazila yesterday. The arrestee is Mobarok Hossen, 30, son of Nazimuddin of village Pailati under the upazila. Officer in-charge (OC) of Purbadhola PS Mosharaf Hossen and Rab-9 sources said Mobarok was caught from a grocery shop along with the firearms in a bag. A case was filed with Purbadhola police station. The OC said that Mobarok is accused in several criminal cases.

Train goes off track in Feni

Train communications on Dhaka-Chittagong route disrupted for about six hours yesterday as a container train derailed near Muhuriganj railway station in the district. Local railway sources said a compartment of the capital-bound train, 801, coming from Chittagong went off the tracks at about 5:30am. Train movement on the route, however, resumed at about 11:30am as rescue trains from Laksam and Chittagong rushed to the spot and salvaged the derailed train. Zakir Hossain, Chittagong divisional railway traffic official, said about one km rail tracks in the area was damaged due to the incident. Hence, trains passing by the area are now running slowly. It will take two to three days to mend the rail tracks fully, he said.

Drug traders protest mobile court action

Drug traders kept their shutters down in the district town yesterday, protesting seizure of date-expired medicines by a mobile court.

The court led by magistrate Abdul Halim raided City Medical Hall in the town at around 5:00pm and seized a huge quantity of date-expired and unregistered medicines.

The medicines were later set on fire in front of the drug store.

Mohammad Ali Raju, owner of the shop, said "The date-expired medicines were kept separately to return those to the company".

Following the incident, the traders closed the shops. They also brought out a procession protesting the drive.

Md Mahabubul Alam Mukul, president of district drug owners' association, said they are often harassed in the name of drives.

Doctors in Bogra continue strike

Sufferings of patients mounted as doctors at all government and private hospitals in the district continued work abstention for the second day yesterday.

The Bangladesh Medical Association, Bogra unit announced a 4-day work abstention from Tuesday to protest attack on a doctor by a relative of a patient who died at Shaheed Ziaur Rahman Medical College and Hospital (SZRMCH).

Hakim Alam, 43, of Dublagari area in Shajahanpur upazila said, his father was suffering from acute respiratory disease. But no doctor at SZRMCH attended him from Tuesday, Hakim said.

Sabina Yasmin, 35, wife of Jahangir Alam of Atmlu area in Shibgonj upazila said they admitted their only son Arif, 5, to the Mohammad Ali Hospital for viral urine infection yesterday but got no treatment.

"We are poor and landless. So we have no ability to take our son to any private clinic", Sabina said.

The work abstention by the doctors began at 8.00am on Tuesday and it will continue till Friday evening.

BMA leaders said, police must arrest all the seven people who assaulted the doctor. Police so far arrested three people in connection with the incident.

BMA secretary Dr Rezaul Alam Jewel said, district and police administration will hold a meeting with BMA doctors in the evening to find out a solution.

Our programme will be withdrawn if the talks become fruitful, added the BMA secretary.

Deputy commissioner (DC) of Bogra Sarwar Mahmud told this correspondent that he had discussed the issues with the BMA leaders and hoped that the work abstention would be withdrawn soon.

'Withdraw false cases against Khagrachhari BNP leaders'

Leaders of Khagrachhari district BNP have demanded withdrawal of 'all false cases' against local party president Wadud Bhuyan.

The cases were filed after 2001 national election, alleging post-election violence and torture on the minorities.

The BNP men were holding a protest rally near the town's party office yesterday.

They said that government was trying to destroy the politics of BNP by filing cases against leaders and activists of the party and torturing them.

The speakers also criticised the price hike of essentials, recent railway, Sonali Bank and Padma Bridge scams.

They urged the government to stop conspiracy and withdraw all false cases against the BNP men and threatened to launch tougher movements if their demands were not met soon.

Senior vice-president of Khagrachhari district BNP Prabin Chandra Chakma presided over the programme while its vice-president Manindra Lal Tripura, general secretary Abu Yusuf, ameer of Jamaat-e-Islami Khagrachhari unit Syed Abdul Momen spoke at the programme.

Earlier, the leaders and activists of district BNP and its front organisations brought out a protest procession in the district town.
