- The People's Republic of Bangladesh has received a loan from the Asian Development Bank (ADB) toward the cost of Dhaka Water Supply Sector Development Project, and it intends to apply part of the proceeds of this loan to payments under the contract for "Supply, Installation, Commissioning of Atomic Absorption Spectrophotometers and UV-Visible Spectrophotometer Including Training" under Dhaka Water Supply Sector Development Project of DWASA, Contract No. ICB-07.1. This contract will be jointly financed by ADB and the Government of Bangladesh (GoB). The eligibility rules and procedures of the ADB will govern the bidding process.
- The Dhaka Water Supply Sector Development Project now invites sealed bids from eligible bidders for "Supply, Installation, Commissioning of Atomic Absorption Spectrophotometer and UV-Visible Spectrophotometer Including Training" as under for Dhaka WASA under Dhaka Water Supply Sector Development Project of the DWASA. The delivery/completion period is 120 days.
Major items of goods:
1. Atomic Absorption Spectrophotometer dedicated for HVG & Cold Vapor Generation : 1 piece
2. Atomic Absorption Spectrophotometer dedicated for graphite furnace : 1 piece
3. High ended UV-Visible Spectrophotometer : 1 piece
- Qualification criteria for bidders:
o Average annual turnover: The minimum annual average turnover shall be US\$ 1.2 million in last three years.
o Contractual experience: The bidder must have successfully completed as a main supplier within the last 5 (five) years, 2 contracts each of similar nature (import/export of similar goods), value (above USD 0.16 million) and complexity.
o Technical experience: Goods offered have been in production for at least 5 (five) years and a minimum of 5 times the scheduled number of units of similar capacity have been sold every year on average.
o Financial position: At a minimum, the bidder must have a positive net worth. The bidder shall submit at least last 3 (three) year's audited financial statements for this purpose.
- International competitive bidding will be conducted in accordance with ADB's single-stage: Two-envelope bidding procedure and is open to all bidders from eligible source countries.
- Interested eligible bidders may obtain further information from Dhaka Water Supply Sector Development Project and inspect the bidding document during office hours at the address given below, from 09:00 to 17:00.
- The bidding document in the English language, may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of BDT 5000.00 or US\$ 60. The method of payment will be Demand Draft or Pay-Order in favor of 'Dhaka Water Supply Sector Development Project'. The document can be either: (a) picked up by the bidder or its representative from the employer's office, or (b) sent by the employer to the bidder by mail, and for this purpose, the bidder is to pay the cost of the mail to the employer. No liability will be accepted for loss or late delivery.
- The employer will arrange a pre-bid meeting on 12th November 2012 at 10:00am. If the prospective bidder requests, the employer will issue a letter of invitation to support a visa application on behalf of the bidder up to one week before the pre-bid meeting date. To assist in the planning for the meeting, it is requested that within seven days after purchasing the document the bidders advise the undersigned on the number of people that will be attending.
- Bids must be delivered to the address below at or before 2:00pm (Bangladesh Time), date: 10th December 2012. All bids must be accompanied by a bid security in the amount stated in the bid document. Late bids shall be rejected. Bids will be opened in presence of the bidders' representatives who choose to attend the address below at 2:15pm (Bangladesh Time) the same day.
