Limon told The Daily Star that DC Ashok Kumar Biswas had also assured him of sending a recommendation based on his application to the home ministry to withdraw the cases. The unexpected move was made on October 24. Soon after Limon and his mother went to meet the UNO at his residence, Ashok reached there. The meeting lasted for nearly two hours when the DC placed his proposal.

Hamida Hossain, chairperson of Ain O Salish Kendra (ASK), the organisation that has been giving legal aid to Limon, told The Daily Star that Rab should conduct an investigation and hold the people responsible to keep its image intact.

"If they [authorities] know that the cases against Limon are made up, why shouldn't they withdraw the cases?" she said.

scrapped the legal provision in 2009. "We do not want the provision to be restored now." Before the 2001 parlia-

mentary polls, the electoral laws were amended to give the armed forces the authority to arrest anyone without warrant for violating electoral laws within a radius of 400 yards of polling stations on election day.

After the debacle in the 2001 polls, Awami League raised questions about the role of some members of the armed forces and vehemently opposed the provision. The party formally demanded the provision's cancellation in mid-2004.

Interestingly, AL accepted it during the tenure of the last caretaker government.

However, assuming power through the 2008 parliamentary polls, the scrapped the provision in early 2009. The previous EC led by

Huda proposed restoring the provision, saying it would enable the armed forces to perform their duty smoothly alongside the regular law enforcement agencies in maintaining law and order during the election.

In defence of the proposal, Brig Gen (retd) M Sakhawat Hussein, a member of the previous EC, said if the armed forces are not given the authority while on duty during the polls, they will not be able to arrest anyone without a magistrate's order.

"So, if members of the armed forces are deployed for maintaining law and order during parliamentary elections, they have to be accompanied by magistrates. Thus, they will not be able to take prompt action to maintain law and order," Sakhawat told The AL-led government Daily Starrecently.


