Three detained for suspicious movement in Rohingya camp

Police detained three people from a Rohingya refugee camp at Kutupalong in Ukhia upazila of Cox's Bazar district yesterday morning for "suspiciously moving around the restricted camp area".

Police deployed in the camp to maintain law and order detained the three -- Abdul Hamid, 35, of Lama in Bandarban district, and Kamal Hossain, 33, and Biplob Akhand, 40, of Jazira in Shariatpur district.

Ukhia Police Station Officer-in-Charge Appela Raju Naha said the three were also talking with Rohingyas and taking photos.

SC introduces data bank

As part of the digitalisation of the Supreme Court, the court authorities have introduced a data bank, which preserves judgements, orders, cause lists and other relevant information to facilitate litigants' access to case information.

Now information about both the Appellate and High Court divisions, including their judgements and orders, is not removed or destroyed, as it was done earlier, and anybody can see those on the SC website anytime.

The apex court's data centre is also preserving some information about Dhaka judges' courts, including their cause lists (records containing details of cases), and it will expand its network to other district courts in phases, SC official SM Kuddus Zaman told The Daily Star.

The SC also has introduced short message service (SMS) to help litigants access case information on their mobile phones.

"Anyone can know the recent status of a case simply by sending an SMS," said Kazi Parvez Anwar, a system analyst of the SC.

To do that, one has to type SC<space>nature of the case (criminal or civil)<space>case number<space>year of its filing and send it to 2233.

In another move, the apex court Star. authorities have set up five digital display screens on the SC premises, which show information about the cases heard and disposed of at the two divisions every day and status of other cases.

The display screens have been set up in front of the Appellate Division, High Court Division, Supreme Court Bar Association,

and the attorney general's office on tes-

Kuddus Zaman said the outcome of a day's hearing was uploaded on the website (www.supremecourt.gov.bd) within hours after the court order. It is helping litigants decide immediately their next course of action, he added.

The SC's own information communication technology (ICT) staffers have developed the system with government's fund, he said.

SC Registrar AKM Shamsul Islam said the SC had embarked on the digitalisation process in order to make the justice delivery system more affordable, accessible, cost effective, transparent and account-

The effort will be fruitful when the people will be aware of the system, he added.

Officials said the apex court started updating its website with the details of the cases heard and adjudicated in October

Eminent jurist Shahdeen Malik described the digitalisation of the judiciary as a positive step. "I hope that the authorities will be able to maintain, sustain, expand and upgrade these digital facilities," he told The Daily

"Both the litigants and litigators will find these facilities helpful, as these make access to justice easier," he said.

Around 18 lakh cases now remain pending with lower courts across the country, while over 14,000 cases await adjudication at the Appellate Division, and 2.82 lakh others at the High Court.

JAIL KILLING CASE

Govt to appeal against acquittal of 6 army men

The government is going to move a pending appeal in the jail killing case saying the 2008 High Court verdict acquitting six former army personnel was done without proper examination of documents and evidence. The state counsels in a concise state-

ment addressed to the Appellate Division termed the HC verdict "distorted and arbitrary". Principal state counsel for the case

Anisul Huq yesterday sent the statement to the Attorney General's Office to file it with the Appellate Division for hearing the appeal against the HC verdict. The HC in its verdict on August 28, 2008

acquitted the six former military personnel from the charge of killing four national leaders -- Syed Nazrul Islam, Tajuddin Ahmad, AHM Qamruzzaman, and Captain Mansur Ali -- inside the Dhaka Central Jail on November 3, 1975.

guilty at the lower court on October 20, 2004. Two of them were given death sentence and the rest life-term imprisonment.

Capital punishment was handed down on Dafadar (dismissed) Marfat Ali Shah and Dafadar (dismissed) Abdul Hashem Mridha. They both are absconding.

The four sentenced to life-term were Lt Col (dismissed) Syed Farooq-ur Rahman, Lt Col (retd) Sultan Shahriar Rashid Khan, Maj (retd) AKM Mohiuddin Ahmed and Maj (retd) Bazlul Huda. They were executed on January 27, 2010 in the Bangabandhu Sheikh Mujibur Rahman assassination case.

The lower court in 2004 also gave lifeterm to eight others. The High Court however did not say anything about them in 2008. The eight are Lt Col (dismissed) Khondaker Abdur Rashid, Lt Col (relieved) Shariful Huq Dalim, Lt Col (retd) SHMB Noor Chowdhury, Lt Col (retd) AM Rashed Chowdhury, Maj (relieved) Ahmed Shariful Hossain, Capt (retd) Abdul Majed, Capt (relieved) Kismat Hasem and Capt (relieved) Nazmul

Hossain. In its statement yesterday, the government also urged the Appellate Division to uphold the life-term imprisonment of these eight, who are also absconding.

After the Awami League-led government assumed power, it filed a leave to appeal petition in September 2009. The Supreme Court in January next year accepted the petition and directed the two accused -- Marfat and Hashem, who were given capital punishment earlier -to surrender before the court.

Earlier yesterday, Anisul Huq told All of these army personnel were found reporters at his office the 2008 HC verdict "denied" the nation justice in the muchtalked-about case.

> He said the government took much time to prepare the 25-page concise statement as they had to examine the statements made by 64 prosecution witnesses, although the Appellate Division on January 11 last year gave them one month's time to do so.

Anisul Huq said the law enforcers could not arrest Marfat and Hashem, two accused of the case, as they are now absconding abroad.

Attorney General Mahbubey Alam said the statement would be submitted to the SC within a few days. He said he would pray to the SC on November 4 for fixing a date for hearing the appeal.
