Govt favours new banks

Draft law allows them to have more directors than other banks

The government has offered concessions to the nine new banks and made room for other contenders having political clout to join the fray for making quick bucks as sponsor directors.

Under the draft Bank Company Act, no bank can appoint more than 15 directors. But the banking division of the finance ministry, which prepared the draft recently, has proposed appointing 20 directors for the newly approved banks.

This has been done to allow the original licence holders (sponsor directors) of the new banks to sell the positions of the five additional directors to make extra money, industry experts say.

The sponsor directors have already sold out those positions at much higher prices to new investors for collecting the required capital, they added.

Some directors are also selling their shares at exorbitant rates, said a Bangladesh Bank official, preferring not to be named.

The central bank in April this year approved nine banks -- six local banks and three NRB (non-resident SEE PAGE 19 COL 5

It was a 'mistake' Scrap HC verdict

Many top BNP leaders say party shifting from 'anti-India' stance

Realising that its long-held "anti-India" stance was a mistake, the BNP appears to be making a turnaround in its policy towards the big neighbour, party insiders

Now on a visit to India, BNP Chairperson Khaleda Zia has clearly signalled that she wants to reverse the stance on relations with New Delhi. She has assured Indian leaders that her party would not allow Bangladesh territory to be used by terrorists and insurgents to

target India.

Political analysts say that after benefiting from its anti-India polemics over the years, the BNP is shifting its strategy because of the changing socio-economic and political conditions at the national, regional and global level.

According to some top BNP leaders, the growing realisation that the party had to pay much for its anti-India strategy and that India is now a big factor in regional and international politics is the reason behind this shift.

in jail killing case

Govt prays to SC for upholding lower court judgment

The government yesterday prayed to the Supreme Court to uphold the lower court verdict by cancelling the High Court verdict in the historic jail killing case.

The Metropolitan Sessions Judge's Court of Dhaka in 2004 awarded death sentence to three former army personnel and life imprisonment to 12 others. The HC in 2008 upheld the death penalty of one, acquitted six of the convicts and did not say anything about the eight others.

Yesterday, the attorney general's office made the prayer to the SC in a concise statement it submitted seeking the hearing of an appeal against the HC verdict filed in 2009.

ACC seeks bank Sale of assets banned

The government has banned selling of assets of Destiny Multipurpose Cooperative Society Ltd (DMCSL) to safeguard the interests of its members.

The Department of Cooperatives (DoC) on October 30 sent letters to all deputy commissioners asking them to prevent DMCSL, a cash cow of controversial Destiny Group, from selling the cooperative's land, buildings or any other assets.

"We have issued the instructions to safeguard the interests of the cooperative's general members. If we keep hold of the cooperative's assets, we will be able to repay its members at least a portion of their dues," DoC Registrar Md Humayun Khalid told The Daily Star over the phone. The DoC is working to find out the total

assets and liabilities of DMCSL, he said. The restriction on the cooperative's
