Myanmar unrest could develop into 'terrorism'

Communal bloodshed in western Myanmar risks developing into "armed terrorist acts", the government said Wednesday, after security forces were targeted by homemade firearms in deadly fighting.

Meanwhile, refugee organizations yesterday said Myanmar's neighbours should prepare to accept refugees from the country's Rohingya minority who may try to flee abroad to escape bloody communal violence.

Myanmar said 180 guns were seized during the new wave of clashes between Buddhists and Muslims in Rakhine state, which has killed dozens, displaced tens of thousands and seen whole neighbourhoods razed.

It said several people had been arrested on suspicion of making the weapons.

"The clashes between two communities are likely to turn from normal unrest to armed terrorist acts after the security forces were attacked with handmade guns," the Oceans. government said, in a statement on the president's website.

The latest clashes have caused more than 32,000 people to flee their homes this month, the government said, adding to the 75,000 people already crammed into overcrowded camps after the earlier fighting.

Myanmar said both local and international organisations were "involved" in the conflict, without elaborating on their identities or exact role.

The toll from the clashes, which began on October 21, stands at 89 people killed, with 136 injured and more than 5,000 homes reduced to ash in a wave of arson.

"We are appealing to countries to keep borders open and to ensure safe access and whatever assistance they can provide," said Vivian Tan, Asia-Pacific spokeswoman for the UN High Commissioner for Refugees.

Asean Secretary General Surin Pitsuwan, meanwhile, has warned the bloodshed could leave the Rohingya minority "radicalised and the entire region could be destabilised, including the Malacca Straits", the vital shipping lane between the Indian and Pacific

Lankan ruling party moves to impeach chief justice

Sri Lankan President Mahinda Rajapaksa's ruling party moved a motion in parliament yesterday to impeach the chief justice for violating the constitution, signaling a deepening rift between the government and the judiciary.

Relations between Shirani Bandaranayake, Sri Lanka's first woman chief justice, and the government have been deteriorating over recent months.

Her supporters say she has been trying to preserve the independence of the judiciary in a highly politicised environment, and as the government faces international pressure over its human rights record. Bandaranayake was appointed in May 2011.

In August, the DoC unearthed the irregularities -- misuse of funds, unauthorised expenditures and investments, recruitment of members, commission and overvaluation of assets -- through a nearly-four-month investi-

DMCSL's major financial irregularity was unauthorised spending of more than Tk 740 crore as commission for Destiny-2000 Ltd distributors to get new members.

The oversight body for cooperatives later submitted its report to the LGRD and cooperatives ministry, and based on the report's findings, the ministry directed the DoC to ban sales of DMCSL's assets.

The report said DMCSL bought lands and establishments across the country for Tk 227 crore. The money was spent till March 31 since fiscal year

Early last month, the government announced its plan to appoint administrator to keep the controversial group's business running.

Destiny Group's top brass currently face charges, including money laundering and transfer of company funds to personal accounts.

The anomalies first came to light after a Bangladesh Bank probe in March found Destiny's cooperative arm was engaged in illegal banking.

Later, other agencies, including the Anti-Corruption Commission, cooperatives department and commerce ministry, also stepped in to look into the matter.
