## BB official, wife die from electrocution

A Bangladesh Bank (BB) high official and his wife died from electrocution at Shahjahanpur in the capital early yesterday.

The deceased were Krishna Chandra Chanda, 50, joint director of the bank, and his wife Sipra Rani Das, 40.

Their son Likhon, 14, was injured in the incident at their house.

The victims' neighbour Taposh Karmakar said first Likhon was electrocuted as he touched the gate, which somehow came in touch with a live electric wire, to open it when his parents returned from a doctor around 12:00 midnight.

Sipra was electrocuted when she tried to save her son. Later, her husband got electrocuted to

## Dhaka Wasa launches Two pro-BNP helpline for services

Dhaka Water Supply and Sewerage Authority (Wasa) for the first time introduced a hotline called "Wasa Link" yesterday to increase the quality of service.

Anyone can call the hotline on 16162 through any mobile phone operator to make service-related complaints or know billing and other necessary information.

Information Minister Hasanul Haq Inu inaugurated the service at the capital's Sonargaon Hotel by calling 16162 and taking some information from the helpline.

Wasa Managing Director Tagsem A Khan said the members of Wasa Helpline would receive the complaints and deliver them to the officials concerned immediately so that the problems could be fixed within 24 hours.

"If the officials concerned fail to solve the problem within the time due to technical reasons, they will inform it to the subscriber and will try to fix it as early as possible," he said.

If the officials do not pay any heed to the complaint, it will automatically reach the higher officials, he added. "We will take action against the officials who will show negligence in providing services."

Four more prosecution witnesses give statements

Four more prosecution witnesses gave their statements before a Dhaka court yesterday regarding the killing of Saudi embassy official Khalaf Al

On March 6, Khalaf, an official at the consular section of the embassy in Dhaka, was shot dead near his Gulshan house in the capital's diplomatic enclave.

Witnesses who gave their statements are United Hospital's physician Dr Abu Sayeed MM Rahman, two ward boys Maksudur Rahman and Mohammad Ripon, and its deputy manager Matiur Rahman.

Later, defendant's lawyers cross-examined

In his statement MM Rahman said he gave first aid to Khalaf after he was admitted to the hospital at 1:15am, but the victim succumbed to his wounds at 5:15am. Later he gave a death certificate of the victim.

Maksud and Ripon said they were present during the making of an inquest report of Khalaf's body by a police official.

Matiur Rahman said he supplied everything for Khalaf's treatment.

Judge Mohammad Motahar Hossain fixed tomorrow for the next hearing.

Earlier on two dates, four prosecution witnesses including complainant of the case gave their statements.

Four of the five accused Mohammad Al Amin, Saiful Islam Mamun, Rafiqul Islam Khokon, Akbar Ali Lalu are in police custody while Selim Chowdhury, the fifth accused, is on the run.

## MISSING ILIAS ALI BNP declares fresh agitation in Sylhet

BNP and its front organisations yesterday announced a three-week long agitation from November 8 in Sylhet demanding whereabouts of the party's missing leader M Ilias Ali.

The programmes include collection of signatures from November 8 to November 30, mass rallies from November 9 to November 16 in the three thanas under Sylhet-2 constituency, doa mahfil at mosques on November 16, a five-hour long hunger strike on November 17, and a 21km long human chain on the Dhaka-Sylhet highway on

December 1. The agitation programme was announced at a press briefing at Ilias Ali's Sylhet residence in Shahjalal Uposhahar.

BNP leaders said Ilias Ali is a victim of polluted and autocratic politics of the ruling Awami League.

AL chief Sheikh Hasina herself assured Ilias Ali's family of finding out him but her government has failed to do so even though about seven months have passed, they said.

More than 25,000 activists of the opposition were indicted in fake cases filed against them after the much talked about disappearance, they said.

Ilias Ali and his driver Ansar Ali went missing on April 18 from the capital's Banani area.

## Food act, BSTI law lack integration

Manufacturers tell discussion

Relevant laws on safe food and standard of other products lack integration, said manufacturers at a discussion yesterday.

Consequently, they said, manufacturers and retailers face harassment by different authorities whose desired standards for products differ from each other.

Omor Faruk Chowdhury, the state minister for industries, held the discussion with the manufacturers of mostly consumer products at Bangladesh Standards and Testing Institution (BSTI) head office in the capital to hear about the problems they face in business.

Lack of integration between the Bangladesh Pure Food (Amendment) Act 2005 and BSTI law results in punishment of manufacturers and retailers, said Ilias Mridha, a director of Pran Group.

There are instances when mobile courts under the pure food act filed cases against products certified by the BSTI, said Anup Kumar Saha, a director of ACI Group.

Shakti curd is an example, speakers said. Local government bodies, including the city corporations, enforce the pure food act while BSTI determines the standard of certain listed products under its own law.

AK Fazlul Ahad, director general of BSTI, said the government is updating the pure food act.

Representatives from Nestle Bangladesh demanded BSTI capacity building for speedy clearance of imported goods while those from Square Group suggested setting standards for sanitary napkins and diapers.

## RANGPUR CITY POLLS JP backs Ranga

Jatiya Party yesterday extended support to its Presidium Member Mosiur Rahman Ranga for contesting the Rangpur City Corporation election set for December 20, said a party press release.

Mosiur was appointed as the party's convener of Rangpur city unit, said the release signed by the press

secretary of Jatiya Party Chairman HM Ershad. Earlier in October, Ershad, in another release, said his party will not extend support to any of the party's aspirants in the Rangpur City Corporation polls as it is a local

level election. Several of its leaders have expressed interest to contest the polls, putting Jatiya Party in a dilemma.

Meanwhile, the Election Commission on Monday announced that the Rangpur City Corporation election is scheduled to be held on December 20.

Over 3.57 lakh voters will choose a mayor and 44 councilors, including 11 women, via the polls.

Aspirants for the election must submit their application seeking candidacy by November 18. The last day for withdrawal of candidacy is November 29.
