Tangail court rejects Pintu's bail prayer

Former deputy minister Abdus Salam Pintu, one of the accused in August 21 grenade attack case, was produced in a Tangail court yesterday in an extortion case filed against him with Bhuapur Police Station in October this year.

Judicial Magistrate Jannatul Ferdous Ibne Haque rejected Pintu's bail prayer and fixed February 11, 2013 for hearing of the case.

Awami League worker Zahidul Islam Bhuiyan Lebu lodged the case against Pintu, also vice president of BNP, and 10 others on October 13.

In the case statement, the complainant said the 10 other accused at the instruction of Abdus Salam Pintu stormed into his house on October 1, 2001 and demanded Tk 3 lakh from his wife Flora Begum.

As she refused to oblige, the accused vandalised the house and took away money and other valuables, the complainant stated.

Pintu was brought to Tangail from

Dhaka Central Jail in a prison van on Monday night. Of the remaining 10 accused, eight were earlier granted bail by the High Court and two are now staying abroad, police sources said.

Anisul Islam Bangabasi, lawyer for Pintu, said the case was filed to harass his client.

BNP men gathered on the court premises in the morning and chanted slogans demanding with drawal of the case.

72 Indian fishermen held for intrusion

Bangladesh Navy also seizes their five fishing trawlers in two days

Members of Bangladesh Navy arrested at least 72 Indian fishermen along with five fishing trawlers in the coastal areas here on Saturday night and early yester-

According to Md Abul Kalam Azad, office in-charge of Sharankhola police station, a patrol team of the Bangladesh Navy rounded up 46 Indian fishermen along with three fishing trawlers in the early morning from the Fairway Bay area in the coastal area for intrusion into Bangladesh waters.

The arrestees were handed over to Sharankhola police yesterday and sent to Bagerhat jail through a court on filing of two

The arrested fishermen hailed from north and south 24 Parganas in Paschimbanga, of India.

However, their names and identity could not be known immediately.

Earlier, on Saturday afternoon, another Navy team arrested 26 Indian fishermen for their illegal entry into Bangladesh maritime boundary.

They are Swapan Das, Bafon Das, Anil Das, Amuliya Das, Gopal Das, Nikhil Mondol, Uttam Das, Sudhir Das, Niranjan Das, Haridhan Das, Rajib Das, Sirmani Das, Sanjay Das, Taraknath Das, Shankar Das, Bivuranjan Das, Mintu Das, Shukumer Das, Binoy Das, Dhananjoy Das, Apon Das, Kalu Das, Mongol Chandra Mondol, Ripon Das, Bimol Das and Rui Das, reports UNB.

The fishermen were produced before the chief judicial magistrate here on Sunday that sent them to jail hajat.

Police said the Navy patrol team held the Indian fishermen from the Bay along with two trawlers on Saturday night on charge of fishing inside Bangladesh waters.

The arrestees, who hailed from different villages of south 24 Pargana district in Paschimbanga, were handed over to Mongla police.

The fishermen said they mistakenly entered Bangladesh's water territory.

Tiger beaten to death

A tiger was beaten to death by villagers at Perikhali under Paschim Dhangmari forest area in Dakope upazila of the district early yesterday.

Amirul Islam Chowdhury, divisional forest officer of the Sundarbans East Zone, said the tiger entered a locality in low-lying Khajuria under

Barishanta union in search of food after crossing a canal adjacent to Dhangmari Forest Station on Monday late night.

The 12-13-year-old tiger which was 7 feet 11 inches long from its tail to head, caught a dog of a fisherman at midnight. It also attacked and injured three fishermen who were fishing at a nearby waterbody.

As the fishermen cried

out for help, neighbouring villagers came out of their homes along with sharp weapons and wooden sticks and chased the tiger.

At one stage, they trapped it near a homestead and beat it dead.

Being informed, Forest Department staffs rushed to the spot.

They collected the skin of the tiger and buried it in the afternoon.

Being informed by local people, law enforcers from Panchagarh Police Station reached the spot and arrested the Hizb-ut-Tawhid activists.

PBS SNAPS POWER CONNECTIONS TO DEEP TUBEWELLS

Cropland drying up, villagers deprived of drinking water

Around 10 thousand acres of cropland in five upazilas under the district is drying and thousands of people are denied pure drinking water as Dinajpur Palli Bidyut Samity-1 (PBS-1) has snapped power connections to 74 deep tube wells under Barind Multilateral Development Authority (BMDA).

The action, following a dispute over payment of additional bills claimed by Dinajpur PBS-1 upon their 'no load loss' plan, triggered resentment among the farmers as it has started affecting the winter vegetables and crops including broccoli and famous kathari rice during the season.

Preparation of the lands for the next cultivation is also hampered.

Sources of BMDA in Dinajpur said they have PBS power connections with 683 deep tube-wells in seven upazilas under Dinajpur PBS-1 but the latter has snapped power supply of 74 deep tube-wells -- 23 in Birganj, 28 in Khansama, seven each in Chirirbandar and Biral, and nine in Dinajpur Sadar upazila since October 31.

Each deep tube well covers around 100 acres of land and supplies pure drinking water for 86 families in the area, said Md Mizanur Rahman, assistant engineer of Barind in Dinajpur Sadar upazila.

Reza Md Nure Alam, executive engineer of Dinajpur BMDA, said, "BMDA, which have been playing a vital role in country's agricultural sector, is also the largest power consumer of PBS. But it seems to have fallen victim of conspiracy. At least 10,000 acres of lands have been affected due to the recent snapping of power connections by Dinajpur PBS-1. We cannot pay the additional charges as there is no decision at the top level in this regard."

When contacted, Kazi Mohammad Ali, general manager of Dinajpur PBS-1 said, "We are implementing the decision of the higher authorities."

An expatriate youth took his own life by taking poison at Shantinogar village in Dorshona municipality area under Damurhuda upazila of the district on Monday evening. The youth was identified as Abdur Rahman Asad, 25 son of Namizuddin of village Shantinogar of the upazila. Quoting family members, police said Abdur Rahman Asad had been living in Kuwait for the last three years. Recently he returned to his village home and a marriage proposal to a girl of his village. Being refused, he took poison at his room at noon. Later, the family members rescued him in critical condition and took him to Chuadanga Sadar Hospital where he died at 7pm.

Robbery in Sylhet

Debashis, Banomali and Lovely were arrested soon after filing of the case while the rest are still at large.

10 hurt as rival groups clash
