

SP, OC failed to take right steps

It mentioned that the then deputy commissioner of the district was having his farewell party at the Circuit House that night where senior government officials of the district were present.

The probe report said the deputy commissioner failed to judge the gravity of the situation and the civil servant neither went to the spot nor ordered someone to go there. The probe body did not speak to those government officials of Cox's Bazar at the party.

The police headquarters, which formed the three-member committee led by Md Nawsher Ali, deputy inspector general of police, Chittagong

Range, submitted the three-page probe report to the High Court Tuesday through the attorney general's office as per its earlier order.

A mob destroyed 12 pagodas and more than 50 houses in Ramu on the night of September 29. The violence was apparently triggered by the image of a Buddhist's Facebook page that had been photo-shopped, revealed The Daily Star investigation. The page had an image derogatory to Islam pasted on it.

The committee had finalised the report on October 18.

The probe body said OC Nazibul had failed to forestall the violence and was negligent in discharging

official duties.

It said he did not provide higher authorities with information about the incident and punitive action could be taken against him.

The probe committee also said Nazibul did not know about the incident early enough even through the incident happened at populous Ramu Bazar in Ramu.

Nazibul did not realise the severity and consequence of the incident, as the people, who led the processions, were known to him, the committee said, adding that the OC failed to show his acumen in taking primary steps.

The OC fully failed to prevent the outbreak and he did not inform the SP of

Cox's Bazar about the incident in time and could not take necessary instructions and guidelines from the SP in this regard, the report read.

It said SP Selim Md Jahangir was in confusion and did not realise the consequence an image derogatory to the holy Quran could have as he was not in touch with the local sentiment as one would hope.

Therefore, the SP did not deploy additional police force and did not rush there on time, the committee said.

The government recently closed SP Selim and attached him to the police headquarters and closed the OC Nazibul and

attached him to the office of deputy inspector general of police of Chittagong Range.

According to the report, being informed about the incident, SP Selim sent a 10-member force to assist the police of Ramu Police Station at 10:00pm and later sent 30 more policemen in two phases.

The police force could not control the situation, the report said.

Supreme Court lawyer Eunos Ali Akond on October 3 filed a writ petition saying that local law enforcers failed to take appropriate measures to protect the temples, monasteries and houses of the minority communities in Ramu.

On October 15, a High Court bench of Justice Naima Haider and Justice

Muhammad Khurshid Alam Sarkar directed the government to submit a report to it by Tuesday on the security measures it had taken before and after the attack on the Buddhist community in Ramu.

On Tuesday, after receiving the report, the bench fixed November 20 for passing an order on this issue.

On the same day, the Ministry of Home Affairs submitted another probe report to the High Court, saying that the mayhem in Ramu was a well-planned attack designed at least 10 days ahead in four phases.

The probe report gave a detailed description of the incident and mentioned that 205 people were involved.

visit of Hasina to Laos, also by any Bangladeshi head of government.

Foreign Minister Dipu Moni, Ambassador at-Large M Ziauddin, Foreign Secretary Mijarul Quayes and Bangladesh Ambassador to Laos Supradip Chakma were present during the meeting.

After the discussions, officials of the two countries signed an agreement to give exemption of visa requirements for government officials and diplomats of both the countries, and also to take the bilateral relations concerning mutual interest to a new height in near future.

Dipu Moni, and Deputy Prime Minister and Foreign Minister of Laos Thongloun Sisoulith signed the agreement for their countries.

PM's Press Secretary Abul Kalam Azad said the Laotian prime minister gave his consent to make a reciprocal visit to Dhaka in the shortest possible time.

He said the two prime ministers also agreed to cooperate with each other in development of human resources, poverty alleviation, and education particularly in granting scholar-

ship to students for higher studies.

Later, Hasina called on President of Laos Choummaly Sayasone at his residence and extended to him the greetings of Bangladesh President Zillur Rahman.

During the meeting, Hasina offered him that Bangladesh could provide doctors, engineers, nurses, teachers, IT experts, accountants, and manpower for agriculture, horticulture, aqua-fisheries and also for mining and construction.

Earlier, the prime minister also paid homage at the monument of unknown soldiers of Laos who had sacrificed their lives fighting against the occupation forces.

After reaching the monument at Lao Deng, Hasina placed a wreath there and stood for a while in silence as the last post was played on the bugle. Dipu Moni and Ziauddin were also present there among others.

After wrapping up her six-day official visit to Vietnam and Laos, the prime minister and members of her entourage landed at Shahjalal International Airport in Dhaka at 6:35pm on a VVIP flight of Biman Bangladesh Airlines.

connection with misappropriating Tk 26 lakh and causing a loss of another Tk 11 lakh to the public exchequer.

Mohammad Moniruzzaman Khan, ACC deputy director and also the investigation officer of the two cases, submitted the charge sheets to the Chief Metropolitan Magistrate's Court of Dhaka.

In one case, Jamir Uddin along with Ashraf was accused of misappropriating over Tk 27 lakh in the name of medical check-up abroad.

While in another case, the ACC accused Jamir Uddin and late Khandaker Delwar Hossain, former chief whip, of abusing their power for misappropriating furniture and other goods worth over Tk 6 lakh supplied by the Parliament Secretariat.

The IO dropped Delwar Hossain's name from the charge sheet as he is dead.

The ACC lodged the cases with Sher-e-Bangla Nagar Police Station on December 28, 2010. On February 15 this year, the ACC filed the case against Khoka with Shahbagh Police Station.

Bigots attack

Mostafizer Rahman, officer-in-charge of Taraganj Police Station, told The Daily Star that a group of people attacked the houses of Ahmadiyyas over the construction of a mosque by the community.

Members of the Ahmadiyya community claimed that local Jamaat leaders Abul Kasem, Abdul Kader and Kazi Rafiqul Islam led the attack.

"Following an announcement on loudspeaker against Ahmadiyyas, several thousand people around 2:00pm equipped with sticks made the attack," they added.

The mob set ablaze two houses of the community, the OC said, adding that police had arrested 11 people for their alleged involvement in the attack.

"But we are yet to identify their political affiliation," he said.

Around 20 Ahmadiyya families live in Kismat Mena Nagar under Hariar Kuti union, and all male

members of these families are hiding in fear of further attacks, sources said.

Witnesses said a chase and counter chase took place between the mob and the law enforcers when a police team led by Upazila Nirbahi Officer Syed Farhad Hossain went to the spot to quell the violence at 2:15pm.

Police fired several tear gas shells to disperse the mob.

The mob also snatched a camera and mobile phones from the daily Prothom Alo Taraganj correspondent Rahidul Islam and assaulted him physically as he was taking footage of the fire.

Rahidul was later admitted to Rangpur Medical College Hospital.

"Police at first retreated from the spot when the religious bigots attacked them. On receiving information, a large number of police members rushed to the area and brought the situation under control," the OC told The Daily Star over the phone.

accounts of the Destiny directors had been transferred.

The letter also gave directives on taking necessary legal action against the money launderers on the basis of the findings of the probe.

A finance ministry official said the commerce ministry had earlier submitted a 450-page investigation report on Destiny Group to the Banking Division.

An inter-ministerial meeting on the basis of that report has identified eight financial irregularities committed by Destiny Group and placed a six-point recommendation.

The finance ministry official said on the basis of two of the six recommendations the Banking Division had directed the central bank to take necessary action.

One of the two recommendations says legal action may be taken against the DMCSL for siphoning off or transferring Tk 1,864.28 crore [except valuation of the fixed assets].

The recommendation also says as the DMCSL management had collected the money from its members and transferred the amount through fraudulent means, legal action should be taken.

Another recommendation says the central bank may be requested to investigate how and where the directors of Destiny Group have transferred the embezzled money.

The inter-ministerial meeting scrutinised the commerce ministry's report and detected the irregularities. It found that 22 individuals of Destiny Group as share-

holders had made most of the transactions among themselves and the DMCSL also conducted illegal banking at the high interest rate of around 16 percent.

Destiny Group also collected a huge amount of money from its subscribers in the name of tree plantation without planting trees and later the money could not be traced.

The commerce ministry report also found that some companies were not launched as per their objectives, thus providing false information and concealing information intentionally.

Other anomalies unearthed include misappropriation of funds by investing capital in loss-making firms continuously, and transferring the money of the Cooperative Society to the bank accounts of the company directors illegally.

Other recommendations of the meeting include advising the National Board of Revenue (NBR) to examine whether the companies of Destiny paid taxes properly and take action on that basis.

Taking action was also recommended as per Companies Act against the Destiny Group companies, including Best Aviation Ltd and Boishakhi Media Ltd, for submitting financial report through hiding company information.

The central bank last year investigated the Destiny Group activities and submitted a report to the finance ministry. The ministry then advised the commerce ministry to come up with a complete report.

Later, the central bank

also submitted several reports on Destiny to the government.

According to the BB report, among the 37 firms of Destiny, Tk 5,132 crore was deposited in 282 bank accounts of three firms and the directors withdrew Tk 5,113 crore.

The BB froze the bank accounts of the directors, but only Tk 190 crore was found in those accounts.


