HC directs police to submit DNA test report

The High Court yesterday directed police to submit immediately the report of DNA test of Shipan Bepari, who allegedly raped a speech impaired girl in Louhojang upazila in Munshiganj in July.

The court also directed the Dhaka Medical College Hospital authorities to carry out the test and deliver the report to the police as soon as possible.

The court gave the directives during hearing on a petition filed on the basis of an August 1 news report of the Bangla daily Janakantha.

On August 2, Human Rights and Peace for Bangladesh filed the petition seeking necessary directives on the issue.

According to the newspaper report, one Shipan Bepari of Singherhati village of the upazila, raped the victim after confining her to a house for two days.

On July 30, police rescued the girl, and sent her to her village in Bhola on the next day without doing any medical examination to suppress the incident, it said.

The HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Farid Ahmed yesterday ordered police to handover the victim, who is now in police custody, to the Safe Home of Ain O Salish Kendra, and produce her before the court on November 18.

The court also asked a teacher of a school for speech impaired students at Bijoynagar in the capital to appear before it the same day to help explain the victim's statements.

Police submitted the victim's DNA test report to the court yesterday, petitioner's counsel Manzill Murshid said.

ALLEGED ABDUCTION OF SHUKHO RANJAN BALI

It's Jamaat's drama

Attorney general tells HC

Attorney General Mahbubey Alam yesterday told the High Court that Jamaate-Islami has staged a drama over the alleged detention of Shukho Ranjan Bali, a defence witness of Jamaat leader Delawar Hossain Sayedee.

He said the writ petition, claiming that law enforcers had abducted and detained Ranjan, was filed in a bid to make the ongoing trial of the 1971 crimes against humanity questionable.

The attorney general was speaking during hearing on the petition filed, challenging the legality of the alleged abduction of Ranjan.

Abul Kalam Azad, Ranjan's friend, submitted the petition on November 7 seeking directives from the HC on the government to produce Ranjan before the court to show that he was not illegally detained.

Azad claimed in the petition that Ranjan, who was in a vehicle with him, had been "abducted by a group of plainclothes police" in front of the main entrance of the International Crimes Tribunal-1 on November 5. Mahbubey Alam yesterday told the

court that Jamaat-e-Islami was involved in terrorist activities including attacking law enforcers across the country in an attempt to foil the ongoing trial of crimes against humanity. He also said the petitioner could not

show any document that law enforcers have arrested Ranjan and so, the petition was not acceptable.

Petitioner's counsel, Abdur Razzaq, argued that law enforcers abducted and detained Shukho Ranjan illegally in broad daylight, so that he cannot place statement before the tribunal on behalf of Savedee.

After concluding the hearing, the HC bench of Justice Naima Haider and Justice Muhammad Khurshid Alam Sarkar fixed tomorrow for passing an order.

UN official lauds Bangladesh's role

A visiting high-up of the United Nations (UN) yesterday lauded Bangladesh for its longstanding and robust support to UN's peacekeeping and peace-building efforts.

"Bangladesh is uniquely positioned as a leading global agent of peace and development, to deploy civilian experts and professionals for nation building activities under the UN to sustain peace in postconflict countries," said UN Assistant Secretary General and Special Adviser on Civilian Capacities Sarah Cliffe.

She made the remark when she called on Foreign Minister Dipu Moni at the latter's office in Dhaka.

Dipu Moni assured the UN official of Bangladesh's readiness to deploy civilian experts especially in the areas of social safety net, development, human rights and natural disaster risk reduction.

Sarah Cliffe, who was on a one-day visit to Bangladesh at the invitation of the foreign ministry, also addressed a workshop in the capital on civilian participation in UN peacekeeping operations.

Foreign Secretary Mijarul Quayes chaired the programme.

Robbers loot house in guise of meter readers

A gang of robbers in the guise of electric meter readers allegedly looted about 70 tolas of gold ornaments and Tk 1.5 lakh in cash from a house at Pallabi in the capital yesterday.

They looted the two-storey house of former additional chief engineer of Public Works Department (PWD) Kazi Muhiul Alam at Section-12, Block-B in the area.

Muhiul Alam told The Daily Star that at around 12:30pm, when he and his daughter were outside home, two men pressed the calling bell and called his wife Nazneen Mehtab. When his wife opened

the door they told her that they came to

read their electric meter. At one stage, while they were

talking, three other people joined them and they all entered into the house. Later, the miscreants tied the hands, legs and mouths of Nazneen and a female domestic help of their house, he said.

The criminals snatched the key of their wardrobe from her brandishing sharp weapons. Later, unlocking the wardrobe they took away the gold ornaments and money.

Pallabi Police Station Sub-Inspector Ansiur Rahman said none was arrested till yesterday evening.

Mijarul Quayes elected member of ICSC

Foreign Secretary Mijarul Quayes has been elected as a member of the International Civil Service Commission (ICSC) at the 67th General Assembly of the United Nations (UN) held in New York, US on

September 25. The ICSC was established by the UN General Assembly with a mandate to regulate the conditions of service of all staff recruited to the UN common system and to promote high standards in international civil service.

Quayes will serve the commission, located in New York, for a period of four years, said a foreign ministry press release yesterday.

This is the third time Bangladesh has been elected to this civil service body.

Meanwhile, Bangladesh has also been elected to the UN's Joint Staff Pension Fund.

The UN General Assembly created the fund in 1949 to provide retirement, death and disability related benefits to the staff of the UN and other selected organisations.

Deputy Permanent Representative of Bangladesh to the UN M Mustafizur Rahman has been elected for the fund.
