KPI student stabbed to death in Jessore

A student of Khulna Polytechnic Institute (KPI) was stabbed to death by a gang of criminals in Navaron Jadavpur area of Sharsha upazila in the district on Monday night.

The deceased was identified as Ahsanul Hossain Luis, 20, son of Abdur Rashid of Sadipur village under Benapole Port Station.

Faruq Hossain, officer in-charge of Sharsha police station, said that the criminals waylaid Luis when he was returning to his house and stabbed him indiscriminately, leaving him dead on the spot at about 8 pm.

He was a first year student at Khulna Polytechnic Institute.

However, the motive behind the killing could not be known immediately.

Police arrested a youth yesterday morning on charge of his involvement in

the murder. The arrestee was Uzzol Hossain, 21, son of Akbar Hossain, of Godawn para

Campaign starts much ahead of Dec 20 polls

Aspirants in the Rangpur City Corporation election scheduled for December 20 have already started campaign, before finalisation of the candidatures.

Aspirants have to submit application for candidacy by November 18 and the Election Commission officials will scrutinise those on November 21 and 22.

The last day for withdrawal of candidacy is November 29.

Although officially nonpartisan, the city corporation election would ultimately gain political colour, as mainly political leaders from major parties contest such polls, especially for the mayoral post, observers said.

League (AL) and Jatiya Party (JP) are preparing for the election.

However, the ruling AL is yet to announce support for any mayoral candidate while JP sees a serious rift over the candidature.

Bangladesh Nationalist Party (BNP) is yet to take decision about letting any of its leaders contest the elections.

A few candidates from AL, including Shafiar Rafman Shafi, president of AL Rangpur city unit, Rashek Rahman, a member of AL Rangpur district unit, and

Tusher Kanti Mondal, gen-

BNP did not participate as their demands, including scrapping of voting through electronic voting machines (EVM) and deployment of army, were not met.

ATTACK ON FELLOW CHAIRMAN

Chairman, members of 12 Natore UPs on strike

Chairmen and members of all 12 union parishads under Natore Sadar upazila will go on an indefinite strike from today, demanding arrest of the criminals, who assaulted Brommapur Union Parishad Chairman and BNP leader Afzal Hossain, on Tuesday.

Upazila parishad sources said, a gang of four to five criminals swooped on Afzal Hossain while he was collecting a nomination paper on behalf of a party man who would contest the upcoming election to the managing committee of Mirzapur High School in the adjacent Mirzapur union.

Hearing the news, chairmen and members of the union parishads held an emergency meeting at the

the evening and decided to go on an indefinite strike from Wednesday.

Later, Golam Sarwar, chairman of Tebaria Union Parishad and also president of Bangladesh Union Parishad Forum Natore Sadar upazila unit, announced the decision at a press conference held at the auditorium.

Sarwar said they will also besiege the deputy commissioner's office, and form a human chain in the district town today to press their demand.

All the 12 union parishad offices in the upazila will remain closed until the culprits involved in the attack on Chairman Afzal Hossain are arrested, he

Human chain by erosion victims

4 held in triple murder case

Police arrested four people in connection with triple murder at Satlathibrahmanbaria village in Belkuchi upazila early yesterday. The arrestees are Anwar Hossain, son of Samsul Haque Khan, Sirajul Islam, son of Somesh Ali of the village, Abdul Kuddus, son of Sonaullah of Agnukali village in Shahzadpur upazila and Abdul Karim son of Ansar Ali of Kamalpur village in Enayetpur upazila. Mizanur Rahman Khan, officer in-charge at Belkuchi police station, said of the four, Anwar and Sirajul were arrested from Shaheed Ziaur Rahman Medical College Hospital, Bogra while the rest from their respective houses. On Monday morning, three people were killed and five others injured in a clash between two rival groups over a piece of disputed land at Satlathibrahmanbaria. Later, a case was filed accusing 19 people, said the OC.

Accused snatched from police
