As it was difficult to nominate candidates for all 23 posts from the parishad, central leaders on Saturday held a meeting with Captain (retd) Mujibur Rahman Fakir, MP, at his residence in the capital.

The meeting finalised a panel but the rival members of the parishad here rejected the panel, sources added.

As the doctors of a faction who got nominations along with their supporters were preparing to join the election on the scheduled date, the doctors belonging to other faction of the parisahd started to press for fresh schedule with fresh candidates from their side, they

Today the panel is likely to be introduced at a function at MMC auditorium in presence of the central leaders of the parishad.

The vested quarters may foil the programme and yesterday's incident is related to it, said a parishad leader, expressing fear.

Contacted, MMC principal Dr. Motiur Rahman, however, said the air of grievances centering the BMA election has already been minimised through a meeting at MMC yesterday afternoon.

A Jubo Dal activist was murdered allegedly by Swechchhasebok League men at Koromza village in Santhia upazila of the district on Tuesday night.

The victim, Md Abdul Hannan, was a member Santhia upazila unit of BNP's youth front.

Police quoted family members as saying that Hannan came under attack while he was returning home at Koromza village from Koromza haat at around 9:30pm.

Swechchhashebok League leader Md Abul Barkat and his associates intercepted Hannan near his house and him over toll collection from

his men hit Hannan with sharp weapons and left the scene, they added.

Critically injured Hannan

cumbed to his injuries soon

## BCL leaders hurt in JCD attack

Three Bangladesh Chhatra League (BCL) leaders were injured as Jatiyatabadi Chhatra Dal (JCD) activists attacked them on Manikganj Government Devendra College campus yesterday. The injured are Abid Hossain Khan Sakib, organising secretary of BCL college unit, Tanvir Foysal Rahi, assistant relief and disaster affairs secretary of the district unit and its member Joy Khandaker. Of the trio, Abid was admitted to Manikganj Sadar Hospital in critical condition. Injured Tanvir and Joy said a group of JCD men numbering 30/40 and led by Awlad Hossain suddenly beat them up with iron rods mercilessly while they were gossiping on the campus. Contacted, former president of the college unit JCD Awlad Hossain said he was not present on the campus when the attack was made.

### Nine injured in clash

At least nine people were injured in a clash between two rival groups over a piece of disputed land at Khordamalibari village in Sadar upazila yesterday. Locals said there was a longstanding conflict between one Azahar Ali of Khordamalibari and Sekender Ali of Fakirtari village over the land. The supporters of the rivals attacked each other with lethal weapons, leaving at least nine from both sides injured following an altercation over the issue. Of the injured, five were admitted to Gaibandha Sadar Hospital.
