# Women's SME expo begins in Ctg

Women entrepreneurs are playing a great role in the country's economy and their participation in industry-oriented activities should be encouraged on a larger scale, Industries Minister Dilip Barua said yesterday.

The achievement of the middleincome country status for Bangladesh depends a lot on the entrepreneurial participation of females, he said.

Barua spoke as the chief guest at the inauguration of a month-long fair -- Sixth International Women SME Expo 2012 -- at the polo ground in the port city.

The fair will remain open for all from 10am to 10pm. Entrance tickets are priced at Tk 15 while children under or equal to 12 years will get 50 percent discount.

"If Jamdani is registered under the GI law in Bangladesh, nobody in the world will be able to claim the patent of the sari," he said, while advising experts for a further review of the GI definition.

"We have our backs to the wall. We must take the assistance of the government now," said Monira Emdad, president of the National Crafts Council of Bangladesh. While Bibi Russell, the founder of Fashion for Develop-

ment, said authentic Jamdanis can only be produced on the banks of river Shitalakhya, where its distinct climatic conditions help make the fine texture of Jamdani. Bibi Russell also mentioned the Indian government's attempts to register the Jamdani and Kantha

under its name. "The Bangladesh government should intervene now," she said. Maleka Khan, founder of Bangla Craft, said there is enough official evidence to prove Jamdani is the prod-

uct of Bangladesh. "Bangladesh has been exporting Jamdani saris to India for many years. It indicates that the patent of Jamdani saris belongs to Bangladesh," she added.

While calling for protecting the existence of

Jamdani from the aggression of India, Mohammad Hamidullah, a weaver, said although the weavers are illiterate they can make good-looking such saris. "We are weaving Jamdani in our locality for genera-

tions," said Jahangir Hossain, a weaver from Rupganj, while challenging others to make better Jamdanis than the weavers of the banks of Shitalakhya. "It is high time to enact the GI law, otherwise the country would lose not only the Jamdani, but also

other traditional products which bear the heritage of the country," said Srimati Shaha, director of Kumudini Welfare Trust of Bengal (BD) Ltd. Chandra Shekhar Shaha, vice-president of National

Craft Council of Bangladesh, said it will not be possible to protect the sari by any particular individual or institution -- it needs assistance from the government.

The private sector entrepreneurs are ready to assist the government for greater interest of the country, he added.

Aziza Sultana Mukti, an assistant manager of Aarong, a social business initiative of the BRAC, urged the government to form small committees to lobby with the government to protect Jamdani's patent.

SM Enamul Haque, assistant registrar of the department of patents, designs and trademark of the ministry of industries, said although the initiative was taken in 2009 the government is formulating the GI law now.

He said the industries secretary instructed him last week to conduct further review of the draft copy of the GI law and re-submit it within a week.

"The department will submit the draft copy to the ministry again soon for tabling it to the cabinet for finalisation. I hope we will be able to finalise the law soon."

"We're now putting the things in place. The required equipment will be available by the next two months," he said.

Ahmed said it now takes seven days to one month to carry a container to Dhaka from the port.

"When the route will open, only 24 hours will be needed, reducing costs as well." The construction work of the container terminal began in July 2005 under the supervision of the shipping ministry.

"We'll be benefited in three ways: it'll save time, minimise costs and reduce pressure on the Dhaka-Chittagong highway," said M Siddiqur Rahman, acting president of Bangladesh Garment Manufacturers and Exporters Association.

Rahman said it takes 18-20 days to carry their containers from Dhaka to Chittagong Port now. Mujibur Rahman Sarker, project director of

Pangaon Inland Container Terminal, said: "The terminal is fully ready. The connecting road of four-five kilometres with the terminal is also ready." "Though the budget was Tk 177 crore, the project

was implemented at Tk 156 crore," Sarker said. The shipping ministry earlier took a decision that

the terminal will be operated by private sector operators, said Sarker. According to the decision, the CPA invited bids to appoint a private operator. But following litigation and other complexities, it

was decided that the CPA itself will operate the terminal, he added.

According to a report of the Asian Development Bank, Bangladesh can raise its gross domestic product by 1 percent and foreign trade by 20 percent by making its inland water transport systems efficient and competitive.

## Stocks end week in the black

Stocks ended last week in the black and broke a losing streak of two straight weeks, riding on investors' optimism of a market rally.

Week-on-week, the DGEN, the key market tracking index of the Dhaka Stock Exchange, went up by 18.05 points or 0.42 percent, to close at 4,365.68 points.

First two trading sessions of the DSE lost 123.94 points while the last three gained 141.99 points. "After consecutive down-

turns, the Dhaka bourse inched up slightly last week as the sellers took respite awaiting a reversal," said LankaBangla Securities in its daily market commentary. At the opening of the

week, market started with the legacy of a bearish trend, but well-timed institutional support salvaged the market from a further downturn, said the stockbroker. "Moreover, the resched-

Finance Minister AMA Muhith, who also attended the event, asked the participants to suggest priorities in implementation of the master plan.

"Problems have been identified properly in the plan. Now opportunities have to be created to improve the livelihoods of people," he said, while lauding the suggestion for floating ambulance.

With regards to the disruption of children's schooling during the monsoon when the haor areas become isolated, Muhith said it was a "major concern".

"The education ministry is yet to find any effective solution to ensure children's schooling during the monsoon."

# Govt's borrowing from banks falls 42pc

When money from the central bank gets circulated in the market, it increases non-food inflation by increasing the money supply. According to Bangladesh

Bureau of Statistics, non-food inflation again crossed the double-digit mark and reached 10.46 percent in October. An official of the central bank said the overall inflation came

down to single digit and is slightly above 7 percent now. The official also said they have been maintaining the borrowing

pattern in such a way that it does

not create any problem for the private sector to get credit.

The trend of borrowing from the central bank changes every month, he said, adding that they will closely monitor the increase in government's borrowing from the BB in line with their monetary policy.

The data of development expenditure till October 30 is not available yet.

However, in the first quarter of the current fiscal year the government's development expenditure was Tk 6,381 crore or 12 percent of the total annual development programme (ADP).

Of the total development expenditure, Tk 4,307 crore was spent from own resources.

However, a finance ministry official said the government had to borrow from the banking system as non-development expenditure marked a rise.

He said statistics of the nondevelopment budget is available now for the first two months of the current fiscal year.

In the first two months of the current fiscal year, the expenditure in non-development budget increased by 11.4 percent over the same period last year.

During the July-August period of the current fiscal year, the total non-development expenditure was Tk 12,852 crore. Of the total expenditure in the

first two months, the expenditure on interest payment went up by 17.7 percent.

As the government's borrowing increases every year, its expenditure is also going up due to higher interest payment.

In the budget this year, the highest allocation was made for interest payment, which is 26.38 percent of the total nondevelopment budget.
