

Notorious criminal held in Jhenidah

Members of Rapid Action Battalion (Rab) on Tuesday arrested a notorious criminal along with firearms in Kaliganj upazila of the district.

The elite forces in a drive in the early hours nabbed him along with two shooter guns, one single barrel gun and a bullet at Dudrajpur village in Kaliganj upazila on Tuesday night.

The arrestee, Arif Hossain, 35, was second-in-command of Ghena Bahini, a top criminal gang, and son of Altaf Hossain of the village.

ATTACK ON PABNA JOURNO Six months over, no headway yet in case

Although six months have passed, no headway has been made in the investigation into the attack on journalist ABM Fazlur Rahman.

After the incident, police arrested three suspects from different areas of Sadar upazila, but they were later released.

Unidentified assailants hacked the right arm of Fazlur Rahman, 48, staff reporter of Samakal, on Edward College campus on May 19.

According to the victim, an anonymous caller rang him around 11:00am and asked him to go to the college campus for collecting information about irregularities in the institution.

As he reached near the teacher's mess on the campus, a gang attacked him with machetes. They hacked Fazlur's right arm and left the scene.

He was admitted to Pabna Medical College Hospital and released from the hospital a month ago.

"We are carefully investigating the case as it is one of the sensational cases of the district," said Sub-Inspector Rana.

said, acting on secret information, a team of the elite force raided the area at about 9.00pm and arrested Arif along with the firearms.

Arif was wanted by police in several cases, including for gunfire with Rab, extortion, abduction and muging, he said.

In Jessor, police in separate drives arrested three alleged criminals along with six hand bombs and sharp weapons in the district town on Tuesday night, reports our Benapole correspondent.

The arrestees were identified as Liton, Sujon and Rony -- all residents of different areas in the town.

The SI said they have got the names of some people involved in the attack, but he declined to disclose their names for the sake of investigation.

Pabna Press Club General Secretary Ahmed-ul-Haque Rana said police could not unearth the clues to the attack on journalist Fazlur Rahman even after six months of the incident.

After the incident, State Minister for Home advocate Shamsul Haque Tuku assured the local journalists of taking immediate step to bring the culprits to book, but the real culprits are yet to be nabbed, Rana added.

Rival villagers were injured and houses damaged during clashes over land disputes in Rangpur and Joypurhat districts yesterday and the day before.

In Rangpur, six people were injured, a house was looted and torched by the rivals on Tuesday at Nagdah village under Parul union of Pirogachha upazila.

Police and local sources

said there had been a long-standing dispute over the ownership of one and a half acre land between Shamsul Haque and Monsur Ali of the village, reports our correspondent.

On Tuesday morning Monsur Ali and his men went to the disputed land for harvesting paddy.

They indiscriminately beat up Shamsul Haque and his wife Chakina Khatun, when they tried to resist them.

Hearing their scream, locals rushed to the spot to rescue them. Monsur and his men also beat them up, leaving six people injured.

At one stage, the attackers also looted the house of Shamsul Haque and set it on fire, villagers said.

In Joypurhat, agitated villagers yesterday ransacked and damaged four houses and blocked road following the death of a farmer who was injured in a clash over land dispute on November 12.

The deceased was identified as Md. Abdus Sabur Tuku, 45, son of Abdur Rouf Munshi of Parulia village under Joypurhat Sadar upazila, reports our Dinajpur correspondent.

Joypurhat police quoting locals said that Saidur Rahman, Md. Hanif, Mostaque and Md. Abdul Hye had a longstanding dispute over one Bigha land with Abdur Rouf Munshi and his sons.

On November 12, a gang attacked the family members of Munshi, leaving Md. Abdus Sabur Tuku and his brother Md. Shirajul Islam critically injured.

Tuku was shifted to Dhaka Medical College where he succumbed to his injuries on Tuesday morning.

The death of Tuku triggered anger among the locals of the area. They attacked the houses of rival villagers yesterday morning, damaging and setting four houses on fire.

They also blocked Hakimpur-Joypurhat highway, protesting the death of Abdus Sabur Tuku.


