Wal-Mart suspends India staff

Wal-Mart, the world's largest retailer, has suspended a "few associates" at its joint venture in India amid an ongoing probe into bribery allegations.

Wal-Mart did not provide further details.

But various reports said the chief financial officer and members of the legal team were among those suspended.

The firm is conducting an investigation into possible violations of a US law that bans US firms from paying bribes to win or retain business abroad.

Disruption forces Indian parliament to adjourn

Anti-graft bill tabled in Rajya Sabha

It was another day of disruptions in parliament with the Lok Sabha being adjourned till Monday and the Rajya Sabha till 2.30pm as differences continued over the issue of foreign investment in multi-brand retail.

The Bharatiya Janata Party (BJP) along with the Communist Party of India-Marxist and the Trinamool Congress continued their protest for the second consecutive day of the winter session.

Both houses saw frequent disruptions. The Lok Sabha and the Rajya Sabha were initially adjourned till 12 noon but furore continued even after that. Finally, the Lok Sabha was adjourned for the day and the Rajya Sabha till 2.30pm.

The opposition, pressing for a vote on foreign investment in retail, stalled proceedings and raised slogans.

Meanwhile, report on the much debated anti-corruption bill was tabled in the upper house yesterday.

The bill on Lokpal and Lokayuktas was sent to a select committee in the budget session earlier this year after several objections were raised on its form. It was passed by the Lok Sabha at the end of the winter session last year.

Addressing a press conference on the bill later, Satyavrat Chaturvedi, Rajya Sabha select committee chief on the Lokpal Bill, said: "Drafting the recommendations was a difficult job because of legal issues and diversified views from different political parties."

leaders and activists and general students, who said it would incite more violence on the campus.

An emergency meeting of the BCL's central executive committee on Thursday withdrew the suspension order, confirmed Sheikh Russell, office secretary of the pro-Awami League student body. The committee decided

this a day after Takim sustained critical injuries following an attack on him on the campus allegedly by several members of Shibir.

The others who were taken back into BCL's fold are former RU unit president Awal Kabir Joy and general secretary Mazedul Islam Opu, Bangabandhu Hall unit convener Shah Muhammad Selim, Madar Bux Hall unit convener Ruhul Amin Babu and activists Tarikul Islam and Al Amin.

Takim and Tuhin have been restored to their posts. They were suspended on July 16 this year due to their alleged involvement in the murder of BCL's Sher-e-Bangla Hall unit joint convener Abdullah Al Hasan Sohel.

Takim was made the vice-president though he lost his studentship for not attending the required number of classes in two academic years.

Contacted, RU unit BCL president Ahmed Ali said the suspension order against the eight has been withdrawn as they have made sacrifices for the organisation.

THREE 'SHIBIR' MEN ARRESTED

Police arrested three suspected cadres of Islami Chhatra Shibir from near Rajshahi University yesterday in a case over attacking RU unit BCL leader AKM Alam Tawhid Akheruzzaman Takim.

The law enforcers rounded up Omar Faruque Babu, Delwar Rahman Omit and Shanta around 5:00pm from Mirzapur and Binodpur areas, said Sanaul Haque, officer-in-charge of Motihar Police Station.

On Wednesday night, a group of Shibir cadres pounced on Takim, suspended vice-president of RU unit Bangladesh Chhatra League, on the campus and hit him on the head with a hammer. As Takim fell to the ground, the gang cut a tendoninhisleftleg.

The following night, deputy public affairs secretary of BCL Shahinur Islam Shakil filed a case with Motihar Police Station against 35 Jamaat-Shibir men, including Jamaat leader Mazedur Rahman, RU unit Shibir president Ashraful Alam Imon and general secretary Shaifuddin Yeahea for carrying out the attack.

Takim was admitted to Rajshahi Medical College and Hospital, from where he was shifted to Bangabandhu Sheikh Mujib Medical University (BSMMU) Hospital in Dhaka for better treatment.

Hospital sources said he underwent surgery in his head at the BSMMU Hospital and has been on life support since Friday afternoon.

India girl killed over pee protest


A teenage girl in the Indian capital Delhi has been shot dead by a man after she objected to him urinating near the gate of her family home, police said yesterday.

The man, who lived in the same building, also shot at and injured the girl's mother in the incident in the Nizamuddin area, police said.

India, China in map row again

Unhappy over China showing Arunachal Pradesh and Aksai Chin as its territory in maps of the country on their new epassports, India has retaliated by issuing visas, containing



Indian maps including these regions as part of it.

The retaliation came after the Chinese government started issuing new e-passports, carrying pages with watermark Chinese maps including Arunachal and Aksai Chin as its parts.

Taking note of this few weeks back, India through its embassy in Beijing is issuing visas to Chinese nationals with a map of India including these places as part of its territory.

China's claim to Aksai Chin and Arunachal Pradesh, which shares a 1,030-km unfenced border with it, is not new.

In 1962, China and India fought a brief war over Aksai Chin and Arunachal Pradesh, but in 1993 and 1996 the two countries signed agreements to respect the Line of Actual Control to maintain peace and tranquillity.

Significantly, these developments occur even as a high-level team of Chinese diplomats, for the first time, visited Sikkim in connection with consular issues, which was seen as reconfirmation of Beijing's stance of accepting the state as part of India.

The development comes even as Prime Minister Manmohan Singh met his Chinese counterpart Wen Jiabao on the sidelines of the Asean summit in Cambodia where the two leaders discussed ways to move forward on the vexed boundary issue.

REVENGE ATTACK Taliban kill 3, wound 90 in Afghanistan

A suicide car bomber killed three people and wounded dozens near a Nato-run training base yesterday, in an attack claimed by the Taliban as revenge for the execution of its militants.

Several Nato soldiers were lightly wounded, a spokesman for the US-led International Security Assistance Force (ISAF) said, without giving further details.

A police spokesman said the blast was near "a joint coordination office" for the Afghan army, police and Nato troops in Maidan Shar, the capital of Wardak province, some 50 kilometres (30 miles) from Kabul.

Taliban insurgents claimed responsibility for the blast, saying it was to avenge the execution on Wednesday of four Taliban members on death row in Kabul.

The four executed Taliban members were among a total of 14 prisoners hanged over two days this week in rare mass executions.


