### Witnesses testify against Azad, Kamaruzzaman

Faridpur on May 16, 1971. Majibar Rahman Khan Panu, the 14th prosecution witness in the case against the Jamaat Assistant Secretary General, testified that Kamaruzzaman and his cohorts apprehended him at his home in May, 1971.

They kept him detained for four days.

Kamaruzzaman had even suggested that a Pakistani army major kills Majibar inside the army camp. However, Majibar was let go at the mercy of the army official, said the 58-year-old tailor.

"Al-Badr Commander Kamaruzzaman used to torture and kill freedom fighters and their relatives picking them up at different parts of Sherpur town," said Majibar, brother of a freedom fighter.

On June 4, the tribunal indicted Kamaruzzaman with seven charges of crimes against humanity committed during the Liberation War.

At the beginning of his 65-minute testimony yes-

terday, Mojibar said he had stitched the national flag with Bangladesh's map on it on March 26, 1971, under the instruction of student leader Amjad Hossain.

"Kamaruzzaman and Kamram [an alleged Al-Badr leader] were my acquaintances because they used to get their clothes made at my shop," said the witness.

After the Liberation War began on March 26, Majibar along with many others took training in operating rifles under the supervision of EPR Subeder Hakim, said Majibar.

After the Pakistani army set up its first camp in Sherpur, he along with 13-14 of his associates left the country for India, he said.

Majibar returned in the first week of May, 1971, after hearing about his mother's illness, he said, adding that his brother Ansar Ali Khan Mantu and Mansur Ali Khan were home.

"My brother Ansar Ali Khan used to repair vehicles of the Pakistani army and that's why my brother

had a good rapport with Pakistani Major Riaz," said Majibar.

"I came to know from my brothers and others that the Al-Badr camp was set up at Surendra Mohan Saha's house. Kamaruzzaman Shaheb was Al-Badr commander. Pro-liberation people were picked up from deferent places, killed and their bodies were dumped under the Seri Bridge," said Majibar.

Al-Badr, an antiliberation force, collaborated with the Pakistani military in committing genocide across the country in 1971, according to prosecution documents.

Seven days after Majibar camehome, Kamaruzzaman, Mintu Khandakar, Advocate Tara, Halu Mia and four-five others surrounded Majibar's home around 7:00pm and took Majibar to Banthia Building.

They kept him detained there, said the witness.

Banthia Building was a Razakar camp where one Liakat was already detained, said Majibar,

adding that Abdus Sattar and Chhana Master were also taken there later on.

At night, Kamaruzzaman directed Tara to take the detainees to Sherpur Police Station and around midnight the detainees were taken there, said Majibar, adding that several others from Tikarchar were also there.

"Around 11:00am, after two days and nights spent there, four-five Pakistani army men took us to the Ahmednagar camp and made us, 11 detainees, stand on the road on the east of Ahmednagar School," said Majibar.

He said one army man asked their names. He slapped and kicked them and when it was Majibar's turn, he hit him with a rifle.

After some time, the detainees were placed next to a big and deep hole and a few minutes later, an army officer asked them to stand up, said Majibar adding, "After his order, we started praying."

"After 10 minutes, Major Riaz, Kamaruzzaman and

jeep and Major Riaz prohibited them from shooting us and asked our names," said Majibar.

Shaheb then told Major Riaz 'they shouldn't be released. They are freedom fighters. If they are released, it would be too harmful for us'," said Majibar adding, "Kamaruzzaman told the major two or three times to 'Halak' [finish] us."

Kamaruzzaman and Kamran left the place and around 5:00pm, Majibar and Liakat were released on the major's directives, said Majibar, adding that Major Riaz directed him to show up at the army camp every day.

"The following day, I went to the army camp and learnt from detained Sattar that Kamaruzzaman and Kamran had gone to the camp again after Liakat and I were released," said Majibar.

"Under Kamaruzzaman's instructions, four people [detainees] of Tikarchar were shot dead inside the large hole," said Majibur, adding, "The remaining five were released in my presence at the camp."

Majibar said Kamaruzzaman, Kamran and some others picked up Sherpur College Principal Syed Abdul Hannan in May, 1971, and took him to Surendra Saha's house, the Al-Badr camp.

Hannan was forced to

Kamran arrived there on a walk through Sherpur town with his head shaved, said Majibar, adding, "I saw this myself."

At the end of May, 1971, "Kamaruzzaman Majibar had a chat with Golam Mostafa on his way to the camp.

"After coming home from the camp, I came to know from my brother Ansar Ali that Kamaruzzaman and his cohorts picked up Mostafa and took him to the Al-Badr camp," said Majibar.

"The next day, I learnt that the body of Mostafa was left under Seri Bridge," he added.

The three-member

Tribunal-2 headed by Justice ATM Fazle Kabir with members Justice Obaidul Hassan and Judge M Shahinur Islam recorded Majibar's testimony and part of the cross-examination before adjourning the case proceeding until today.

Meanwhile, Bhakta Ranjan Biswas, son of martyr Madhab Chandra Biswas, told Tribunal-2 that Abul Kalam Azad alias Bachchu Razakar had killed his father in Faridpur on May 16, 1971.

Bhakta said on the same day and spot Azad killed Ganendra Mondal, a relative of Bhakta's neighbour.

"I have seen the incidents [killings] and my neighbours Prafulla Kumar Mondal, Tusta Kumar Mondal, Sunil Kumar Mondal and many

others witnessed it too," said Bhakta, the sixth prosecution witness in the case against expelled Jamaat member Azad.

"I want justice for my father's killing," Bhakta appealed to the tribunal as tears rolled down his cheeks.

During his 20-minute testimony, the 65-year-old witness from Purura village of Faridpur said around 11:00am on May 16, 1971, Azad along with cohorts surrounded their home.

Bhakta's father, who was an Awami League supporter, tried to run away but they detained him, said the witness, adding, "They looted the house of money and gold ornaments."

Taking his father about 300 yards west of their home, Azad shot Madhab dead with his rifle, said Bhakta.

After the killing, some 500-600 Hindus fled the country, said Bhakta.

Amir Hossain, a collegemate of Azad and the seventh prosecution in the case, also testified against Azad yesterday.

He said Azad in association with the Pakistani army, used to torture and kill pro-Awami League people and Hindus in 1971.

During his 43-minute testimony, Amir, a warwounded freedom fighter said after the Pakistani army arrived in Faridpur on April 21, 1971, Al-Badr commander of Faridpur Azad occupied the house of

Hiralal Mukter and made it an Al-Badr training centre. Amir said on July 27,

1971, some Razakars captured him at Faridpur town and handed him over to the Pakistani army at Faridpur stadium. He was detained for one month at the camp.

"Bachchu used to accompany Pakistani army Major Akram Koreshi and as a classmate, I thought that he might help me get out. Instead of doing that, he told Koreshi [in Urdu], 'he is a freedom fighter. Kill him'," said Amir. "Afterwards, the

Pakistani army men tortured us all [everyone detained there]," he added. Amir escaped the torture taking advantage of a fire incident at the camp, he State-appointed defence

counsel Abdus Sukur Khan completed crossexamination of both the witnesses before the court adjourned the case proceeding until December 3.

Azad is on the run. Meanwhile at Tribunal-, defence counsel Abdur Razzaq placed closing arguments in the case against Delawar Hossain Sayedee. Razzaq said the intention of holding the trial against the Jamaat leader after 40 years was

the grave of his daughter so that he could visit it occasionally and pray for the eternal peace of her soul. Work on DNA profiling

from samples collected from the bodies of 59 unidentified victims started yesterday. Fifty-three of the

unidentified victims were buried at Jurain Graveyard on Tuesday. The bodies of six victims were handed over to their

relatives after they identified their dear ones at the DMC morgue.

The DNA samples from all 59 bodies were collected on Monday and kept at the National Forensic DNA Profiling Laboratory.

Ahmad Ferdous, scientific officer at the laboratory, told The Daily Star that the lab had collected samples and had tagged the bodies with numbers before they were buried in tagged graves.

He said the laboratory

would make a database of DNA samples collected and match those with the parents or children of the victims.

He said teeth, tissues

had been collected as samples for DNA profiling.

However, one to three months could be required to make DNA profiling of the samples collected. DNA profiling of relatives of the victims would take less time, he said.

Ferdous added that the lab authorities were keeping contact information of the victims' relatives. If their DNA profiles matched with that of a body, they would inform the authorities concerned and the relatives of the matter.


