5.5 quake hits Indonesia

A 5.5-magnitude earthquake struck off the coast of eastern Indonesia yesterday, the US Geological Survey said.

The Indonesian

Meteorology, Geophysics and Climatology Agency (BMKG) had earlier reported the quake at a magnitude of 6.3 and a depth of 12 kilometres (7.5 miles), but issued no tsu-

nami alert. USGS reported the quake struck at 0856 GMT at a depth of 55

kilometres, 288 kilometres north of Saumlaki in the Tanimbar Islands. "There was light shaking reported but we've

received no reports of damage or casualties so far," BMKG technical chief Suharjono told AFP. Indonesia sits on the

Pacific "Ring of Fire" where continental plates collide, causing frequent seismic and volcanic activity.

After the amendment, the government will be able to exercise this sweeping authority for two more years.

The law has empowered the government to avoid compliance with the Public Procurement Act, 2006, which was introduced to ensure transparency in government pro curement. It also allows authorities

to quickly publish tender notices in newspapers and websites, make correspondences and negotiations with bidders through emails to fix service prices. Even it allows direct bidding and unsolicited deal with a single bidder or one from a pool of pre-selected bidders through restrictive tender. The law curtailed the

court's jurisdiction, saying all acts done or purported to have been done, actions taken or orders made under this law shall not be questioned in any court.

When the law was made last year, legal experts blasted the government and said it would encourage corruption in the power sector.

In defence of the extension of effectiveness of the law for two more years, State Minister for Power, Energy and Mineral Resources Enamul Haque told the House it was not possible to meet the country's demand for power and energy even after the expiry of effectiveness of the law on October 11.

He said quick implementation of some more projects is needed to meet the demand for power and energy. Therefore, extension of effectiveness of the law is needed, he said in a brief statement tagged with the copies of the bill.

thousands of supporters gathering in the city's Naya Paltan area, Khaleda, leader of the opposition in parliament, said the alliance would hold rallies across the country on December 6 to mark "Democracy Freedom Day". She also announced the staging of demonstrations and processions in all cities, districts and upazilas by the opposition alliance on December 23 and December 26. Amid roaring chants of

anti-government slogans, Khaleda said she would lead the procession in the capital on December 26, while other leaders of the 18-party would do so in their respective areas. Pointing to ruling party leaders' involvement in

corruption, Khaleda claimed she had information and the names of ruling party leaders who had embezzled public money, and where they had kept it.

She also said she had the names of those who had fallen victim to forced disappearances and who were behind such activities. "I will make it public through the media in time. None will be spared," Khaleda said, without giving any further details.

"This incompetent and most corrupt government has failed totally... Acknowledge your failure and give election under the caretaker government. We will have nothing to say if the people send you to power again," Khaleda added.

Yesterday's grand rally was part of the 18-party alliance's declared programme to mount pressure on the government to

bring back the caretaker government system.

The opposition alliance has been carrying out various programmes, including enforcing hartals and blockades, since June last year when the government repealed the caretaker provision through the constitution's 15th amend-

According to the constitution as it stands at present, parliamentary polls will be held under a partisan government. Therefore, the next spate of general polls due in 2014 will be held with the Awami League government in power. Hours before Khaleda

started her speech, thousands of supporters filled the roads from Fakirapool intersection to Kakrail crossing and from Shapla Chattar to Naya Paltan intersection and adjoining alleys.

The opposition supporters carried banners, festoons, placards and portraits of BNP founder late president Ziaur Rahman, Khaleda and Senior Vice-Chairman of the party Tarique Rahman.

The Jamaat-e-Islami, whose top leaders are facing war crimes trial, and its student wing Islami Chhatra Shibir joined the rally to show their strength by gathering a huge number of activists and leaders. At the Nayapaltan rally,

Khaleda said: "We have been observing our programmes in a lawful manner. We are still showing patience. But you [the govt] will have to face dire consequences if any obstacles are created while we observe our programme."

She called upon the

government to hold the next general polls under the caretaker government for the continuation of the country's democratic pro-

"Otherwise, there will be

no election in the country under the present government," Khaleda said, adding, "This is a democratic country, not a dynasty. This country is not for any fam-The BNP chief reiterated her appeal to give her party another chance to run the

country. "We will take the country forward, make it self-reliant and create job opportunities for the youth." She also promised that she would fight corruption and crimes if her party assumed power again. "I

will take stern action if anybody is involved in corruption and crime irrespective of their identity. ...And I will not come before you if I fail to do so

and will accept your [people's] judgment." She said the government was desperate to remain in power at any cost. "There

are rumours that emergency will be promulgated, but this will terribly go against them [the govt]." Blasting the finance minister, she said the coun-

try was being deprived of foreign investment due to the government's corruption and incompetence. But the finance minister had pinned the blame on Prof Yunus for this, she added. "Dr Yunus is admired by

side. Nobody even advised me to install one like that, apart from the existing ones," he argued in an exclusive interview with The Daily Star, for the first time since the deadly fire killed 111 workers at his factory on Saturday.

"I could have done it. But nobody ever suggested that I doit."

While Delowar was apparently shaken by the tragedy, he did not announce any compensation for the families of the deceased, nor did he clearly express any sympathy for them, at least not in public.

Besides shouldering the entire responsibility for the incident, Delowar also blamed others for the tragedy -- at least partly. He alleged that the officials of the labour department had visited his factory several times, but they had not raised any question about the exit routes.

It was the social compliance audit of the retail giant Walmart that complained only about the excess working hours at the factory. "But we have rectified the problem after receiving the complaint," he claimed.

The retailer did not complain about the absence of any emergency exit from outside, Delowar said, adding that it did not even raise any objection over having a warehouse on the ground floor in the same building and near the staircase.

"Now I can understand it was my fault and I realise it at a time when more than a hundred lives have been lost," said Delowar.

A total of 1,137 workers, out of 1,163, were present in the factory when the incident occurred. The factory has a space of 1.40 lakh square feet. Delowar started his own

garment business in March 2004 by setting up Tuba Textiles Mills Limited with two production lines. Ashulia-based Tazreen Fashion is a sister concern of Tuba Group.

He made his fortune with the garments business by setting up a dozen units since 2004. Earlier, his career began as an accounts manager at Latest Garment in 1989.

Delowar refuted the claim that the fire had originated from an electric short circuit on the ground floor. "It is not true, as there was no electric point over there,"

he asserted.

"Of course, I believe it is sabotage and therefore, a pre-planned incident. We are looking for some officials who were present during the incident and now cannot be traced," he said. Among the officials,

Mubarak Hossain Manju, production manager, was on the fourth floor during the incident; while Mohammad Dulal, quality manager, was on the third floor though his seating arrangement was on the fifth floor. Abdur Razzak, factory manager, was on the third floor although his designated desk was on the fifth floor, mentioned Delowar.

"If they are found, they can tell us why the workers were barred from leaving the second, third and fourth floors after the first fire alarm had rung," he said.

Denying the allegation of locking the collapsible gates from outside during the incident, the owner said: "The gates were never locked. They always remain open."

He also explained that the warehouse was set up on the ground floor to facilitate the loading and unloading of raw materials.

Asked if it was a violation of rules having a warehouse on the ground floor and adjacent to the staircases, he only replied: "Now I can realise manythings."

He also admitted that the fire extinguishers did not work. "The workers panicked rather than use the fire extinguishers. Every worker was trained to use it," he claimed.

Earlier in the day, The Daily Star reached Delowar, who was thrust into the deadliest factory fire in September, 2009.
