Fire survivors tell stories of utter neglect

The officials of Tazreen Fashions Ltd in Ashulia, where more than 100 workers died in a fire on Saturday night, played music to suppress the sound of the fire alarm, a survivor alleged at a discussion yesterday.

Maria Akhtar, who miraculously survived the inferno, said the fire alarm rang at 6:50pm and the workers on the sixth floor ran to the staircases for exit. But the production manager on

duty asked them to go back to work, saying there was no danger. They later managed a makeshift bamboo bridge to escape to a nearby buildingwith liferisk, she said. The discussion on how to stop

deaths in fire at garment factories was organsied by the Prothom Alo at its office in the city. Maria said Delwar Hossain,

the owner, visited the factory 15 minutes before the raging fire started to engulf the eight-storey factory building.

Normally, workers are asked to remain disciplined and well-clad prior to the owner's visit but that day he came silently, Maria said.

Syed Ashraful Zaman Kallol, another survivor who worked on the fifth floor, said production managers Dulal and Ranju and factory manager Razzaq all obstructed the workers' escape immediately after the alarm rang.

"There would have not been such

phenomenal losses of lives had they allowed us to leave the factory," said Kallol, who later escaped, breaking open a fourth-floor window, to the nearby building.

Two new banks get more time to submit documents

Bangladesh Bank (BB) has extended the deadline for submitting supporting documents for licence application for NRB Global Bank and Madhumati Bank.

Madhumati Bank's deadline has been extended to March 31 of next year, while NRB Global Bank's to December 31 this year, by the BB board upon appeal from the sponsors of the two proposed banks.

In April, BB gave the goahead to nine new private banks, all linked with either lawmakers of the ruling Awami League or Jatiya Party or influential persons, despite opposition from different quar-

Break-up with Walmart may send Tazreen to bankruptcy

BGMEA president says the retailer's decision to end ties with the garment maker is deceitful

The Walmart's decision of cutting ties with Bangladeshi garment supplier Tazreen Fashions is 'deceitful', said BGMEA President Shafiul Islam Mohiuddin yesterday.

Such a unilateral decision might push the garment maker to bankruptcy, he said.

The US retail giant terminated its with him. relationship with Tazreen after at least 111 workers were killed in a deadly fire in the garment maker's factory in Ashulia on Saturday night, mainly due to lax safety measures.

the US retail giant said Tazreen was no longer authorised to produce merchandise for Walmart. "Our thoughts are with the families of the victims of this tragedy."

"A supplier subcontracted work to this factory without authorisation and in direct violation of our policies. Today, we have terminated the relationship with that supplier," the retailer said.

ADB's \$1b loans for power, stockmarket

The Asian Development Bank (ADB) has approved \$1 billion as loans to give a boost to Bangladesh's power supply system and to develop the country's capital market.

The lender will give \$700 million for the power supply system, which will reduce outages and power shortfall. ADB is expected to sign

a deal at the Economic Relations Division today to give \$300 million loan under the Second Capital Market Development Programme.

"Supply shortages are putting a severe strain on businesses and undermining quality of life, with poor communities suffering the most," said Herath Gunatilake, lead energy economist in ADB's South Asia Department.

"Providing more electricity more reliably is absolutely critical for Bangladesh's growth and development."

Govt still undecided on internet regulation

With four days to go to the International Telecommunication Union (ITU) conference in Dubai, the government is yet to decide on its stance over the case of monitoring internet usage suggested by conference. some ITU member states. The proposal, put forward by some

countries in Europe, Asia and Africa, would be decided via a voting process at the conference set to take place on December 3 to 14. Sunil Kanti Bose, chairman of Bangla-

desh Telecommunication Regulatory Commission (BTRC), said Bangladesh's stand would be taken after consulting with the stakeholders. "The UN should have an authority on

internet," he said, adding that the current internet culture "cannot go at it is". "We want the internet rules to com-

plement the country's laws." At the Dubai conference where mem-

ber countries will place their stand, the ITU is supposed to revise the International Telecommunications Regulations. Bangladesh is a council member of

the ITU.

Nazrul Islam Khan, the ICT secretary, said internet regulation is needed to ensure universal access and empowerment of people -- and not to control the internet.

"But constitutional or legal transfor-

mation is not required," he said.

According to a statement of the ITU on July 13, Hamadun Touré, ITU secretary general, asked all member states to hold open consultation as the members have full access to the documents of the

Mustafa Jabbar, the president of Bangladesh Computer Samity, said, officially he did not hear of any consultation initiative on the revision of International Telecommunications Regulations (ITR) that would lead to moderation of internet usage.

He hopes the government will not take any decision on the issue on its own, while adding that some initiatives are needed to prevent misuse of internet.

Abu Saeed Khan, a senior policy fellow of Colombo-based think tank LIRNEasia, said the Bangladesh government has ignored the ITU's directive that instructed it to consult the ITR issues with its citizens.

"Rather, it [the government] has been highly secretive and the nation remains in the dark about the government's standpoint on the issue. Even the ICT ministry is equally unaware about this

issue. It is unacceptable and alarming." Khan urged Sajeeb Ahmed Wazed, the Prime Minister's ICT adviser, to immediately intervene and ensure that Bangladesh does not vote in favour of internet regulation.
