### BSF picks up two

UNB, Jhenidah

Members of Indian Border Security Force (BSF) picked up two cattle traders and injured one of their associates by hurling bombs at Kushumpur border point of the district Sunday night. Bangladesh Border Guard (BGB) sources said three cattle traders-- Monirul Islam, Belal, 24, son of Rafi Uddin, and Amol, 25, son of Bhandu Biswas-- all hailing from Loraighata village in Moheshpur upazila, entered the Indian territory for buying cattle by crossing Kushumpur border at about 8.00am. BSF members of Fatepur camp chased them and threw hand bombs at them, leaving Monirul injured. They picked up Belal and Amol while Monirul managed to flee.

### Youth jailed for stalking

UNB, Manikganj

A mobile court here on Sunday sentenced a young man to two months' imprisonment for sexually harassing a college girl in Satoria upazila of the district. Executive magistrate and upazila Nirbahi Officer Shahin Akhter, who led the mobile court, handed down the punishment to Anwar Hossain, 18, son of Badar Uddin, resident of Hargaj Noyapara village under the upazila. Police said, Anwar had been harassing the girl, a student of Kalushah Degree College, for long on her way to the college. On Saturday, the victim's mother lodged a complaint with the local police station in this connection. Police arrested Anwar from his house the next day and handed him over to the mobile court.

### Body recovered

Police recovered the body of an unidentified woman at Talimganj village in Mithapukur upazila yesterday morning. Abu Hena Mostafa Kamal, officer in-charge (OC) of Mithapukur police station said locals saw the body at a paddy field at Talimganj village and informed the police. Kamal said criminals killed her by slitting throat on Sunday night somewhere else and later dumped the body at the paddy field.

### Two addicts get RI

A mobile court in Adamdighi upazila of the district yesterday sentenced two people to three months rigorous jail for being addicts and keeping drugs. The convicts are Shankor, 33, son of Jitendra Nath of Noagaon and Bhulu Mia, 28, son of Akkash Ali of Sataharpara of the upazila. Police said that they were arrested with drugs on Sunday night.

## Thakurgaon town recalls the day of freedom

On December 3 in 1971, the valiant freedom fighters freed the district town from the Pakistani occupation forces.

Different socio-political and cultural organisations yesterday organised various programmes to mark the day.

District unit of Bangladesh Udichi Shilpi Goshthi chalked out a day-long programme including procession, photography

show on Liberation War, discussion and cultural function.

A colourful procession was brought out from martyred freedom fighters' memorial premises that paraded different streets of the city.

Earlier, former lawmaker and organiser of the liberation war Fazlul Karim inaugurated the programme.

A discussion was held at Thakurgaon Government Boys' High School ground. Deputy commissioner

Mukesh Chandra Biswas was present as chief guest.

Among others, superintendent of police Foisal Mahmud, acting president of district unit Awami League and administrator of Thakurgaon Zila Parishad Sadek Kuraishi, were present as special guests.

On the other hand, Thakurgaon Muktijoddha Shangshad formed a human chain at Thakurgaon intersection, demanding expedite trail of war criminals.

## Infighting kills BCL leader

A local leader of Bangladesh Chhatra League (BCL) was killed and five activists were injured in a factional clash at Burichang upazila headquarters yesterday.

The deceased was identified as Sarwar Alam Polash, a leader of BCL Burichang upazila unit and son of Latif Member of Shikarpur village.

Witnesses said, a clash ensued between

Rumel group and Kamal group of upazila BCL at noon over establishing supremacy in the area, which left six people, including Polash (Rumel group), injured.

Among the injured, Polash died on the way to Comilla Medical College Hospital. Another injured BCL activist was admitted to the same hospital.

BCL men of Rumel group swooped on the office of the upazila chairman following the killing and ransacked the office.

## Satkhira jail without doctor for 14 years

About 1,000 prisoners at the district jail are deprived of minimum treatment as the lone post of physician at the prison has been lying vacant for the last 14 years.

There are at least 954 prisoners, including men and women, at the jail.

Jail sources said, the post of assistant surgeon was never filled up since the establishment of the jail in 1998.

As a result, the authorities on and often face difficulties in providing emergency

treatment to the prisoners. They always take the sick prisoners to the district Sadar Hospital.

If the post of assistant surgeon was fulfilled, it could be possible for the authorities to give the prisoners minimum treatment on their own. This would also help them get rid of additional responsibilities of treating patients at other hospitals, they said.

The jail authorities alleged that they never got any positive response from the higher authorities

despite repeated request to arrange appointment of a doctor to the vacant post.

Contacted, jail superintendent Nurunnabi said that a decision was taken in this regard at a coordination meeting of the deputy commissioner long ago but no doctor was appointed by the authorities.

Dr. Maruf Hossain, resident medical officer at district Sadar Hospital, said the higher authorities have been urged to appoint an assistant surgeon at jail on an urgent basis.

### Minor boy electrocuted

UNB, Benapole, Jessore

A four-year-old boy was electrocuted at Komolpur village in Monirampur upazila of the district on Sunday evening.

The deceased was identified as Shuvo, son of Sadhan Kumar of the village.

Local people said, while the boy was playing with his playmates near his neighbour's house, he suddenly came in contact with an electrified iron rod and died instantly at around 5:00pm.

## Two commit 'suicide' in Dinajpur

A schoolgirl and a youth allegedly committed suicide after parents turned down their love affairs in Biral upazila early yesterday.

The deceased were identified as Janaki Rani Roy, 15, daughter of Gendu Chandra Roy and Paritosh Chandra Roy, 24, son of Jyotish Chandra Roy of Matiyain village.

The girl had an affair with Paritosh, who worked at a local

rice husking mill, for long.

But their parents declined to accept the relation when the matter became public.

Later, the duo took their lives by hanging themselves from a tree at the village at midnight.

On information, police rushed to the spot and recovered the bodies and sent them to the hospital morgue for autopsy, said Amirul Islam, officer in-charge of Biral police station.

### Man kills wife, surrenders to police

A man surrendered to police after killing his wife in Kalai upazila of Joypurhat district early yesterday.

The deceased, Sheuli Begum, 26, was an expecting wife of Helal Uddin of Takaur-Damapara village.

Quoting locals, Toriqul Islam, officer in-charge of Kalai police station, said Helal stabbed Sheuli indiscriminately, leaving her dead on the spot. The incident took place when Sheuli was asleep.

Later, mentally challenged Helal surrendered to police.

### Boy killed by stepmother

UNB, Laxmipur

A minor boy was allegedly strangled by his stepmother at Laharkandi village in Sadar upazila on Friday night.

The deceased was identified as Farad, 10, student of Class II and son of Sekandar of the village.

Locals said Sekandar bought some warm clothes for his two sons. A quarrel took place between him and his second wife Fateha Begam over the issue.

As a sequel to this, Fateha strangled Farad, Sekandar's son from his first marriage, at night and then hung the body from the ceiling of the house to prove the murder as a case of suicide.
