This request for expressions of interest follows the General Procurement Notice for this project that appeared in UN Development Business online on September 10, 2012. The People's Republic of Bangladesh has requested a credit from the International Development Agency in the amount of US\$155 million equivalent towards the cost of the Rural Electrification and Renewable Energy Development II (RERED II) Project and it intends to apply part of the proceeds of this credit to payment under the Contracts for Consulting Services for Environmentally Safe Disposal and Recycling Guideline for Compact Fluorescent Lamps (CFL).

- The expected duration of the contract will be 3 (three) months. The scope of services include: (i) Developing a national guideline for safe disposal of CFLs taking into account the local context and global best practices; and (ii) Sorting out the CFL disposal issue for the dysfunctional CFLs distributed under the Efficient Lighting Initiatives of Bangladesh (ELIB) program.
- Power Cell on behalf of Power Division now invites eligible consultants (companies) to indicate their interest in providing the services.
