

US air strike kills Pak Qaeda leader

AFP, Dubai

A US air strike in Pakistan has killed an al-Qaeda leader, Khaled Bin Abdel Rahman al-Hussainan, while he was having dinner after a day of fasting, the group announced late Friday.

The militant, also known as Abu Zaid al-Kuwaiti, was killed when he was having a late dinner after fasting during the day, the group said in a brief statement posted on several jihadist websites.

"We announce the martyrdom of Sheikh Khaled al-Hussainan who died as he was having his shuhur meal and we pray to God to accept him in heaven," the statements said.

Exporters Association (BGMEA) for siding with Delowar Hossain, owner of Tazreen Fashions, from the very beginning.

"BGMEA has maintained its tradition by siding with the owners," said Anu Muhammad, professor of economics at Jahangirnagar University.

The rights activist said the government has been trying to protect Delowar by painting the incident as an act of sabotage.

"Although the government talks about sabotage there is no sign of investigating the reasons and people behind it," he said.

The activists demanded immediate arrest of the owner of the export-oriented apparel company as well as the officials of BGMEA and

the government agencies whose negligence led to the fire.

Mishu said the factory owner sent the workers to death by violating workplace safety laws, and demanded life imprisonment for him.

"It is a criminal offence equivalent to killing. We want the owner to be arrested. But it has been over two weeks, and the owner remains at large. We strongly protest and condemn such inactivity by the government."

She cited previous cases of deaths from factory fire, where the owners went unscathed due to government's apathy.

"A precedent needs to be set. If the Tazreen owner goes unpunished, the others will continue to defy the laws."

"They were all public money. Why should the public bear the financial brunt when they are not responsible?" Anu questioned.

Not all of the 43 workers' families, however, got Tk 6 lakh each as promised, Mishu claims.

"We have got a number of families who got Tk 1-2 lakh. It is a deceit to the families -- in the name of compensation."

Anu Muhammad said, "The prime minister has donated Tk 2 lakh to the family each dead and the labour and employment ministry also donated Tk 1 lakh each."

Besides, he added, the compensation of Tk 6 lakh for each death is not enough.

"Our Serious Accident

Law stipulates that the compensation would be double the amount of money the victim of an accident would have earned during his or her lifetime."

He said the workers who died were aged 20 to 30 and they would have worked another about 40 if the country's life expectancy is taken into account.

"By all calculations, the families of the dead workers should have been given Tk 48 lakh as compensation."

He also said nobody is taking care of the workers injured in the fire.

"They are taking treatment on their own expenses. If any of the badly burnt workers becomes crippled, who will take care of him or her? We do not know the

answers."

Gulrukh also said the BGMEA has not taken any step to list the injured workers and has also not decided whether any compensation would be given to the family members of the missing workers.

Meanwhile, over 100 workers of Tazreen Fashions yesterday demonstrated at Nishchintapur Primary School in Ashulia, demanding salary and compensation.

"It is impossible for me to survive as I have no money to buy foods for my five boys," said Laizu Begum, 30, who worked at Tazreen for eight months. Her identification number is 4048. She worked on the third floor of the eight-storey building.

"I left the factory two

hours before the blaze started," said Laizu.

"I come to the school ground every day and the factory authorities note down my name. But no one gives me salary and compensation," she lamented.

Among the demonstrators were family members of some of the workers still missing.

The salary and compensation of the missing workers should be given to their family members, as the factory authorities know the workers, said Anwarul Islam Arif, who lost his wife Rehana Begum, 26, in the fire.

"My wife was a known face at the factory. Everyone knew her as she had worked at Tazreen for the last three years," said Anwarul, also a supervisor of Tazreen Fashions.

was on life support in the intensive care unit of Apollo Hospital and passed away at 4:40pm, said hospital sources.

He is survived by two sons, Ferdous Murshid and Kumar Murshid, and two daughters, Tazeen Murshid and Sharmeen Murshid.

The first namaz-e-janaza of Murshid will be held at Azad mosque in Gulshan after Zohr prayers today, and the second will take place at Dhaka University mosque after Asr prayers, Kumar Murshid told The Daily Star.

His body will be kept at the Central Shaheed Minar from 2:30pm to 4:00pm for paying last tributes. Sammilito Sangskritik Jote will organise the proceedings.

Former vice-chancellor of Rajshahi University,

Murshid had been unstable since September 23 when he suffered a brain stroke.

He was taken home from the hospital for a short period in October, but had to be readmitted to the hospital on October 18 following another stroke.

Doctors said a computerised tomography (CT) scan revealed a sign of haemorrhage in his brain.

Born in 1924, Murshid was at the forefront of the Language Movement in 1952, the Mass Uprising in 1969, the six-point movement and the Liberation War in 1971.

During the war, he was a member of the planning commission of the Mujibnagar government in exile. He was an adviser to Bangabandhu Sheikh Mujibur Rahman and Tajuddin Ahmed.

In his illustrious diplo-

matic career, he served as Bangladesh High Commissioner to Poland, Hungary and erstwhile Czechoslovakia and was also appointed assistant secretary general of the Commonwealth in 1977.

He was the first chairman of Transparency International Bangladesh (TIB) and was a trustee board member of the anti-graft watchdog till his death.

He was the editor of the literary journal New Values between 1949 and 1965. He received the Bangla Academy Award in 2010 for his contributions to literature.

President Zillur Rahman, Prime Minister Sheikh Hasina, and Leader of the Opposition Khaleda Zia yesterday in separate messages expressed profound shock at the death of Prof Murshid.

MEETING KHALEDA ZIA

200 teens held in Afghan war

development in the last four years had we been indulged in corruption. The ACC is working independently and it did not enjoy such freedom in the past," she told a view-exchange meeting with the grassroots-level leaders of Habiganj District Awami League at her Gono Bhaban residence.

Hasina, also the Awami League chief, said, "The ACC is summoning and interrogating the ministers, advisers and parliament members whenever they want. This practice was fully absent during the tenures of Khaleda Zia and HMErshad."

She alleged that the ACC would not be able to do so if the BNP was in power as "the BNP hooligans would have attacked the ACC officials".

On the other hand, Hasina said, the aim of the present government was to ensure accountability and transparency in all spheres of the government. "Our policy is to root out corruption and bring solvency in the life of the people," she added.

Hasina blasted again BNP chief Khaleda Zia for announcing anti-government movement in the month of victory and called upon her to refrain from such agitation, which the prime minister claimed, was declared to the war criminals.

The prime minister alleged that the BNP chairperson was playing a dubious game about the trial of the 1971 culprits to misguide people.

"Khaleda Zia goes to Martyred Intellectuals Memorial at Mirpur to pay respect to the martyred intellectuals on December 14 in one hand, while she announced anti-government programmes in the victory month of December to save the war criminals who killed intellectuals at the dawn of the

victory," Hasina said making a question: "Isn't it a pretence of Khaleda Zia?"

Hasina also binned the opposition's demand for restoration of the caretaker government.

Highlighting the background of the caretaker government, she said Awami League was compelled to start the movement for caretaker government in the mid '90s following vote rigging of the BNP government in different polls including Magura and Mirpur by-polls.

She said hundreds of people were killed in the national and local government polls during the rule of BNP governments. "The killers of Bangabandhu

were brought in parliament through the farcical and voter-less February 15th elections," she said.


She said the country turned into a sanctuary for terrorists and militants like Bangla Bhai from 2001 to 2006 due to patronisation of the four-party alliance government.

Hasina said the people did not forget the two-year tyrannical rule of the past caretaker government as they unleashed a reign of panic across the country.

She asked if there was any guarantee that a caretaker government would hold elections within three months. "Is there any guarantee they won't throw
