# Bangladeshi FFs invited to India

The relationship between Bangladesh and India is an extraordinary one, for it was achieved at the cost of sacrifice, said Captain (retd) AB Tajul Islam, state minister for liberation war affairs, at an event in the capital yesterday.

He hoped that India would continue to foster its remarkable relationship with Bangladesh.

The High Commission of India organised the reception programme at Indira Gandhi Cultural Centre to honour the Bangladeshi freedom fighters who have been invited by India to Kolkata to partake in celebrations marking Bangladesh's victory day at Fort Williams on December 16.

On the occasion, the High Commission also presented 20 scholarships to children of freedom fighters, including ten high school and ten undergraduate students.

Addressing the programme, Pankaj Saran, high commissioner of India to Bangladesh, thanked the government and the people of Bangladesh for acknowledging the international friends who helped Bangladesh during its Liberation War in 1971.

Tajul Islam appreciated India's initiatives of giving scholarships and inviting freedom fighters and thanked India for its continuing support and hospitality.

India will provide scholarships to a total of 1,595 direct

descendants of freedom fighters of Bangladesh this year. The freedom fighters left for Kolkata yesterday following the event.

# 15pc under-9 children at risk of disabilities: Survey

More than fifteen percent of the country's children below nine years of age are at risk of different forms of disabilities, a survey report claimed yesterday.

It said these at-risk children were being abused more than the non-risk ones.

Around 34 percent of the at-risk children fall victims to different forms of abuses, while 28 percent of the non-risk face the problems, it added.

The survey report, which was launched during a discussion at the capital's Jatiya Press Club, identified family members, relatives, and neighbours as the abusers.

The findings are based on the interviews of 3,005 under-nine children. Save the Children and Bangladesh Protibondhi Foundation (BPF) jointly conducted the survey across six divisions of Bangladesh between December 2011 and November 2012.

Forty-nine percent of the respondents were female children while 51 percent were male.

Titled "Replication of Mini-Model of BPF in Six Divisions", the stduy suggested that children in Sylhet, Chittagong and

Rangpur divisions were at higher risk of disabilities.

The report said more than 40 percent of the children at risk of disabilities shared how they faced physical tortures. On the other hand, 23 percent of non-risk children shared the same stories, it said.

The report mentioned that parents of the at-risk children expressed their frustration about the negative social attitude and stigma against their children.

Participating in the discussion on the survey findings, speakers laid emphasis on proper steps for the children's safety in their own houses and shelter homes. They also highlighted the need for the guardians' active role in the safety measures. The speakers proposed to include

disability issue in the syllabus of medical students and called for a standard child protection policy and involvement of the civil society for mainstreaming the physically challenged children.

Kristine Zeuthen Jeppesen programme manager of Save the Children in Asia and West Africa, and Dr Shamim Ferdous, executive director of BPF, among others, spoke on the occasion.

### JAIL KILLING CASE SC adjourns hearing till January 15

The Supreme Court yesterday adjourned till January 15 the hearing on an appeal filed against a High Court verdict that acquitted six former army personnel in the jail killing case.

The court passed the order during hearing on a petition filed on December 11 by the government to exempt it from issuing notice to Dafadar (dismissed) Marfat Ali Shah and Dafadar (dismissed) Abdul Hashem Mridha to face the trial.

Last year, the government filed the appeal with the apex court challenging the HC verdict in the case filed for killing four national leaders -- Syed Nazrul Islam, Tajuddin Ahmad, AHM Quamruzzaman and Captain Mansur Ali -inside the Dhaka Central Jail on November 3, 1975.

In November this year, it submitted a statement to the SC, praying for upholding the lower court verdict that gave death penalty to three former army personnel and life term imprisonment to 12 others.

In 2004, the Metropolitan Sessions Judge's Court of Dhaka sentenced to death Risalder (retd) Muslemuddin, Dafadar (dismissed) Marfat Ali Shah and Dafadar (dismissed) Abdul Hashem Mridha.

On August 28, 2008, the HC upheld the capital punishment of Muslemuddin and acquitted Marfat and Hashem. It also acquitted Farooq, Shahriar, Mohiuddin and

Bazlul Huda. On January 27, 2010, Farooq, Shahriar, Mohiuddin and Bazlul Huda were executed in the Bangabandhu assassination case.

# JMB man gets 10 years' jail

A Rajshahi court yesterday sentenced an activist of banned militant outfit Jama'atul Mujahideen Bangladesh (JMB) to 10 years' rigorous imprisonment for a series of bomb blasts in Rajshahi in 2005.

The convict, Abdur Rahim alias Nasim, was also fined Tk 2,000, in default, to suffer one more year in jail.

Four other charge-sheeted accused in the case were acquitted as they were punished earlier for similar charges, said public prosecutor Entajul Haque.

Judge of the Speedy Trial Tribunal Ekramul Haque Chowdhury delivered the

verdict in presence of the accused. On August 17, 2005, a series of bomb

blasts took place in Shah Makhdum area of Rajshahi city. Sub-Inspector Inspector Gias Uddin Ahmed filed a case against some unnamed persons on May 10, 2006.

Amirul Islam, sub-inspector of Shah Makhdum Police Station, pressed charges against eight militants including top three Majlish-e Sura members of JMB in connection with the case.

IMB chief Abdur Rahman, Sura members -- Siddikul Islam alias Bangla Bhai, and Samad alias Abdul Awal -- were exe-

cuted earlier. The four militants discharged yesterday are Delwar Hossain alias Mithu, Arif alias Alal, Kamal alias Shafiullah Tarek, and Torikul Islam.

# Bangladeshi chased by BSF drowns

A Bangladeshi man drowned in the Padma river after being chased by Indian Border Security Force (BSF) on Tuesday afternoon.

The dead is Babar Ali of Natore, said Bangladesh Border Guard (BGB) officials quoting his relatives.

Babar along with some Bangladeshis was returning from India on a boat through Yousufpur border in Rajshahi when BSF troops of Babnabaz camp in India, on a speedboat, chased them, said Subedar Hossain Ali, BGB com-

pany commander in Charghat. After being chased, all of them on board, including Babar, jumped into the river. But only Babar could not swim ashore and drowned. Later, BSF recovered the body and took it to Raninagar Police Station in Murshidabad, he added.

The victim's brother-in-law Alauddin said Babar went to India for job purpose. A process is underway for bringing back the body, Hossain added.
