Book fair opens today

Man killed in wall collapse

A construction worker was killed as the boundary wall of a house collapsed on him at Khodaitoli village in Burichong upazila yesterday morning. The deceased was identified as Abdul Alim, 45, son of Adal Khan of the village. Police said Alim, who had been working at the house of one Ohab Master of the village for the last three days, died on the spot as the wall fell on him at about 10:00am.

Boy jailed for stalking

A mobile court sentenced a teenage boy to six months' imprisonment for stalking a schoolgirl in Fulchhari upazila on Monday, reports our correspondent. Stalker Helaluddin is a class nine student of Fulchhari Pilot High School. Police said Helaluddin used to tease the girl, classmate of the boy, on her way to school and home. On information, locals caught Helaluddin and handed him over to police in the afternoon when he was teasing the girl on her way to home. He was then produced before the court, led by upazila nirbahi officer (UNO) Mehdi-ul-Saheed.

Four houses gutted

At least four houses were gutted and two people sustained burn injuries as a fire broke out at Puizar village in Pangsha upazila early Tuesday. The injured were identified as Shariful Islam, 50, owner of a burnt house, and his son Foyzal Islam, 20. Fazlul Haque Mandal, station officer of Pangsha fire service, said the fire originated from an electric short circuit at a house and soon engulfed three other adjacent houses. On information, a firefighting unit from the upazila headquarters rushed in and doused the blaze after three hours of frantic efforts, he said. The injured were admitted to the upazila health complex and then shifted to Faridpur Medical College and Hospital as their condition deteriorated. The affected house owners claimed that the loss caused by the fire could go up to Tk 20 lakh.

Arms seized

Border Guard Bangladesh (BGB) in a drive seized two pistols from Andolpur village in Chaugacha upazila on Monday afternoon. Being informed, some arms traders were staying in the area to sell some firearms, a team raided the village and seized the pistols in an abandoned condition. However, none was arrested. A case was filed in this connection.

Biting cold paralyses life in Lalmonirhat

Poor people in dire need of warm clothes

Life in the district is badly disturbed due to the biting cold accompanied by dense fog in the northern region for over a week.

Under the blanket of dense fog, vehicles move slowly with headlights on while many people, especially children and aged ones, are getting different cold-related diseases like diarrhoea and pneumonia. The low-income people, especially the farm labourers, are the worst sufferers as most of them cannot go out for work due to the adverse weather.

Around two lakh people in Lalmonirhat district are passing days in extreme misery without warm clothes. The people living in the char (landmass emerged from riverbed) areas beside Teesta and Dharla rivers are more vulnerable.

The sun was invisible for the last four days as the sky remained overcast with thick fog almost the whole

day.

"I have been facing biting cold during the last eight days as I don't have the ability to purchase warm cloth. As I can't go out for work due to the fog and cold, I have to pass days half-starved," said Kulsum Bewa, 69, widow of late Johir Ali at Kalmati Char village in Lalmonirhat Sadar upazila.

Lal Miah, 42, a rickshaw puller at Uttor Saptana village of Sadar upazila, said he and other rickshaw pullers in the village cannot go out for pulling rickshaw due to the severe cold as they do not have sufficient warm cloths.

"Even if one goes out with rickshaw in the town, he can earn only a little as passengers are not available," said rickshaw puller Majedul Islam, 45, of the same village.

Azahar Ali Bokul, driver of a Dhaka-Lalmonirhat coach service, said, "Due to the heavy fog, we have to drive the vehicles slowly. Lalmonirhat-bound buses from Dhaka often make one to two hours' delay to reach

the destination."

People in the char areas are trying to keep themselves warm by burning straw and other stems of plants. Many people were found thronging the makeshift shops on the footpaths of the town to buy warm clothes.

"We have no ability to purchase warm clothes, and so, we are waiting for help from government and non-governmental organisations," said Taher Ali, 65, a marginal farmer at Char Dawabari village of Hatibandha upazila.

Lalmonirhat District Relief and Rehabilitation Officer Anwarul Islam said, "My office has got only 2300 pieces of warm cloths from the ministry concerned and those were sent to five upazilas in the district for distribution among the cold hit people on Sunday. I sent an emergency fax message to the ministry on Monday seeking more 30 thousand pieces of warm cloths especially blankets for the cold hit people in the district."

Hartal passes off peacefully in Thakurgaon

A six-hour hartal enforced by district BNP demanding release of party's acting Secretary General Mirza Fakhrul Islam Alamgir passed off peacefully in the town yesterday.

Leaders and activists of BNP and its associate bodies took position at different points in the morning. They brought out several processions at Thakurgaon intersection, Art Gallery intersection, old bus stand and Polytechnic Institute area at 6:00am.

They blocked traffic on different roads by putting up barricades and burning tyres.

Land dispute leaves two killed

Two people were killed over land dispute in Narail and Magura districts yesterday.

Our Narail correspondent reported that a man was killed and five others were injured in a clash over a land dispute between two groups of villagers at Hardoma village in Gurudaspur upazila.

The deceased was identified as Khairul Bashar, 35, son of Abdur Rauf of the village.

Police said the clash erupted at around 12:00 noon between the supporters of Abdur Rauf and Abdul Gafur of the village, leaving Khairul Bashar, 35, dead on the spot and injur-

ing five others from both sides.

The injured were admitted to Gurudaspur upazila Health Complex.

In Magura, A man was hacked to death by his rivals at Mobarakpur village in Mohammapur upazila in the morning.

The deceased was identified as Ilias Ali 35, son of Abdul Haque Molla.

Police quoted family members as saying that supporters of Nazrul Islam, a member of Nohata Union Parishad (UP) hacked Ilias with sharp weapons while Ilias and three others were collecting earth from the land to fill up a nearby pond.

50 injured as villagers clash in Habiganj

At least 50 people were injured in a clash between two groups of villagers over establishing supremacy at Korar village in Lakhai upazila of the district yesterday.

Police said the clash was a sequel to a longstanding dispute between UP member Fazlu Mia and former member Jewel Mia over control of the village.

Both groups equipped with lethal weapons attacked each other, leaving 50 people from both sides

injured. Of the injured, 25 were admitted to Habiganj Sadar Hospital while the rest given first at the hospital.

Being informed, police rushed to the village and dispersed the clashing groups. Lakhai Upazila Parishad Chairman Rafiq Ahmed and Upazila Nirbahi Officer (UNO) Mir Mahbubur

Rahman also visited the village.

No case was filed was filed with the police station concerned in connection with the incident as of 6:00pm yesterday.
