# Anti-communal confce calls for resisting anti-liberation forces

Eminent citizens and leaders of social organisations and political parties yesterday called upon all non-communal, progressive and democratic forces to awaken and unite the country's people to build a national resistance against the communal and anti-liberation forces.

At a national anti-communal conference, they demanded banning the use of religion in politics, excluding religious elements from the constitution, completing the war crimes trial and ensuring due punishment of the war crimes accused.

They urged all to boycott political parties that are allied with the communal and anti-liberation forces, and stressed the need for infusing non-communal values and spirit of the Liberation War among the young generation to nip communalism in the bud.

Fifteen eminent citizens convened the conference, held in Kazi

Bashir auditorium of the capital's Mahanagar Natya Mancha. Leaders of different political parties and socio-political organisations joined the conference to express solidarity.

Explaining the reason for holding the conference, Prof Zillur Rahman Siddique, one of the organisers, said, "Some recent incidents including violence in Ramu worried us. These incidents have shown how wrong we were when we thought that we had ousted communalism from the country."

These incidents also show that there is no scope to keep mum, he said, adding that, "We have to find out who are nurturing the communal forces and what we should do to ward off those forces."

"We have to tell the history of Bangladesh to all, we have to tell them that there is no place for communalism in our country as the basis of the country was noncommunalism," he said.

Prof MM Akash of Dhaka

University read out a declaration paper on behalf of the organisers, urging all to establish an equal democratic culture defeating all communal, fundamentalist and militant forces, ensuring equal rights of citizens and creating opportunities for them, and moving the four basic principles of the Liberation War forward in every sphere of life.

Another organiser and noted theatre personality, Ramendu Majumdar, said the seed of communalism has been deeply planted in the society and communalism cannot be eliminated until the use of religion in politics is banned.

Emphasising chalking out a long-term plan to get rid of communalism, he said the Razakars and Al-Badrs were able to show their strength in this very month of victory as some political parties backed them up.

Sultana Kamal, former adviser to a caretaker government, said, "From this platform we have to announce that we want to see proper trial of the war crimes accused and the trial has to be completed."

"We have to take clear stance here and speak out. A country may have thousands of good people, but if they keep mum then even a few criminals can fulfil their motives. We have to say that we want to see a Bangladesh where there will be no differences," she further said.

Awami League leader Tofail Ahmed said there is a lack of unity among the pro-liberation was

JSD President Hasanul Haque Inu said, "We have to boycott the communal and militant forces and say that we would not make any alliance with those forces."

# Next general polls will be held on time

The next general election will be held in between October 25, 2013 and January 25, 2014 as per the constitution, said Civil Aviation and Tourism Minister Faruk Khan yesterday.

The election will be held under the Election Commission while an interim government will conduct the country's routine works during the period, he also said while addressing as chief guest a discussion at Jatiya Press Club in the capital.

NGOs, Bangladesh (CLNB) held the discussion observing "Benin Peacekeeping Force Day." Faruk said the caretaker

### State, govt bound to try war criminals Says human rights chief

The state and government are bound to try war criminals to ensure justice in the country, National **Human Rights** Commission Chairman Prof Mizanur Rahman told a seminar yesterday.

"But the trial of war criminals is facing threats through different ways. Different subterfuges are being shown, after hacking into a judge's personal conversation, to halt the trial," he said.

The seminar, "World Human Rights Day and the Human Rights of the Marginal People", was organised by Research and Development Collective and Oxfam in the capital's Dhaka Reporters Unity.

Mizanur said the hackers should be tried for personal privacy violation. Criticising political

parties for resorting to confrontations only for state power and without ensuring citizen's human rights, he said the state failed to establish human rights for all communities. Former adviser to a

caretaker government Akbar Ali Khan said it was essential to establish the rule of law to establish human rights.

Law Commission acting chairman Prof Shah Alam and Prof Meshbah Kamal of Dhaka University also spoke at the programme.



Muggers shoot dead trader in capital

Two muggers shot dead a local trader on Dhaka-Chittagong highway in Kutubkhali area of Jatrabari yesterday afternoon.

The dead, Rafiqul Islam Rafiq, 40, lived at Bibir Bagicha in Jatrabari. Rafiq ran a tea and cigarette stall in Baro Bazar. He also worked as treasurer at Jatrabari Baro

Bazar Small Traders' Association. A witness, Alek Dewan, a vegetable trader, said he saw locals chasing two people who were speeding away on a motorcycle. When he followed the locals, he found Rafiq lying on the ground with a bullet wound in his head. Alek recognised

the victim as he was Rafiq's regular customer.

Alek took him to Dhaka Medical College Hospital where doctors declared him dead.

Amir Hossain, president of the association, said around 1:30pm Rafiq was on his way to the Jatrabari branch of Al-Arafa Islami Bank to deposit over Tk 1 lakh of the association. But, the muggers shot him dead and snatched the money.

Rafiq also had a cheque of Tk 1.5 lakh with him to withdraw the amount from

the bank, he added. Mizanur Rahman, officer-in-charge of Jatrabari Police Station, said they recovered the cheque from the pocket of the dead but the motive behind the killing

could not be known immediately.

# Hafiz, wife express no-trust in judge

Former BNP lawmaker Hafiz Ibrahim and his wife Mafruza Sultana yesterday expressed no-confidence in a judge of the Special Judge Court-6 after she rejected their two adjournment petitions in a money laundering case.

The case was filed against them for laundering \$1.75 lakh to Singapore. The couple filed the petition against Judge Fozila

Begum. In the petition, Hafiz's lawyer told the court that his clients had earlier filed a writ petition with the High Court challenging the legality of the case proceedings. However, the HC gave a dissenting order on the writ.

Later, the matter was sent to the Chief Justice for the next course of action but the issue remains pending. So, the lawyer prayed for adjournment of the hearing.

But the trial court rejected the adjournment petitions as the HC had not given a stay on the writ. The court also fixed January 10, 2013 for next hearing of the case.
