Commerce Secretary Mahbub Ahmed told The Daily Star over the phone yesterday. The US and EU are two

largest export destinations of Bangladesh. "In the letters, we have

mentioned the government's stance regarding the Tazreen incident," Mahbub said without going into details. He declined to say what steps the government took after the blaze.

Under the Generalised System of Preferences (GSP), 97 percent of Bangladeshi export goods get duty-free access to the US.

However, the GSP does not offer duty-free access for textiles, which account for up to 80 percent of the country's exports.

As a result, exporters of Bangladesh have to pay 15.30 percent duty for exporting garment items to the American market. The country pays more than \$600 million duty annually for a little more than

\$5billion export to the US. On January 24 this year, Bangladesh attended a hearing at the United States Trade Representative on whether it should remain part GSP, after trade union AFL-CIO applied for discontinuation of the facility for the country on the ground of deteriorating labour rights environment.

Earlier, it attended the USTR hearing in 2009 and 2007.

Another senior official of the commerce ministry said generally the USTR calls for hearing on GSP in every three year. The next hearing might take place in 2015, the official said asking not to be named.

said the problem is with dense fog that gripped mainly northwestern region and the central part of the country including Dhaka, Tangail and Mymensingh over past several days. The fog is also affecting some northern districts including Jessore and Kushtia, he added.

Dense fog blocks the sunlight and enhances a feeling of cold wave that occurs at a temperature below 10 degrees Celsius. It heavily disrupts movement of ferries, launches and highway vehicles. It may also lead to accidents on the highways in case of reckless driving. Temperature in Rajshahi

yesterday varied between 12 and 16 degrees Celsius, which is normal at this time of winter, said Rashid. Temperature in Dhaka was approximately 13 degrees yesterday and may slightly fall today.

Flight operations at Shahjalal International Airport are mostly normal except between 11:00pm and 8:00am due to runway repair work.

Ferry services on Mawa-Kawrakandi route which were halted since 1:00am resumed around 7:00am yesterday, writes our Munshiganj correspondent quoting Shekhor Chandra Roy, assistant manager of Bangladesh Inland Water Transport Corporation (BIWTC).

Ferry services on Mawa-Kawrakandi and Paturia-Daulatdia routes faced disruption for hours due to poor visibility triggered by the dense fog.

Around 400 vehicles got stuck at both Mawa and Kawrakandi terminals.

Bus passengers and cargo vehicles bound for 21 southern districts faced untold sufferings due to the dense fog, which is leaving an adverse impact on businesses of agricultural prod-News agency UNB adds:

The BIWTA suspended ferry traffic on Paturia-Daulatdia route at 11:00pm on Sunday due to poor visibility caused by dense fog. The services later

resumed at 2:30am after the fog disappeared.

Metropolitan Magistrate Mohammad Mostafizur Rahman passed the order after two assistant directors of ACC, who are also the investigation officers of the cases, produced them before the court with a 14day remand prayer.

Previously, in his statement under Section 164, Managing director of Hall-Mark Group Tanvir Mahmud said the trio used to hide the forged documents of LC and Inland Bill Purchase (IBP) from the bank authorities, through which the scam was committed, Deputy Commissioner of ACC Mir Mohammad Zainul Abedin Shibly told reporters at his office in the capital.

The Sonali Bank's Ruposhi Bangla Hotel branch, which had disbursed over Tk 1,568.49 crore in loan to Hall-Mark between October 2011 and May this year, used to send the copies of forged IBP and LC to the GM and the DGMs

as per banking rules, but suspended GM Mahidur did not inspect the branch timely during his tenure, said Shibly. He said GM Mahidur in

collaboration with others kept from inspecting the branch only to make the scam a success.

On October 4, after two and a half months' investigation, the ACC filed 1 cases against 27 top officials of Sonali Bank and Hall Mark Group for misappropriating over Tk 1,568 crore of depositor's money. The amount is a portion of the total money swindled, according to the investiga-

Seven of the accused are officials of Hall-Mark including its owner Tanvir Mahmud, while the rest of Sonali Bank, including its former managing director Humayun Kabir.

The cases were filed under the anti-money laun dering and corruption prevention acts.

Mali fighters destroy more Timbuktu tombs

Armed groups occupying Timbuktu in northern Mali used pickaxes on Sunday to smash up any remaining mausoleums in the ancient city, an Islamist leader said.

The rebels' ruthless implementation of their version of Islamic law comes just days after the United Nations approved a military force to wrest back control of the conflict-ridden area.

"Not a single mausoleum will remain in Timbuktu, Allah doesn't like it," Ansar Dine leader Abou Dardar told AFP. "We are in the process of smashing all the hidden mausoleums in the

Witnesses confirmed the claims and one resident, who said he belongs to Al-Qaeda in the Islamic Maghreb (AQIM), another militant group occupying the city since a March coup plunged the west African state into chaos.

Anything that doesn't fall under Islam "is not good. Man should only worship Allah," Mohamed Alfoul said of the mausoleums, which the armed Islamists con-

sider blasphemous. The vandalism of the Muslim saints' tombs in the

UNESCO World Heritage site came a day after other Islamists in the northern city of Gao announced they had amputated two people's hands.

The continued strict application of sharia law is seen as a sign that the armed Islamist groups are unfazed by the UN's green light for the African-led military operation.

Planners have said any intervention cannot be launched before September next year. French Defence Minister Jean-Yves Le Drian however told Monday's edition of La Croix newspaper that he thought it could be launched in the first half of 2013.

In July, Islamists destroyed the entrance to a 15th-century mosque in Timbuktu, the so-called "City of 333 Saints."

"The Islamists are currently in the process of destroying all the mausoleums in the area with pickaxes," one witness said.

"I saw Islamists get out of a car near the historic mosque of Timbuktu. They smashed a mausoleum behind a house shouting 'Allah is great, Allah is great'," another resident told AFP.

The tribunal, on its own motion, issued the show cause notice following a report of Bangla daily Amar Desh, published on December 23, quoting Suranjit's speech at a rally of Awami League-led 14-party alliance a day earlier.

The newspaper quoted Suranjit as saying, "The next year is 2013. Verdict of 14 identified war criminals has already been finalised. Trial of these 14 war criminals would be completed anytime within 2013. Their verdict of execution will also be implemented. None would be able to resist it." In its order, the tribunal

said Suranjit's comment in prima facie appears "to be extremely derogatory to the independence of the tribunal, causing substantial obstruction to the administration of justice." "Thus we [tribunal] need

to have an explanation from Suranjit Sengupta as to how and on what basis he has foretold such imaginary comment in public on a subjudice matter," said Justice Hassan.

The tribunal on November 13 asked the high-ups in the government to exercise restraint and be careful in making comments on a sub-judice matter.

It also disposed of two separate contempt of court petitions against Awami League leaders Syeda Sajeda Chowdhury and Matia Chowdhury on the day.

On December 4, the tribunal also issued a showcause notice upon the editor and a reporter of the Bangladesh Pratidin for publishing report setting an "imaginary timeline" of passing verdict in the case of Quader Mollah. The matter, however, was

disposed of as the respondents offered unconditional apology before the court.

The insiders also said a few leaders are likely to be dropped from the central committee and they are trying frantically to remain in it.

A top policymaker said some central leaders would be dropped from the party this time for their poor performance and involvement in antiorganisational activities.

Contacted, AL Presidium Member Matia Chowdhury said some new faces would be included in the party leadership as there is a proposal to expand the central committee subject to approval of the committee and the national council.

the journal Cancer Research showed, tens of thousands of viruses were released to kill the cancerous cells.

Experts labelled the study "exciting," but human tests are still needed.

Using viruses to destroy rapidly growing tumours is an emerging field in cancer therapy, however one of the challenges is getting the viruses deep inside the tumour where they can do the damage.

"There's a problem with getting enough virus into the tumour," Prof Claire Lewis from the University of Sheffield told the BBC.

She leads a team which uses white blood cells as "Trojan horses" to deliver the viral punch.

'SURFING'

After chemotherapy or radiotherapy is used to treat cancer, there is damage to the tissue. This causes a surge in white blood cells, which swamp the area to help repair the damage.

"We're surfing that wave to get as many white blood cells to deliver tumourbusting viruses into the heart of a tumour," said Prof Her team takes blood samples and extract

UK, said: "It demonstrates course of chemotherapy that this innovative method of delivering a tumour-

At this stage each white blood cell contained just a couple of viruses. However, once the macrophages enter the tumour the virus can replicate. After about 12 hours the white blood cells burst and eject up to 10,000 viruses each - which go on to infect, and kill, the cancerous cells.

GONE At the end of the 40-day study, all the mice who were given the Trojan treatment were still alive and had no signs of tumours.

By comparison, mice given other treatments died and their cancer had spread.

Prof Lewis said: "It completely eradicates the tumour and stops it growing back." She said it was a "groundbreaking" concept, but

One of Mexico's top federal police officials has announced his resignation, rejecting charges of corruption and promising to elaborate on his motivation after he steps down in January.
