Seven persons died in the past 24 hours in different parts of Uttar Pradesh as cold wave conditions prevailed across the state.

# Anger justified, but violence no solution

Says Pranab; injured policeman dies

PTI, Allahabad

President Pranab Mukherjee expressed "deep distress" over the recent gang-rape of a girl in Delhi but cautioned that though anger over the "ghastly incident" was "justified", violence was "no solution".

Meanwhile, a 47-yearold constable, Subash Tomar, an Indian policeman injured in clashes during the protest died yesterday, a police spokesman said.

The 23-year-old girl was gang-raped inside a moving bus on December 16 in south Delhi. The incident sparked a national outrage and a wave of protests in Delhi.

More than 100 people were injured, including dozens of policemen.

Much of central Delhi remains sealed off after a wave of violent protests against crime in the capital and over a surge in violence against women.

Condoling the death of a policeman who succumbed to injuries suffered during the violent protests against the incident in the national capital, Mukherjee urged the youth to "control their emotions" while assuring that "necessary action" was being taken by the government.

"I take a moment here to express my deep distress over the recent incident of

brutal violence against a DELHI GANG-RAPE CASE young girl in Delhi.

"I appreciate the justified anger against the ghastly incident. But I would like to remind the youth that violence is no solution," Mukherjee said in his convocation address at Motilal Nehru National Institute of Technology (MNNIT) in the city on Tuesday.

Describing the rape victim as a "brave young

girl", the president said he prayed for her "speedy recovery" and added, "the government is alert to the situation and is taking necessary action to ensure that such unfortunate incidents are not repeated in future".

The president was speaking as the chief guest of the ceremony in Allahabad.

In a rare televised address on Monday, Prime Minister Manmohan Singh also urged for calm following the weekend clashes in New Delhi and vowed to punish the rapists for their "monstrous" crime.

Meanwhile, the condition of the gangrape victim was better than the previous day though she was still on ventilator, doctors attending on her said yesterday.

However, the doctors at Safdarjung Hospital said she was still on ventilator but her condition was improving.

Gunmen opened fire on a car carrying a senior figure from an extremist Muslim Sunni group in the Pakistani city of Karachi yesterday, killing four policemen and two other people, police

The target of the attack, Maulana Aurangzeb Farooqi, was hit in the leg by a bullet and needed hospital treatment but his injuries were not lifethreatening, police said.

Karachi police chief Iqbal Mehmood confirmed the attack and casualties and said that initial investigations showed that the gunmen were on a motorcycle, and the policemen who were killed had been escorting Farooqi.

### Sunni leader | Two killed, 11 hurt in Myanmar plane crash

A Myanmar passenger jet packed with foreign tourists crash-landed and burst into flames yesterday in a field in eastern Shan state, killing at least two people and injuring 11 others, officials said.

Black smoke was seen billowing from the charred wreckage of the Air Bagan aircraft, which came down near Heho airport -- the gateway to the popular tourist destination of Inle Lake.

#### Six killed at Nigeria Xmas church service

Gunmen attacked a church in volatile northern Nigeria during a Christmas Eve service, killing six people including the pastor, before setting the building ablaze, residents and police said yesterday, as the pope deplored "savage acts of terrorism" against Christians in Africa's most populous nation.

The raid in Yobe state is the latest violence likely to be blamed on radical Islamist sect Boko Haram, which has repeatedly targeted churches during times of worship, including multiple attacks last year on Christmas Day, during its deadly insurgency.

Boko Haram attacks have often targeted churches, as well as police and other symbols of the establishment in Nigeria. Violence linked to the insurgency is believed to have left some 3,000 people dead since 2009, including killings by the security forces.

### Iran begins naval war games: Reports tests and manoeuvres to underline

Iran yesterday launched naval manoeuvres in the Gulf, and announced plans for another exercise in the strategic Strait of Hormuz later this week, media reports said.

Revolutionary Guards naval units began a four-day exercise inside Iranian waters at South Pars, a joint gas field between Iran and Qatar, a Guards spokesman was quoted as saying by the Fars news agency.

The drill, dubbed "Fajr 91," is aimed at honing "capabilities in executing defensive and security

scenarios," Admiral Alireza Nasseri said without elaborating. The Guards are tasked with defend-

ing Iran's territorial waters in the Gulf. The regular navy, meanwhile, on

December 28 begins an exercise dubbed "Velayat 91," covering an area that includes the Strait of Hormuz, the Sea of Oman and parts of the Indian Ocean, navy chief Admiral Habibollah ISNA news agency.

Warships, submarines and missile defence systems will be used and tested during the exercise, Sayari said.

Iran frequently conducts missile

its military muscle and has repeatedly threatened to close the Strait of Hormuz to oil tanker traffic should it be attacked. The United States has warned Iran

that any attempt to close the strait would be viewed as a "red line" -grounds for US military action.

Iran's navy, with 17,000 service-Sayari said in remarks reported by the men, is tasked with defending Iranian interests in the Indian Ocean and beyond. Its offshore forces are limited to half a dozen small frigates and destroyers, and three Russian Kilo class submarines.

"The touts can easily be identified if a thorough investigation is carried out," Mynul said.


DAG Motahar Hossain Sazu said most of the court orders submitted to Madrasa Education Board were fake.

In a circular issued on March 2 last year, the apex court said it had observed that the accused were being released by lower courts on the basis of forged bail orders.

On receiving an HC bail order, lower court judges must contact the deputy registrar-6 and assistant registrar-11 at the HC division's criminal section.

An accused, according to the circular, must not be released until they receive confirmation that the HC order is genuine.
