Fertiliser kept under open sky in Gaibandha

Buffer stock godown lacks space, damage feared due to exposure to dense fog

Huge urea fertiliser allocated for the cultivation of rabi and boro crop in this current season is kept under the open sky due to space shortage in the buffer stock godown in Gaibandha dis-

If kept in the open for long, the fertiliser may get clotted and deteriorate in quality due to exposure to dense fog and drizzle, said fertiliser dealers.

The Department of Agriculture Extension (DAE) sought allocation of 58,000 tonnes of urea for Gaibandha district in this crop season. Of it, 29,052 tonnes is meant for boro

the district buffer stock, said they have no godown of their own. BCIC leased the existing buffer stock godown from BADC that is assigned to distribute fertiliser among the dealers. "In last boro season, huge

fertiliser clotted in the buffer stock godown and the dealers filed complaint with BCIC, as farmers declined to accept such fertiliser. The authority did not take initiative regarding the matter and the dealers stopped drawing fertiliser despite the threat of license cancellation," said Ataur Rahman, a fertiliser dealer in the municipality area.

Abducted teacher murdered

Fulchhari police yesterday recovered the body of kidnapped schoolteacher Hafizur Rahman from remote Char Kauyabadha in Fazlupur union of Fuchhari upazila under the district, seven days after his abduction.

On December 19, a gang of robbers attacked passengers of a country boat bound for Chithulia Digor Government Primary School in Mollarchar union.

The passengers included two bank officials and a few teachers who were going for distribution of Tk one lakh 93 thousand 250 as stipend among the students of ten primary schools in the char (landmass emerged from riverbed) area.

The armed robbers snatched away the cash from two officials of Rupali Bank Ltd, Gaibandha Branch, and kidnapped teacher Hafizur Rahman before fleeing the scene.

The criminals also mercilessly beat the passengers, badly injuring three of them.

A case was filed with Fulchhari police station but Hafizur Rahman remained traceless.

Informed, police rushed to Kauyabadha in Fazlupur union and recovered the abducted teacher's body yesterday, Fulchhari police station officer in charge Abdul Mannan said, adding that the body was sent to Gaibandha Hospital for autopsy.

None was arrested in this connection.

Double-murder in Naogaon: 2 suspects remanded

Two people, detained in connection with a double murder case, were placed on a two-day remand on Monday. Chief judicial magistrate

Mural of martyred teenage freedom fighter demanded



Local freedom fighters have demanded setting up a mural with the portrait of martyred freedom fighter Mizanur Rahman.

Then an intermediate first year student of Lohagara Degree College, Mizan joined the Liberation War after receiving some training at the local level.

His fellow freedom fighter Sayem Ali described the scene of his martyrdom. "As Md Siddiqur

Rahman, then a teacher of NarailVictoria College, also serving as a collaborator of the Pakistan occupation army, sent a massage to the freedom fighters that a group of Pak army and their local collaborator Rajakars would surrender at his Masimdia village house in Narail Sadar

upazila, freedom fighters led by Mizanur Rahman went there on December 9 in 1971 when the treacherous enemy ambushed us.

"At one stage, the freedom fighters had to retreat. Suddenly Mizan turned back alone and hurled a grenade at the enemy but it did not burst. Then a bullet pierced his chest and he died on the spot," said Sayem, who was captured and mercilessly beaten by Razakars that day.

"After that the enemy hung Mizan's body with a bamboo pole, marched the town with it and arranged a 'photo session' at Narail Chowrasta to get wicked pleasure. We heard that they buried Mizan at Narail town graveyard. But the grave could not be detected yet," he said.

The next day, the freedom fighters got reorganised and attacked the camp of Pak army and Rajakars on the compound of Narail Water Development Board, forcing them to surrender.

"We want setting up a mural with the portrait of Mizanur Rahman to keep his glorious sacrifice alive in the mind of the new generation," said Mizan's fellow freedom fighter Sayed Moniruzzam, now financial affairs secretary of Narail district unit of Muktijoddha Sangsad.

Locals fear house collapse as mindless sand lifting on

Local people of Khanshapara in Gobindagnaj upazila feared their houses might be collapsed into a large ditch at any time created due to mindless sand lifting.

The ditch is becoming deeper day by day due to continued sand lifting by the authorities concerned for setting up a cluster village, causing serious threat to the adjacent 15 houses in the area, said locals.

Government allocated about Tk one crore for setting up the cluster village on a khas wetland in the area to accommodate destitute people, said sources.

Niberon Chandra, resident of Khanshapara village, said "We repeatedly urged the authorities concerned to shift the location of sand lifting, considering the problem, but they turned a blind eye to the matter".
