A nine-year-old girl was burnt alive as a house was gutted in a fire at Chokkhanpur village in Sherpur upazila on Tuesday night. The deceased was identified as Hamida, 9, daughter of Hamidul Islam of the village. Hamida's mother Shirin Akhtar, 32, and her sister Asma, 5, also sustained burn injuries in the incident. The incident took place at around 8:00pm when the victims were asleep, said inspector Mizanur Rahman of Sherpur police station.

KU admission tests

The admission tests for first year honours courses under the academic session 2012-13 at Khulna University (KU) will begin today. The tests will continue till December 30, said university sources. At least 27,403 applicants will sit for the admission tests against 975 seats under five schools and one institute. CHUADANGA HOSPITAL INCIDENT

Khulna docs start work abstention

Doctors of Khulna division went on an indefinite work abstention yesterday, demanding arrest of the culprits who assaulted a physician at Chuadanga General Hospital on Monday.

Bangladesh Medical Association (BMA), Khulna unit, brought out a protest procession on Khulna Medical College Hospital premises and held a rally in the morning, demanding punishment of the attackers.

Sufferings of the patients mounted as doctors of all government and private hospitals started work

When a patient died at Chuadanga General Hospital on Monday, the relatives of the patient got furious, sources said.

They ransacked the hospital and beat up medical officer Dr Mashiur Rahman, leaving him seriously injured.

He was admitted to the intensive care unit of Khulna Medical College Hospital.

BMA central committee vice-president Dr Sheikh Baharul Alam said, they will continue work abstention for three hours from 9am to 11 am everyday until the arrest of the culprits.

College girl rescued from traffickers

One held on Putkhali border

Members of Border Guard Bangladesh (BGB) rescued a female college student from Putkhali border point of the district on Tuesday night while she was being trafficked to India.

The BGB also arrested an alleged human trafficker.

The 17-year-old girl hailed from Narail district town while the arrestee, Rokeya Begum Ruki, was of Putkhali village.

Rafiqul Islam, commanding officer of the 26 BGB Battalion, said on secret information that two traffickers were preparing to take a girl to India through the Putkhali border, a BGB team raided the area at about 9:00pm and rescued the girl.

The team also arrested human trafficker Ruki while her accomplice Kadam Ali fled the scene, sensing the presence of the border guard members.

The girl later told the law enforcers that they had promised to arrange a lucrative job for her in India.

A case was filed with Benapole port PS against Rokeya and Kadam Ali in this connection.

BSF picks up youth

Indian Border Security Force (BSF) picked up a Bangladeshi cattle trader from Putkhali Beel (water-body) area of Medenipur border point in Jibannagar upazila of Chuadanga early yesterday.

The victim was identified as Sentu Mondol, 26, son of Nuru Mondol of Harinnagar village in the same upazila.

Villagers said Sentu was detained by the BSF members of Dharampur Camp at gun-point at around 1:30am while he along with other cattle traders was entering Bangladesh territory with cows through Medenipur border from India.

The other cattle traders, however, managed to flee.

Commander of BGB-35 Battalion Lieutenant Colonel Qazi Asaduzzaman said that the BGB sent a letter to BSF protesting it and called for a flag meeting. BSF has agreed to discuss the matter, he added.

Jamat-Shibir men attack policemen, injure 10

At least 10 policemen were injured in an attack by the activists of Jamaat-e-Islami and its student wing Islami Chhatra Shibir at Dhobra village in Shibganj upazila on Wednesday night.

Sub-inspector Khairul Islam and ASI Nannu Mia of Shibganj police station were among the injured.

Additional superintendent of police Ariful Haque said, a team of the PS went to the village to arrest Ataur Rahman, ameer of Shahbajpur

union unit Jamaat, in a case filed for attacking police at Kansat area on December 4.

As police raided the house of Ataur, hundreds of Jamaat-Shibir men confined them and swooped on them, leaving over 10 injured at around 9:00pm.

They also ransacked a police vehicle, two motorbikes and snatched mobile phone sets from the policemen.

Police filed a case with the PS, accusing 528 Jamaat-Shibir men in this connection said the ASP.

Three school students go 'missing'

They went out of their houses for taking

part in a cricket match at Shahid Miraz-Tapan Stadium of the district, Anik's father Abdul Mannan told this correspondent.

Shaikat's mother Dalia Begum said, her son made a cell phone call and said they were confined to a house. Shaikat also urged her to save him, she said.

Officer in charge (OC) of Manikganj Sadar police station Shafiqul Islam, however, said that the three friends were staying in Cox's Bazar.

Police came to know this by mobile phone tracking, the OC said.
