Narsingdi Jubo Dal leader murdered

A Jubo Dal leader of opposition BNP was stabbed to death, allegedly due to an intra-party conflict, near party office in Ghorashal under Palash upazila yesterday.

The deceased was identified as Pothikullah Pothik, 50, convener of Ghorashal municipal Jubo Dal. He hailed from Ghorashal Miapara village in the upazila.

Police said, a gang numbering 8/10, equipped with sharp weapon swooped on him at about 12:00 and stabbed him indiscriminately, leaving him critically injured.

Pothik was a supporter of Elder Kabir group. He was attacked near Ghorashal bus stand by rivals while going to the local Jubo Dal office.

A BNP activist was also injured in the attack when he tried to save Pothik.

Pothikullah was rushed to

Narsingdi Sadar Hospital where the attending doctors declared him dead.

Police sent the body to Sadar Hospital morgue for autopsy.

Officer in-charge Shahadat Hossain of Palash PS said Pothik was a victim of the long-standing conflict between the supporters of BNP's industry secretary Elder Kabir and central body member Dr Abdul

Moyeen Khan.

THREE-POINT DEMAND

Phulbari people's 10-day ultimatum to govt

Phulbari people yesterday gave a 10-day ultimatum to the government to meet their three-point demand, including withdrawal of the home ministry's letter issued on October 14 last year, asking the local administration to help Asia Energy conduct its survey in Phulbari.

The two other demands are implementation of Phulbari accord of 2006 and withdrawal of Asia Energy office from there.

They issued the ultimatum from a rally organised by Sammilito Peshajibi Sangathan at Nimala intersection of Phulbari town in the morning.

Chaired by Phulbari Municipality Mayor Manik Sarker, also convener of the organisation, the speakers threatened to launch a

tougher agitation programme if their demands were not met within the deadline.

After the rally, they took out a procession in the town and paraded the main streets.

Local leaders of the National Committee to Protect Oil, Gas, Mineral Resources, Power and Port also held a rally at the same venue in the afternoon.

At the rally, they demanded implementation of Phulbari accord by March 29. The deal was signed on August 30 in 2006 between the BNP-led four-party alliance government and the committee after three people were killed and over 100 injured in police firing.

Police opened fire while local people were agitating against a move for open pit mining in Phulbari. The leaders of the committee also demanded immediate withdrawal of the home ministry's letter.

Raj Punnah festival starts tomorrow

Raj Punnah, a traditional festival of the Bomang tribe, begins in Bandarban tomorrow.

Sixteenth Bomang King K S Pru Chowdhury will inaugurate the five-day festival at Darbar Hall in the morning.

Raj Punnah is an annual revenue collection programme. Bomang Circle chief K S Pru Chowdhury will collect taxes from headmen and karbaris (businessmen) and the people of 109 mouzas under the Bomang circle.

On the opening day of Raj Punnah festival, the headmen of 109 mouzas and over 1,000 karbaris will pay their

allegiance to the king with annual Jum tax and traditional gifts.

Hundreds of people from remote areas of the three hill districts and elsewhere in the country have started arriving at Bandarban to attend the festival.

A fair will be held at the field in front of the Bomang king's palace during the five-day Raj Punnah festival. Bomang people will put on display their traditional food items and organise colourful cultural programmes at the fair.

Local administration has taken all-out measures to maintain law and order during the festival and ensure security of the tourists.

IU pro-VC also goes

Professor M Kamal Uddin, pro-vice chancellor of Islamic University (IU), was finally relieved of his duties yesterday, in face of weeks of protests by teachers and students.

"We have received an official fax message from the ministry of education in this regard in the afternoon," said IU registrar Moslem Uddin.

Chancellor of the university President Zillur Rahman issued the order, he said.

The step was taken in a bid to remove the stalemate that began at the university three and a half months ago.

On September 8, academic activities at the uni-

versity came to a halt as the teachers of the university under the banner of Islamic University Teachers Association (IUTA) started agitation, demanding removal of the then vice-chancellor Prof M Alauddin, pro-vice chancellor Prof M Kamal Uddin and treasurer Prof Md Shahjahan Ali for their alleged involvement in irregularities in the recruitment of 132 teachers and officials on September 7.

Earlier, vice chancellor M Alauddin was removed from his post. Prof Abdul Hakim Sarkar of Dhaka University replaced him on December 27, said the registrar.

The university is now on winter vacation. It will open tomorrow.

NEW YEAR STARTS WITH NEW BOOKS

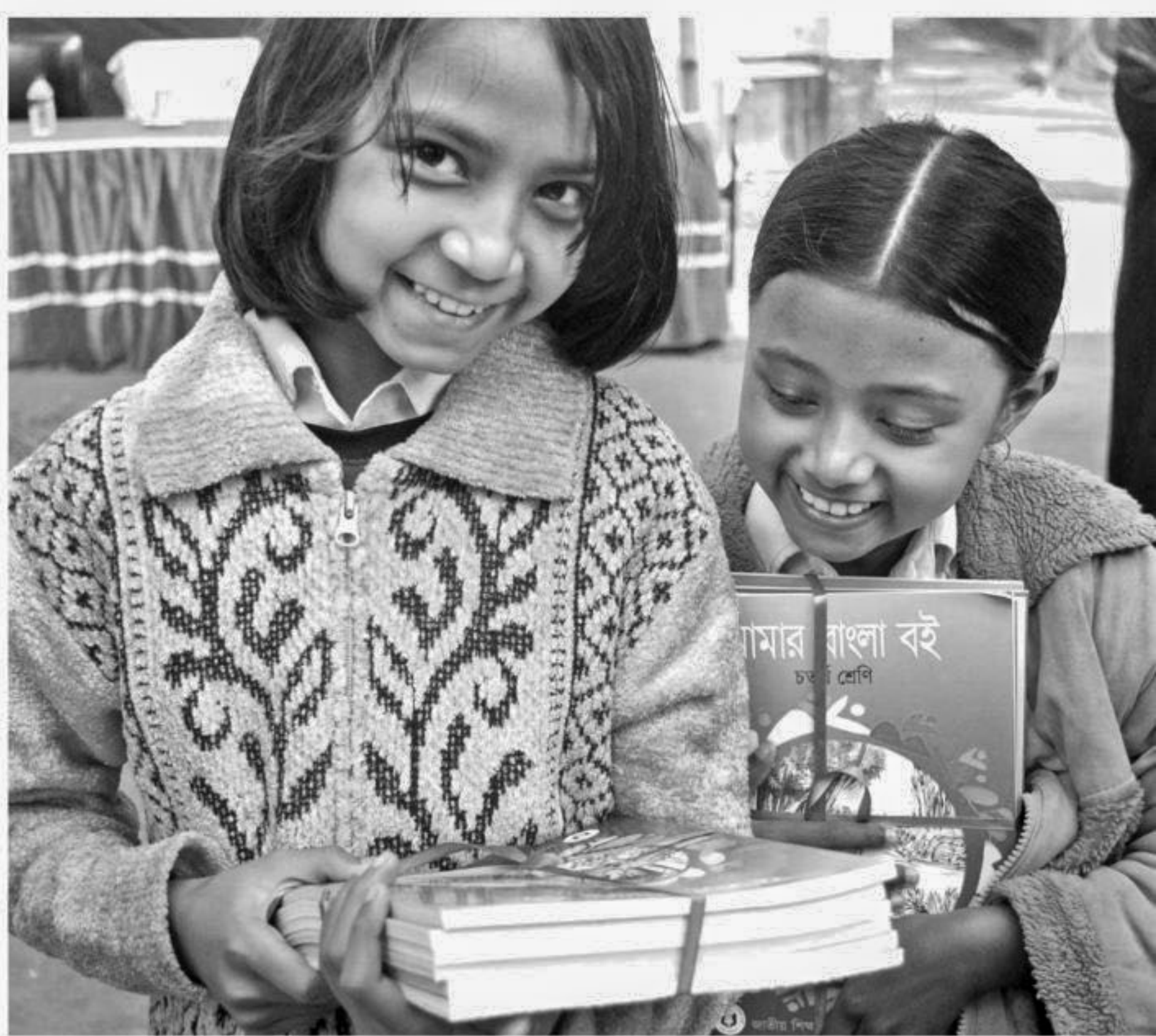

College principal confined

Bangladesh Chhatra League (BCL) cadres confined the principal of Patuakhali Government College to his office room for about half an hour yesterday. They also ransacked the principal's room. Police and college sources said a gang of 15/20, allegedly led by Atiqur Rahman Parvez, secretary of college unit BCL, confined Principal Pranesh Kanti Sikder to his room at around 3:00pm bringing a number of corruption charges against him. On Information, police rushed to the spot and rescued Pranesh. Contacted, the principal said "I am not aware why they launched the attack. Despite repeated attempts, this correspondent could not reach the BCL leader for his comment over the issue.

Ansar man 'kills himself'

An ansar man allegedly committed suicide by shooting himself with his rifle at Tattipur police camp in Kaliganj upazila yesterday morning. The deceased was identified as Azizul Islam, 35, son of Rahmat Ali of Agjantipur village under Faridpur upazila in Pabna district. He worked at the camp for a couple of years, said Sayed Kamruzzaman, officer in-charge at Kaliganj police station. "Azizul got angry while he was talking to his wife over phone at around 9:30am. At one stage, he shot himself," said the OC.

Youth found dead

A physically challenged youth was found murdered at Ranishankoil Bazar in Ranishankoil upazila early yesterday. The deceased, Joykumer Boshak, 25, son of late Durga Boshak of the area, ran a shop on a trolley. Firoz Khan, officer in-charge at Ranishankoil police station, said criminals killed Joykumer and dumped his body in the bazar area at midnight after taking away his mobile phone and Tk 700. Police arrested a man in connection with the murder, said the OC.

Housewife murdered

A mother of a child was stabbed to death allegedly by her husband over family feud in Hakimpur upazila on Monday night. The deceased was identified as Jamila Begum, wife of Md Rabiul Islam of Kaliganj village. Police arrested Rabiul in this connection. Police said Rabiul attacked Jamila with a knife, leaving her critically injured following an altercation over a family matter. Jamila was rushed to the upazila health complex where she died after sometime.

Bail prayer rejected

A court here on Monday rejected the bail plea of Jamaat-Islami ameer of Shajahanpur upazila Abdur Rahim and sent him to jail.
