Boiler blast kills worker

A rice mill worker, who was injured in a boiler blast on Sunday night, died at Rangpur Medical College and Hospital on Tuesday. The deceased was identified as Amjad Hossain, 40, of Koshaituli village in Mahiganj area of the city. Five workers were injured when a boiler at Nakib Rice Mill exploded in the area at around 7:00pm, said Altaf Hossain, officer in-charge at Rangpur Kotwali police station. Injured Amjad, Kanchan Bibi, Abdul Kader, Manu Mia and Moni Kunda of Koshaituli area, were sent to the hospital, said the OC.

Six arrested on border

Youth found dead

Police recovered the body of a young man from a field at Matikora village in Dhunot upazila of the district on Tuesday. The deceased was identified as Zohurul Islam, 28, son of Abdus Sattar of Sadar Para of the same upazila. Police said local people spotted the body of Zohurul in the area at about 10:30 am and informed them. Inspector Shahjahan Pasha(Investigation) of Dhunot police station said, criminals might have strangled Zohurul as a sequel to previous enmity over drug trading and dumped the body there.

The deceased was identified as Monoara Begum, 60, wife of late freedom fighter Abdur Rauf of the village. Acting on information, police recovered the body that bore several injury marks from a field of the village.

Criminals kill farmer

A farmer was killed and another injured at Charigaw village under Durgapur upazila on Tuesday night. The dead was identified as Ismail Hossen, 60, of the village. Neighbours and police said, when Ismail was sleeping in his bedroom at night, a gang entered his bedroom by breaking open a window and attacked him with sharp weapons. Hearing his cry for help, a neighbour, Arab Ali, rushed to the spot only to be attacked and injured by the gang. Seriously injured Arab Ali was admitted to Durgapur upazila health complex. A case was filed with Durgapur Police Station in this connection.

'Arms peddler' arrested

Rapid Action Battalion (Rab) arrested an alleged arms peddler and recovered firearms from him at Puthigara village of Ataikula on Tuesday night. The elite force sources said, on secret information that some criminals were staying in the area to sell some firearms, a team of Rab-6 conducted the drive and seized the eight air guns at night. None could be arrested as the gang managed to flee the scene sensing the presence of the law enforcers.

UP chairman faces music for caning housewife in the name of fatwa

A union parishad chairman in Kochua upazila of the district was temporarily suspended on Tuesday on charge of caning a housewife at a village arbitration in the name of fatwa (religious edict).

Kochua upazila administration executed the suspension order of the chairman of Moghia union, Mawlana SM Manzurul Karim, on Tuesday afternoon after receiving a letter from the Ministry of Local Government, Rural Development and Cooperatives in this regard.

M Ashraful Islam, upazila nirbahi officer of Kochua Karim was suspended following a ministry order and union panel chairman soon.

Selina Pervin has been asked to work as acting chairman.

On October 14, a group of villagers, led by Manzurul Karim, severely injured a housewife of Sonakur village under the upazila, by caning her at a local arbitration, accusing her of having an illicit relation with a local youth.

The torture on the woman sparked criticism across the country following its media coverage. The housewife later filed

a case with the local police station against five people, including the chairman.

GG Biswas, acting officer in-charge of Kochua police station, said police were upazila, said SM Manzurul investigating the case and a report in this regard would be submitted to the court

5 boat tragedy victims buried at their villages

Five out of six people, who drowned after a boat capsized in the Meghna in Chandpur on Tuesday, were buried at their respective villages in Chatmohar upazila of Pabna and Tarash upazila of Sirajganj districts yesterday.

The boat tragedy victims are Sajibur Rahman Sajib, 18, of Langolmore village, Helal Sardar, 22, and Md Mostafa alias Bidyut, 20 of Boradnagar village in Chatmohar upazila; and Md Abdul Mojid, 45 and Monir Uddin, 25, Ranigram village

in Tarash upazila.

They all were daylabourers and went to Chandpur in search of job, family sources said.

The bodies of the five arrived at Chatmohar upazila headquarters at around 11:00am. After janaza on Boradnagar Madrasa and Langolmore Eidgah premise, they were buried at their village graveyards after Zohr prayers.

At least six people drowned and another went missing after a boat with around 50 people on board hit a jetty in dense fog and sank in the Meghna River at Harina ferry terminal in Chandpur on Tuesday morning.


People's sufferings taken into

Natore BNP calls Villagers beat dead off today's hartal youth suspecting him a robber

Locals beat dead a youth suspecting him a member of robber gang at Debor Para village in Lalpur upazila early yesterday.

Three members of a house were also injured by the gang. The deceased was identi-

fied as Farhad Ali, 28, son of Bayes Ali of Tarapur village under the same upazila. Matiyar Rahman, officer

in-charge of Lalpur police station, said there was a family feud between Milton Ali of village Milkipara and his father-in-law Zinnat Ali of Debor Para village for long. On the fateful night,

Milton along with Alamgir, Farhad and Intaj swooped on the house of his father-inlaw with sharp weapons and injured Zinnat Ali, his son Santu and daughter-in-law Sahida Begum critically.

Hearing the hue and cry, locals rushed to the spot and chased the gang. They beat up Farhad leaving him dead on the spot. However, others managed to flee the scene. In another incident, showroom.

robbers looted over Tk 3.82 lakh from the accounts section of a local sugar mill in Sadar upazila late Tuesday night.

Sirajul Islam, head cashier of the mill, said the robbers entered the accounts section of Natore Sugar Mill located at Administrative Bhaban of the mill by breaking window grill. They entered the vault room by breaking its wall and looted the money from the vault.

In Manikganj, robbers took away 10 pieces of fridge, two motorbikes, six televisions and 11 pieces of stabiliser from the show room of Sayem Electronics at Nayadingi bazar under Saturia upazila early yesterday, reports our correspondent.

The robbers entered the show room by breaking the lock of shutter at around 2:00am, proprietor Jahangir Alam said.

The gang also looted a 200 kg iron box, locally known as sindhuk, with 35 tolas of silver and some gold in it from the shop of Sujon Saha at Koitta Khalpar, half a kilometre away from the
