3 'robbers' beaten to death in 2 districts

Two alleged robbers were beaten to death by a mob at Arpara village in Sadar upazila of Kushtia early yesterday, reports our correspondent.

The deceased were identified Arif Hossain, 25, son of Alam Hossain of Shankardia village of the upazila, and Ashraful Islam, 35, son of Atiqul Islam of Dhambalpur village in Alamdanga upazila spot, he added. in Chuadanga district.

Another member of the gang, Hasibul, 15, caught by the mob, was handed over to the police. Police recovered one pistol, three bullets, a Chinese axe from the spot.

Joynul Abedin, additional superintendent of police in Kushtia, said a gang of 7-8 robbers stormed into the

Arpara village around spondent. 1:30am.

Hearing screams of the family members, neighbours rushed to the spot and surrounded the house, the ASP said.

At one stage, they entered the house and caught three of the gang while others fled the scene, he said. The villagers beat up two

of them indiscriminately, leaving the duo dead on the Police recovered the

bodies and sent those to Kushtia General Hospital. Injured Hasibul, also of Shakardia village, was arrested by police.

Away in Naraynganj, another alleged robber was killed in a mob beating at Utma village under Sonargaon upazila early house of one Idris Ali at yesterday, reports our corre-

The deceased was identified as Faysur Rahman, 38, of Khizirpur area in the upazila.

Acting officer in-charge (OC) Harun-ur-Rashid of Sonargaon PS said, a gang numbering 15-16 were preparing to commit a robbery.

Sensing the presence of the robbers, locals announced it through the loud speaker of the local mosque.

The villagers chased the robbers, caught two of them and gave them a good beating, leaving Faysur dead on the spot while Musa, 40, seriously injured, the OC

Faysur was a chargesheeted accused in three cases, including for robbery, with the police station, the

JCD forms human chain

12 hurt in clash over land

At least 12 people were injured in a clash between two rival groups over a piece of disputed land at Kathaltoli Bazaar in Borolekha upazila on Wednesday. Of the injured, two were admitted to Osmani Medical College Hospital and others taken to the upazila health complex while the rest given first aid. Police and locals said, there was a longstanding conflict between UP member Mokbul Ali and Nisat Hotel owner Selim Uddin of the bazaar over the land. When Selim went to the land, Mokbul along with his supporters rushed to the spot and resisted the rival group, triggering a clash. Sub Inspector Mahbub Ahmed of Borolekha PS said they arrested 4 people in connection with the clash.

15 shops gutted

At least 15 shops were gutted in a devastating fire at Pakhimara Bazar in Kolapara upazila early yesterday. Abdul Malek, local union parishad chairman, said that the fire originated from an unknown source at around 4.00am. Fire fighters from Barguna district headquarters reached the spot one hour later but by that time locals managed to douse the flame. The loss in the fire was estimated at Tk 40 lakh.

Townspeople protest gambling, obscene dances at fair

People of the district town yesterday formed a human chain, demanding steps to stop gambling and obscene dances at a fair in Rajarampur area.

Under the banner of a committee to resist boozing, gambling and unsocial activities, they also held a rally in front of the deputy commissioner's office in the town to realise the demand.

Addressing the rally, the speakers said that obscene dance and gambling are being held in the name of jatra (open air drama) and variety show at the fair arranged by a section of people.

Besides, different drugs were being sold there openly, alleged the speakers.

The area has become a

heaven for drug peddlers as heroin, opium, phensidy and other items are easily found, they said.

They also urged the authorities to take stern action against the drug peddlers in the area.

Later, they submitted a memorandum to the DC in favour of their demand. Among others, Abdul

Matin, mayor of the municipality and convener of the committee, Principal Abdul Jalil of Namoshankarbati Degree College and Abdus Samad, president of Sector Commanders' Forum, spoke.

DC Shah Alam said necessary measures would be taken against those responsible for the offence after investigating the matter.

A girl has stopped attending college as a few locals harassed her on the way to the institution in Rangabali upazila.

Victim's father Alamgir Hossain of Phulkhali village submitted a written complaint to Bangladesh Ain Sohayota Kendra in Dhaka in this regard on Tuesday after failing to get support from the local people.

According to the complaint, the girl, a first year student at Rangabali College, could not attend classes because of the teasing.

Villagers said it was done in a planned way by a local following a dispute over a piece of land.

One Abdur Razzak allegedly occupied the land of the girl's father recently. When Razzak was asked to return the land, he filed a false case with Rangabali police station against the plaintiff to harass him.

Mahbubur Rahman, officer in-charge of the PS, however said Alamgir is a charge sheeted accused in a murder case.

Regarding the stalking issue, the OC said nobody came to him to file any complaint in this regard.
