Primary schools collecting admission fees illegally

Although there is no official provision for taking any fee for admission to government and non-government primary schools, most of the schools in the district are charging Tk 60 to 70 for the purpose.

The institutions are also taking Tk 40 to 70 as 'readmission fees' from the students promoted to next classes, although salary of the teachers and other staff of such schools are paid from the government exche-

"I gave Tk 140 for admission of my two kids to class one of this school," a guardian named Rahima Begum told this correspondent

during his visit to Bhoakhali Government Primary School in Narail Sadar upazila on Wednesday.

Abul Bashar, headmaster of the school, said, "We take Tk 10 for an admission form and Tk 60 for each student's admission. The money collected in this way is spent for paying salary to the employees like

Kamal Hossain, an Easy Bike driver, and a resident of of Kurigram village under Narail Sadar upazila, said he had to pay Tk 60 for his daughter's admission to class one of Shib Shankor Government Primary School in the same upazila.

"I could not have my son admitted to Shib Shankor Government Primary School as I failed to pay Tk 60 for the purpose," said Monju, a garden worker living at a slum in Narail municipality

Shamima Sultana, headmaster of the school, however, denied the allegations of taking any money for the admission.

said, "We the teachers and a guardians' committee arrange the salary of a few school employees who are not on the government payroll."

Another guardian requesting anonymity said he had to pay Tk 40 for his son's admission to class V in Auria Government Primary School this week.

Most other government and non-government schools of the district are also taking money illegally for admission.

Meanwhile, a good number of kindergartens and private schools in the district are taking 500 to 600 taka for admission as there is no official instruction to them Replying to a query, she regarding the fees for admission and tuition.

> Contacted, District Primary Education Officer Tobibur Rahman said, "There is no provision for taking any money for the admission to government and non-government primary schools. We will take necessary action if any school is found guilty in this regard."

Series of robberies: 5 held in Gopalganj

Robbers looted cash, gold ornaments and mobile sets from five business establishments, including three jewellery shops, at Bhangarhat Bazar in Kotalipara upazila on Saturday night.

The law enforcers arrested five people in this connection.

The shops are Suprio Alangker Bhandar of Anil Podder, Sarat Alagkar Bhandar of Ranjan Halder, Shilpi Jewelers of Ameo Bairagi, a grocery shop of Kamal Madhu and a mobile phone and accessories sales' shop of Kamrul Sheikh.

The victims said, a gang of 18/20 swooped on the bazar and tied the security guard.

The robbers then entered the shops by breaking open the locks and looted the valuables worth Tk 50 lakh and fled the scene, said the affected shop owners.

Bimol Krishna Biswas, chairman of Kotalipara upazila parishad, said earlier another robbery was committed at the residence of one Manmatha Ojha of Latenga village.

But, the law enforcers did not take any action in this regard, alleged the chairman. Police inaction then created panic among the businessmen at the bazar, he said. Contacted, Md Tota

Mia, officer in-charge at Kotalipara police station, said they arrested five suspected robbers and were investigating the robbery.

Rape, Murder of Chanpa in Faridpur

'Autopsy report false, bring culprits to book'

Protesters under the banner of Bikkhubdho Faridpurbasi (aggrieved people of Faridpur) yesterday formed a human chain in front of the local press club, demanding exemplary punishment to the culprits who killed schoolgirl Zakia Akhter Chanpa after rape on the night of December 13 last year.

They rejected the autopsy report that claimed that Chanpa committed suicide. The protesters termed the report false and also demanded punishment to the forensic expert, who prepared the report.

Zakia Akhter Chanpa, 15, a class nine student of Pordia Girls' High School in Kanaipur union under Sadar upazila, went missing from a wedding ceremony at her relative's house near their residence at Kashemabad village in the same union on the night of December 13.

The following morning, her body was found hanging from a tree at the village. Police recovered the body and sent it to Faridpur Medical College Hospital for autopsy.

Chanpa's elder brother Hasibul Islam, also a student of Jaganath University in Dhaka, filed a rape and murder case with Faridpur Kotwali Police Station the same day, accusing their

son Babu matabbar, relative Judicial Magistrate Abdullah Shamim Mondol and villagers Al Masud issued an order, Abul Kha and Hashem Kha,

Soon after filing of the case, police arrested Abul Kha and Hashem Kha while the rest four are still at large.



In the case statement, the complainant stated that Salam and his accomplices used to tease Chanpa on her way to and from the school and they were involved in the rape and murder of her. Parvin Akhter was an abettor of the culprits, he said in the statement.

The autopsy report, submitted by forensic Doctor Anjan Kumar Das to the Judicial Magistrate's Court a week ago, said no signs of rape and murder were found on the Chanpa's body. She committed suicide, the report revealed.

In the inquest report, Sub-Inspector Kamruzzaman of the police station mentioned that signs of rape were found on the Chanpa's body.

As per the order, Chanpa's body was exhumed on Saturday in the presence of Executive Magistrate Shahidul Islam. The body was later sent to Faridpur Medical College Hospital morgue for further autopsy. Yesterday, the protesters

also took out a procession in the town and then submitted a memorandum to the deputy commissioner, demanding immediate arrest and punishment of the accused. They also demanded punishment to forensic expert Doctor Anjan Kumar Das for allegedly submitting a false autopsy report to the court
