10-TRUCK ARMS HAUL 2 magistrates testify in court

STAFF CORRESPONDENT, Ctg Two magistrates, who recorded statements of the

witnesses and the accused in the 10-truck arms haul cases, testified before a Chittagong court yesterday.

Both of the metropolitan magistrates--Muntasir Ahmed and Md Abu Hannan--were later crossexamined by defence counsels.

In his testimony, Muntasir said he took the statement of former DGFI director general Maj Gen (retd) Sadik Hasan Rumi, a prosecution witness.

He was cross-examined by the counsels of former DGFI director Brig Gen (retd) Rezzakul Haider Chowdhury, former state minister for home Lutfuzzaman Babar, and former director general of National Security Intelligence (NSI) Brig Gen (retd) Abdur Rahim.

Replying to a question, Muntasir said, "I recorded everything in the witness's statement that he [Rumi] said and left nothing." In another reply, he said there was no case reference in Rumi's statement. The other magistrate,

Md Abu Hannan, testified that he took the confessional statement of the accused, NSI director Wing Commander (retd) Shahabuddin, and the statement of the prosecution witness, constable AKM Mohiuddin. He was later cross-

examined by Shahabuddin's counsel. When the counsel claimed that he recorded the confessional statement ignoring Criminal Procedures Code (CrPC), Hannan denied it.

On April 2, 2004, around 1,500 wooden boxes containing arms and ammunition were seized at the jetty of Chittagong Urea Fertiliser Ltd. Two cases were filed the next day.

TK 7.8CR EMBEZZLEMENT

ACC charges seven Oriental Bank staff

The Anti-Corruption Commission (ACC) yesterday pressed charges against seven former officials of now defunct Oriental Bank Ltd in eight cases filed for embezzling Tk 7.80 crore of depositors' money.

According to ACC investigation, the seven officials, including five vice-presidents of the bank, misappropriated the amount in the name of disbursing loans from the bank to some fake business firms in 2005. The five ex-vice-presidents of the now-defunct bank are

Shah Mohammad Harun, Abul Kashem Mohammad Ullah, Fazlur Rahman, Mahmud Hossain and Kamrul Islam.

The two other accused are Tariqul Alam, former executive officer, and Imamul Huq, former deputy managing director of the bank's principal office in the capital.

Abul Hossain, ACC deputy director, said he along with two other deputy directors submitted the charge sheets to the Chief Metropolitan Magistrate's Court of Dhaka.

He was speaking at a press briefing held at ACC office in the capital.

ACC investigation found that the accused sanctioned Tk 1 crore in loan to Abul Hossain, a business firm, Tk 95 lakh to Modern Bulders Ltd, Tk 95 lakh to Latif Engineers, Tk 95 lakh to Momtaj Enterprise, Tk 95 lakh to Nur Machineries, Tk 1 crore to Bakkar Hossain, Tk 1 crore to Abdus Salam and Tk 1 crore to City Com.

Deputy Director Abul Hossain said all eight business entities are fake and the account holders of the businesses are nonexistent.

REPATRIATED FROM TANZANIAN JAILS

Deceived workers want punishment for brokers

Twenty Bangladeshis, who returned last year from two prisons in Tanzania, yesterday urged the government to take strict action against their brokers for fraud and to help them get back their money from those brokers. The repatriated migrants alleged that

these brokers of unauthorised recruiting agencies had lured them to go to Tanzania promising them of giving lucrative jobs and had abandoned them at the border of the East African country without travel documents. A strong broker network exists in

Bangladesh and Tanzania to deceive overseas job aspirants, the workers also alleged at a press conference in Dhaka Reporters' Unity in the capital.

"We had to give a huge amount of money to the brokers to migrate to South Africa. But we could not reach our destination rather we suffered a lot both in the jungles and jails of Tanzania for many days", said Faruk Hawlader, one of the 20 workers.

He said, after they were repatriated to Bangladesh last year, the government had filed a case against their brokers under the anti-human trafficking law, but the brokers are yet to face trial.

Most of these workers went abroad through local brokers without taking clearance from Bureau of Manpower Employment and Training (BMET), thus making it difficult to take legal action against their brokers, said BMET Deputy Director Roksan Ara Begum.

The workers alleged that their brokers did not face any trial yet and even denied returning their money.

The 20 Bangladeshis were caught and sent to jail by Tanzanian immigration police while trying to enter South Africa without travel documents in between 2010 and 2011.

No one likes hartal

Dr Yunus for exploring opportunities for youth

GRAMEEN SHIKKHA-CISD TRAINING CENTRE LAUNCHED

it can export skilled manpower, Nobel laureate Prof Muhammad Yunus said yesterday. "The Bangladeshi youth are very creative

and are quick learners. We should explore new opportunities for them," said Yunus, while highlighting the role of youth in solving social problems. Yunus's comments came at the launch of

the "Grameen Shikkha-CISD Vocational Training Centre" in Savar. "We are not teaching in the academic

sense, rather we are creating skilled manpower,"Yunus said. Gerben De Jong, the ambassador of Netherlands to Bangladesh, emphasised the

need for skill development among the youth. "We are thinking of working with the private sector for the development of Bangladesh."

Grameen Shikkha, with financial assistance from the Netherlands-based C&A Europe, has been conducting a vocational training programme since 2008 for the country's poor and the school dropouts, said Nurjahan Begum, managing director of Grameen Shikkha.

Nurjahan said the programme is conducted as a form of social business.

The organisation has trained more than 2,300 students on vocations such as electronics, industrial swing, mobile phone servicing, garment machine mechanics, computer, solar home management and computer applications, she said.

Most of the graduates find employment

within a couple of months after graduation, Nurjahan said.

"The objective of the programme is to develop the human resource of Bangladesh with a view to expanding the country's economic development," said C&A's Director Chris Brenninkmeyer.

The programme empowers the youth from the rural and slum areas as it provides vocational training at a minimal cost, he added.

Grameen Shikkha also started a scholarship management programme with a unique idea of Prof Yunus from 2002, Nurjahan said


Nearly 180 sponsors have given financial support to more than 3,500 students in all districts of Bangladesh, according to the Grameen Shikkha MD.

"Without the Grameen Shikkha scholarship I could not have continued my study as I lost my father and mother in 2008 and 2009," said Zinnoory Begum, a student of management and information system at Dhaka University.

Zinnoory, the middle child of her parents, have been receiving Tk 4,166 every month since May 2010 for her education.

"It is difficult for my father, an auto rickshaw driver, to bear the educational expenses of his five children," said Khadiza Akter Nishat, a student of department of textile engineering at Bangladesh University of Business and Technology.

Grameen Shikkha has awarded Nishat a bursary of Tk 3,000 per month. Rokia Afzal Rahman, president of Metropolitan Chamber of Commerce and Industry, was also present.

Contract renewed for making MRPs, MRVs

The government yesterday renewed contract with a joint venture firm comprising three companies of Malaysia, Bangladesh and Poland to produce machine readable passports (MRPs) and machine readable visas (MRVs) till June

The deal was signed nearly 10 months after the expiry of the contract on March 31, 2012.

The government on April 1, 2010 signed a Tk 526 crore MRP and MRV project with Malaysian IRIS Berhad Corporation, PWPW of Poland and Dataedge Ltd of Bangladesh to introduce MRPs and MRVs in Bangladesh.

The renewed contract of Tk 133 crore will be effective from April 1, 2012 since when the joint venture has been working without any payment from the government.


