Garbage dumping turns Bogra railway station area stinky

Passengers' complaints fall on deaf ears

MAMUNUR RASHID, Bogra

Frequent dumping of garbage in front of Bogra Railway Station has polluted the environment in and around the area.

Around 18 trains pass through the station every day and thousands of passengers, who arrive here and travel to elsewhere in the country from the district, face unhygienic situation due to bad smell coming from piled up rubbish.

Passengers lodged complaints to the station master several times, but to no

effect. Some passengers of Lalmonirhat-bound "Padmarag" train said the environment of the station has become polluted. "We want to get rid of this situation," they added.

Another passenger of Bonarpara-bound train said the authorities concerned should immediately take necessary steps to stop dumping of garbage in front of the railway station.

An employee of the station on condition of anonymity said the household garbage from the nearby ward is thrown here and the people work in the department concerned of the municipality are responsible for causing a public nuisance on the station premises.

Station Master Benjurul Islam said he had sent letters to the mayor several times, urging him not to dump garbage in front of the station. "The municipality authorities did not pay heed to the request," he said.

Arshadul Bari Arshad, ex-Commissioner of Ward No 8, said railway station is not a garbage dumping area. He held the municipality authorities responsible for polluting the environment in and around the station.

Despite repeated attempts, ward commissioner Ibrahim Hossain could not be reached over cellphone for his comments on the issue.

In the absence of elected Mayor advocate Mahbubur Rahman, panel mayor Parimal Chandra said they have arranged an alternative dumping spot and will remove the garbage from the railway station area soon.



Students of different institutions in the city formed a human chain in front of the press club yesterday, demanding establishment of Public Service Commission (PSC) zonal office here.

They also demanded for raising age limit for government jobs from 30 to 35 years.

Earlier, they brought out a procession that paraded the main streets of the city in favour of their demands.

At the human chain, the participants said that the government established the zonal office of PSC in all divisions except Rangpur while over 50,000 here appear at different examinations, including BCS, under the commission round the year.

There are 21 honours level colleges, two public universities, six government and non-government medical and dental colleges in eight districts under the division. Besides, it has more than 250 degree level colleges, they said.

The job seekers of the division, most of them hail from middle class families, have to face financial crisis to participate in the examinations in Rajshahi and Dhaka.

Considering the woes of the applicants, the participants urged the government to take steps to set up the office in the division without much delay.

They, however, threatened to go for tougher programmes like hartal if the demands were not met immediately.

Later, they submitted a memorandum to the DC to realise the demands.

Body recovered in enclave

4 return after jail term in India

Fake energy drinks seized

A mobile court yesterday sentenced two people to jail and fined them Tk 2,50,000 for making fake energy drinks. The convicts are Murad Mallick, 28, son of late Akbor Mallick of Dafader Para in Daulatpur area in the city and Zilan Hossain, 25, son of late Oliur Rahman, of Baoisona village under Naragati upazila in Narail. Acting on a tip-off, DB police raided the house of Rafiqul Islam at Deana Modhyapara Hospital Road and arrested tenants Murad and Zilan from a fake energy drinks factory at the ground floor and recovered 3,000 bottles of fake drinks and equipment.

DEADLINE GOES UNHEEDED

IU teachers won't return to classes

Islamic University Teachers Association (IUTA) yesterday decided not to return to classes until their three-point demand were met.

The decision was taken at a meeting at the association's office on the campus.

The three demands are -immediate removal of treasurer Shahjahan Ali, sacking of corrupt officials including proctor who had joined hand with immediate past VC M Alauddin and pro-VC Kamal Uddin and investigation into the incident of attack on teachers' meeting on November 19.

Earlier on Monday, different organsiations issued an ultimatum at separate meetings with vice-chancellor Prof Abdul Hakim Sarkar and asked him to meet the demand within 24 hours.

The organisations are IUTA, Bangabandhu Parishad IU unit, Zia Parishad and Green Forum.

"The VC did not take any

step although he promised it and the deadline ended at 12:00pm on Tuesday," Prof Iqbal Hossain, Yakub Ali, newly elected general secretary of IUTA said.

Academic activities at the university came to a halt as the teachers of the university under the banner of IUTA begun agitation on September 8 last year, demanding removal of the then vice-chancellor Prof M Alauddin, pro-vice chancellor Prof M Kamal Uddin and treasurer Prof Md Shahjahan Ali for their alleged involvement in irregularities in the recruitment of 132 teachers and officials on September 7.

Meanwhile, the authorities concerned relieved Prof Alauddin and Prof Kamal Uddin of their duties on December 27 and January 1 to end the four-month-long deadlock.

But the treasurer was not replaced. Contacted, the new VC told this correspondent that he was trying to settle the matter with the teachers.

Trader injured by stalkers dies
