

Japan plans extra \$2.1b in military spending

Japan plans to spend an extra \$2.1 billion on missiles, fighter jets and helicopters, an official said yesterday, as it tries to strengthen defence capabilities with concerns growing over a rising China.

The cash injection over the next few months comes on top of regular military spending for 2012-13. It is separate from a request for a rise in the military budget for the next fiscal year which policymakers called for on Tuesday.

"We will request 180.5 billion yen to be allocated to military spending from a stimulus package," a defence ministry spokesman told AFP, adding that some of the money would be used to buy PAC-3 surface-to-air anti-ballistic missile systems and modernise four F-15 fighter jets.

The announcement came a day after Prime Minister Shinzo Abe's ruling Liberal Democratic Party said Japan would increase military spending for the first time in 11 years in the next fiscal year starting April.

US plans to leave no troops in Afghanistan

President Barack Obama would consider a plan for post-2014 Afghanistan that would leave no American troops in the country, a senior US official said, ahead of talks with President Hamid Karzai later this week.

Officials however stressed that Obama, mulling how quickly to draw down US soldiers from the country, would not be guided by specific future troop levels, but would decide the fate of the American presence based on strategic needs.

Asked whether Obama would consider a scenario in which all US troops left and there was no residual force in Afghanistan, Ben Rhodes, a deputy national security advisor said: "That would be an option we would consider."

"We wouldn't rule out any option. We are not guided by the goal of a certain number of troops in the country. We are guided by the objective that the president has set," Rhodes told reporters Tuesday.

Obama's goals are to ensure that Afghanistan's new national army has the capacity and equipment to defend itself and to ensure that al-Qaeda cannot make a post-war comeback and again find safe haven, he said.

Ahead of the meeting with Karzai, reports citing US defense sources have put forward a range of possible plans -- including the "zero option" for the residual level of the American commitment to Afghanistan.

The Wall Street Journal reported late last week that the Pentagon had prepared plans for a smaller presence in Afghanistan at the insistence of the White House.

The newspaper said the plans now prepared by the Pentagon call for leaving roughly 3,000, 6,000 or 9,000 US troops in the country.

The presence of US troops in Afghanistan after 2014 will also have to be governed by a status of forces agreement, which Obama and Karzai are expected to discuss at their talks at the White House tomorrow.

putting embargo on exports from Bangladesh, citing so-called violation of human and worker rights."

"However, the possibility of such embargo in practice seems less likely, as it could be against WTO rules and other international norms," the draft position paper said.

The withdrawal of GSP for Bangladesh is likely to be widely publicised around the globe and would negatively impact the Foreign Direct Investment (FDI) in Bangladesh, the paper added.

The paper also said the news of GSP withdrawal on the grounds of unsafe and hostile working environment might encourage the US consumers to shy away from purchasing Bangladesh-made products.

The withdrawal might also tarnish the image of Bangladesh's higher achievements of Millennium Development Goal (MDG), the paper said.

Asked, Commerce Secretary Mahbub Ahmed told The Daily Star, "I will hold meetings with the officials to finalise the country's position regarding United States

Trade Representative's (USTR) GSP hearing in the US."

He said the ministry would also place progress reports of the commitment of the previous hearing that took place on January 24 last year.

Bangladesh pledged to introduce Better Work Programme of the International Labour Organisation (ILO) and International Finance Corporation (IFC), according to the copy of the hearing. The Daily Star obtained the copy of the third hearing of USTR.

The government also committed to launch a project in collaboration with the Bangladesh Garment Manufacturers and Exporters Association (BGMEA) to establish dormitories for female workers in Chittagong.

director, director, secretary, general manager, or any other officer of any authority, by whatever designation he is called, may be prosecuted.

If found guilty, he may be sentenced to jail for a maximum of three years and fined Tk 50,000, or may get both penalties.

According to the proposal, the word "authority" refers to any department of the government, statutory public authority or statutory body, registered company, partnership firm, society or association.

In defence of such a proposal, a senior EC official said the EC has taken the initiative to enforce effectively the provisions stipulated in the constitution and the RPO.

Article 126 of the constitution says it shall be the duty of all executive authorities to assist the EC in discharging its functions.

From the date of dissolution of the parliament and until the formation of a new one, the government shall not take any decision relating to appointment, transfer and posting of officials of all ministries and of offices subordinate thereto without prior consultation with the commission," says the proposal.

But according to the current constitutional provision, the next parliamentary polls will be held within 90 days before dissolution of the current parliament.
