



## Rescue little Aklima from strange disease

Six-year-old Aklima Begum, daughter of day labourer Abu Kaiser of Mathbaria upazila under Pirojpur district, has been suffering from a strange disease marked by unusual swelling of palm muscle for the last five years.

At a programme organised by local online newspaper www.amaderbarisal.com at Barisal Reporters Unity last month, Abu Kaiser, a day labourer, and his wife Fahima Begum, made a fervent appeal to the affluent people to help for treatment of their daughter.

After a year of her birth, Aklima's left hand palm muscle started swelling unusually, they said.

It worsened gradually and now the girl faces serious problem to carry on his normal daily activities as she has to engage the other hand to carry the diseased palm.

Aklima has eagerness for study but the strange disease stands in the way.

Doctors at Bangabandhu Sheikh Mujib Medical University Hospital in the capital suggested early operation to bring the girl back to a relatively normal life but it requires a lot of money, said the poor parents.

Earlier on November 1, www.amaderbarisal.com published a report titled 'asuabhabik haat niey Aklimar durbisaho jibon' (unbearable life of Aklima with unnatural hand).

Consequently, several people expressed their sympathy for the girl and donated sums for her treatment.

At the programme at Barisal Reporters Unity, Md Jewel Arman, a Saudi expatriate, handed over 50 thousand taka collected by him from some Saudi expatriates for Aklima's treatment.

The money collected so far, however, is still much less than the requirement.

At the programme attended by local journalists and the elite, speakers called upon all to help raise fund for bringing Aklima back to a normal life.

# Khulna jail has little treatment facilities for women inmates

Khulna district jail has no treatment facilities for the female prisoners.

Though there is a hospital for the male inmates in the jail, the fair sex are not entitled to have any treatment there.

Besides, when the 25-bed hospital is filled to its capacity, the male patients also receive treatment on the hospital floor.

Only a pharmacist remains on constant duty for treatment of the inmates at the hospital, jail sources said.

To the patients, he is known as 'Chhoto Daktar' or a doctor in crisis.

The lone physician at the hospital is known to them as 'Bara Daktar' or main doctor.

Male prisoners with serious illness are given indoor treatment at the hospital while those with minor physical problems get first aid there.

But the female inmates have no access to any of the medical facilities, be it indoor or outdoor.

Patients with serious illness that the hospital finds unable to handle are sent to the prison cells of either Khulna General Hospital or Khulna Medical College and Hospital.

Recently, the jail authorities have set up a 'temporary' treatment centre inside the women ward, where it is not possible to provide treatment to more than two female

patients at a time.

However, the authorities sometimes bring all sick female inmates to the ward for treatment, putting the general women inmates in an awkward position.

The situation has not only frustrated the human rights bodies but also angered many of them.

Advocate Mominul Islam, coordinator of Khulna unit of Bangladesh Manabdhikar Bastabayan Sangstha, said the matter depriving the female prisoners of treatment facilities, a basic right, cannot be accepted.

Mansura Begum, who was released on bail from the jail on November 22, expressed her resentment over the situation and said when women prisoners fall sick, a pharmacist is called for treatment.

Mansura further alleged that the 'Chhoto Daktar' dispenses medicines only for fever, headache and cold-related diseases.

Jailer Md Rafiqul Islam admitted to the allegation that there was no medical centre for the women prisoners.

Beds for women at the jail were not considered when it was established in 1812, Rafiqul Islam said.

It was not possible to set up a hospital for women in the jail for want of space, he added and said that the authorities should set up a hospital in the compound immediately.

## 125th founding day of a Patuakhali school

Patuakhali Government Jubilee High School, one of the oldest and renowned schools in the country, will celebrate its 125th founding anniversary with a two-day programme beginning today.

Home Minister Mohiuddin Khan Alamgir will be present at the programme as chief guest, said organisers.

The programmes include colourful procession, debate competition, memorial meeting and cultural function.

Old and new students will bring out the procession from the school premises at around 8:30am today.

The district town has been well decorated on the occasion. Over 50,000 guests, including former and

present students, are expected to be present at the celebrations on school premises.

The school was set up in the town in 1887 during the Queen Victoria's Golden jubilee festival.

A group of young men began the activities of the school 'Patuakhali Entrance School (up to class eight)' at a small house at the launch ghat in the town.

In 1952, this school enlisted in Uplift Scheme. In 1962 it enlisted in Maltire Tarol Scheme. On 15th November, 1968 this school had been nationalized and name the school as 'Patuakhali Govt Jubilee High school' in government level.

Minister Shahjahan Mia, Justice Nizamul Haque Nasim and Additional Deputy Attorney General MK Rahman, among others, were the students of the school, said acting headmaster Md Siddiquir Rahman.

## Fake brigadier arrested

# Brick field manager beaten to death in Natore

## Victim's father-in-law accuses owner

Severely beaten up allegedly by the employer, manager of a brick field died at Natore Sadar Hospital early yesterday.

The deceased is Fazlul Haque, 45, manager of AKC brick field in Natore, and son of Azahar Ali of Tarafbhaikha village under Gabtoli upazila in Bogra.

"Brick field owner Abdur Rahim and its manager Fazlul Haque used to sit on the same chair. On Monday

afternoon Rahim came to the brick field office when Fazlul was sitting on the chair. Seeing Fazlul on his chair, Rahim became angry and beat him up with wooden sticks, causing serious injuries to him," said the victim's father-in-law Monu Mian.

Locals later rushed Fazlul to Natore Sadar Hospital

where he succumbed to his injuries early Thursday.

Eyewitnesses, however, said Fazlul faced wrath of his employer as Fazlul kept his socks on the chair.

"Rahim often assaulted Fazlul on trivial matters. He beat him up with iron rods last month. But Fazlul continued working there just for earning his bread. Rahim, a rich and powerful man, is now giving death threat to Fazlul's family if they lodge any case against him," Monu Mian said.

Police found some injury marks on Fazlul's body that has been sent to Natore Sadar Hospital morgue for autopsy, said Jalal Uddin, sub-inspector of police in Natore.

Munshi Asaduzzaman Tony, resident medical officer in Natore Sadar Hospital, said they also found some injury marks on Fazlul's body and sent the relevant

organs to Dhaka for viscera report.

Apel Mahmud, assistant superintendent of police in Natore, said no case was filed with Natore police station in this connection as of filing this report at 5:00pm. Police will take stern action against the culprits just after they receive the case, he added.

Despite repeated attempts by this correspondent, Abdur Rahim could not be contacted as he was not available at his house and his mobile was found switched off.

Rahim's brother Abdur Karim said, "Rahim did not beat up Fazlul on Monday. He had beat him a month ago in connection with stealing of money. Manager Fazlul was an asthma patient and he died from the disease."
