### 3 cops hurt in clash with BNP men

INDO-BANGLA EXTRADITION TREATY

### Indian cabinet nod likely today

The Indian Cabinet is likely to consider a proposal today to sign an extradition treaty with Bangladesh ahead of Home Minister Sushilkumar Shinde's visit to Dhaka next week.

The treaty could be signed during Shinde's three-day visit to Dhaka beginning January 28.

The long-awaited extradition treaty is being considered by the cabinet after the Bangladesh government made minor modifications in the draft, sources said.

The cabinet meeting will be presided by Prime Minister Manmohan Singh.

The extradition treaty, if signed, is expected to pave the way for deportation of jailed Ulfa (United Liberation Front of Assam) General Secretary Anup Chetia and

many other insurgents from Bangladesh. The agreement will also help Dhaka in getting back its criminals who are currently lodged in Indian jails.

India has been pressing for Chetia's deportation since long. The Ulfa militant has been in a Dhaka jail following his arrest in 1997 on the charge of entering Bangladesh without valid documents.

He, however, moved court seeking asylum in Bangladesh on security reason, making it "legally" difficult for Dhaka to execute New Delhi's demand.

## TIA ORPHANAGE GRAFT SC fixes March Hasina defends \$1b defence purchase from Russia

Strongly defending the \$1 billion defence purchase from Russia, Prime Minister Sheikh Hasina yesterday said the government was modernising the armed forces in the light of "the country's defence policy".

"The defence policy was formulated in 1974 at the instruction of the father of the nation and in light of the policy, the "Forces Goal 2030" was prepared, and in light of that the armed forces is being reconstituted and modernised," she told a press conference at the Prime Minister's Office yesterday.

Military weapons will be purchased so that the armed forces grow strong and become capable of defending the nation's independence and sovereignty, Hasina said. "It is futile to become a king without swords and shields," she said in response to questions on the justification of the huge arms purchase.

The prime minister visited Russia on Jan 14-17 to sign a number of deals with Moscow, including the defence purchase and financing of the Rooppur nuclear power plant.

She said arms purchase was not a new subject, Bangladesh used to buy military hardware from many countries including China, Russia, USA, UK, Japan and Italy.

Recently, the government procured more military equipment including 44 tanks, training planes and missiles through cash payment from China but no-one raised any questions, she said, adding that Bangladesh needed military equipment as the country was engaged in UN peacekeeping missions.

Bangladesh purchased military equipments including armoured personnel carriers (APCs) from Russia when peacekeepers were sent on peace missions, and the UN later reimbursed the expenditure, she said.

Apart from modernising the armed forces, Hasina said the government kept in consideration the maintenance of sovereignty on the 1,11,631 square kilometres of area in the Bay, which Bangladesh won against Myanmar.

Asked if the arms deal got the cabinet approval, she said it was not.

A committee comprising defence, finance, foreign and cabinet division officials was constituted to scrutinise the deal, she said. "Not everything about defence is made public, some is kept secret everywhere."

#### **ROOPPUR NUKE PLANT**

The PM said ROSATOM, the atomic energy commission of Russia, was very eager to start the actual work of Rooppur Nuclear Power Plant within this year. "The design will be completed by

May, and preparatory work of the plant site will be finished by August and actual work will start by September-October," she said. The nuke power plant will have

two reactors of 1000MW, and there will be five-tier safety arrangements.

As per the agreement, Russia will take back the waste of the plant, she said.

The prime minister said two agreements were inked to set up the nuclear power plant, under which Moscow would provide \$500 million to finance the preparatory works. The interest rate is very low, she said.

### 7-year-old girl raped, culprit held STAFF CORRESPONDENT

A seven-year-old girl was raped on Tuesday and police detained a man in this connection on the same day from the capital's Khilgaon area.

The detained is Manik, a night guard and father of a two-year-old girl, who is also the victim's neighbour.

Faruk Hossain, subinspector of Khilgaon Police Station, said on Tuesday evening Manik called the victim to his room. The child's mother came looking for her and heard her daughter's groans from inside Manik's room.

She knocked on Manik's door and demanded to know why the room was locked with her daughter inside and why the girl seemed in pain, Faruk said, adding that Manik could not give any satisfactory answer to her or to the locals who were called.

The sub-inspector said Manik's wife along with their daughter had gone to their village, so Manik was alone in his rented house.

The victim's mother filed a case and Khilgaon police arrested Manik in the area on Tuesday.

The victim was taken to Dhaka Medical College Hospital (DMCH) yesterday where doctors found evidence of rape on her.

Manik yesterday was produced before a Dhaka court, which sent him to

The victim has been admitted to DMCH One-Stop Crisis Centre (OCC)

Dr Bilkis Begum, coordinator at OCC, said doctors who examined her found injury marks on the victim.

A forensic test will be done on the victim to ascertain the rape.
