HUMAN CHAIN BY PEOPLE OF GAIBANDHA

'Restore shut-down local trains'

Locals formed a human chain along the platform of Gaibandha railway station yesterday demanding immediate restoration of four shut down local train services in the northern districts under Western Zone of Bangladesh Railway.

At the programme organised by Gaibandha Nagorik Parishad, the speakers urged the authorities to take immediate steps including recruitment of adequate

manpower to resume operation of the closed trains and warned of greater agitation programmes including hartal otherwise.

Authorities closed operation of local 481-up and 482down trains that had been plying Lalmonirhat-Santahar route via Gaibandha and Bogra on December 18 last year.

Earlier on August 23, 2011, the railway authorities closed up and down trains of 'Ramsagor Express' plying Bonarpara-Thakurgaon route via

Gaibandha, Rangpur and Dinajpur.

Consequently, no train is available till 11:00am from Gaibandha station for going to Bogra, Rangpur, Dinajpur and other places and so, students, office staff, traders and others requiring travel in the morning are badly suffering.

People have to count extra money to travel to the places by bus.

Due to the situation, traders face problem to transport vegetables and other perishable goods from

rural areas to the markets in district headquarters.

"The railway cannot run all the trains properly as a large number of posts of loco-masters and assistant loco-masters in metre gauge sections are lying vacant for long," said Abdul Hye, divisional railway manager, Lalmoirhat.

"Authorities will resume operation of all the shut down trains as soon as the vacant posts are filled up. Meantime, to overcome the western railway have for- among others.

Leader 'Goes Missing' in Dhaka

BCL activists at IU continue agitation

Saiful Islam, BCL president of Bangabandhu Hall unit at Islamic University in the district 'went missing' in capital Dhaka onTuesdaynight.

BCL activists at Islamic University in Kushtia yesterday blocked the Kushtia-Khulna highway for one and a half hours, demanding immediate steps to rescue their leader.

Saiful Islam, went to Dhaka to meet with the central leaders of Awami League at its Dhanmondi office there and since remained traceless, BCL sources said.

Hailed from Bheramara upazila of Kushtia, Saiful is a fourth year student at law department at the university. The blockade was with-

drawn after Joynul Abedin, superintendent of police in Kushtia, assured the students of taking steps to find the missingleader within two days.

The BCL men yesterday put-up road barricade in front of the main gate of the university around 11:00am.

Earlier on Wednesday and Thursday, the BCL activists blocked the same highway to press home their demand. Saiful, who went to Dhaka

on Monday, went missing on

his way to Kazipara at Mirpur from Farmgate area around 9:15pm Tuesday, sources said.

Saiful's cell phone was also found switched off since then. Sad Ahmed, elder brother

of Saiful, and Shishir Islam Babu, BCL organising secretary of Bangabandhu Hall unit, filed two separate general diaries with Sher-e-Bangla Nagar police station in Dhaka and Islamic University police station in Kushtia on Wednesday.

Meanwhile Sher-e-Bangla Nagar police on Friday arrested two people in connection with the incident.

The arrestees are Jweel Hossain and Md Rana.

Abdul Jalil, sub-inspector at the police station told this correspondent that they arrested them from Farmgate area in the capital on Friday night.

Unite for full implementation of CHT peace accord

Santu Larma tells headmen

Chairman of Chittangong Hill Tracts (CHT) Regional Council Jyotirindra Bodhipriya Larma yesterday urged the headmen (traditional leaders) in the hills to be united for full implementation of the CHT peace accord.

Addressing as chief guest at the second CHT Headmen's Conference held at the auditorium of Khudro Nrigosthi Institute in Rangamati town, Jyotirindra, who is popularly known as Santu Larma, also urged the traditional jummo leaders not to get involved with national political par-

"National political parties including Awami League, BNP and Jatiya Party do not believe in democracy and good governance. They are against the CHT peace accord, and always work customs as good leaders in against the interest of jummo people living in chief. hills," he said.

Urging the headmen to support Partbatya Chattagram Jana Sanghati Samity (PCJSS), Santu Larma, also the chief of PCJSS, said, "Do the politics which will help to ensure establish your fundamental rights and never betray with

must be competent, qualified and educated to be able to discharge their duty rightly. They have to involve with all kinds of social and development activities in the society. They have to be inspired with the values of jummo nationalism to establish the rights of hill people.

"As public representatives, the headmen have to play their role in protecting own culture, tradition and the society," said the PCJSS

"CHT Regional Council and three hill district councils have become dysfunctional institutions as the successive governments during the last 15 years were not sincere about the rights of the jummo people and lacked political goodwill to implement the peace accord fully," said the former guer-

Santu said the AL-led government has done nothing other than giving assurance to implement the peace accord in last four

years. Traditional leaders put their eight-point demand including increase of a headman's allowance to Tk 7000 (from present Tk 1000) and a karbari's allowance to Tk 3000 (from present Tk 500), making traditional laws and institutions functional, construction of offices for three circle chiefs and head-

Two hundred and twentyfour headmen out of a total 375 under Chakma Circle, Mong Circle and Bomang Circle took part in the twoday conference, to be concluded today.

CHT Headmen's Network organised the conference under the auspices of CHT Regional Council, International Labour Organisation and CHTDF-UNDP.

Tarun Kanti Ghosh, vicechairman of CHT Development Board, Robert Stoleman, UNDP-CHTDF chief of implementation, Shamsul Huda, executive director of ALRD, and Brishaketu Chakma, member of Rangamati Hill District Council, spoke at yesterday's function chaired by Ranglai Mro, president of CHT Headmen's Network.

40 injured as AL, BNP lock in armed clash

Over 40 people were injured during a clash between the activists of Awami League and BNP in Shayestabad area under Barisal Sadar upazila on Thursday night.

The trouble began when Shayestabad Union Parishad (UP) Vice Chairman and local BNP leader Shamim Hawladar along with his party men went to Ramkathi Government Primary School ground adjacent to the house of UP Chairman and AL leader Arifuzzaman Munna at around 8:00pm to have a picnic there. Locals said AL men led by Munna swooped

on the BNP men, prompting them to retaliate. The rival political groups used sharp weapons and exchanged fire during the clash that continued for four hours, they added.

Four houses of local BNP men were also vandalised during the clash.

Of the injured, UP Chairman and AL leader Arifuzzaman Munna, Shahidul Zamaddar, Nasir and Basir, were admitted to Sher-e-Bangla Medical College Hospital with bullet injuries while the rest to different hospitals and clinics in the city.

Barisal City Corporation Mayor Shawkat Hossain Hiron visited the injured at Sher-e-

Bangla Medical College Hospital on Friday. Being informed, police and Rab personnel went to the spot, dispersed the clashing groups and

brought the situation under control. They picked up 51 people, including UP Vice Chairman and BNPleaderShamim, from the spot.

Md Ibrahim, member of Ward No-7 of the UP, said at least 20-25 gunshots were fired and over 50 people injured during the clash.

Contacted, Rafiqul Islam, officer-incharge of Kawnia Police Station, said they found a gun with six cartridges on the spot and arrested 51 people, including UP Vice Chairman Shamim.

UNB adds: Awami League and BNP men clashed over capture of a khas pond at Ratankandi village in Shahjadpur upazila of Sirajganj yesterday, injuring at least 13 people. Police said there had been a longstanding

dispute between two groups-one led by local AL leader Rashid and another by local BNP leader Juran--overtaking possession of the pond.

The clash ensued when Juran and Rashid groups went to the spot to take possession of the pond at around 9:00am.

They made chase and counter chase and hurled brick chips at each other. Police went to the spot and brought the situation under control.

Three houses were also vandalised in the area during the clash. Five of the injured were admitted to Sirajganj General Hospital while the rest given first aid. No case was filed with the police station concerned as of 6:00pm yesterday.

Bring rapists to book, demand protesters

Driver, helper held in Manikganj

Different organisations formed human chains in front of Manikganj Press Club yesterday and on Friday demanding exemplary punishment to the rapists of the garment worker.

Police said the 18-yearold garment worker was raped on a running bus on Dhaka Aricha highway by the driver and helper of the bus and then thrown out of the vehicle at Manora in Manikganj Sadar Upazila on Thursday afternoon.

Law enforcers arrested the driver, Dipu Miah, 30, and his helper Kashem Miah, 28, the same day. They were produced in the Judicial Magistrate's Court-1, Manikganj, on Friday. After recording their confessional statements, Senior Judicial Magistrate Sheikh Md Mujahid-ul-Islam sent them to jail.


