them will be around Tk 40,000. Initially, the selected

jobseekers will not have to bear any expenditure, as their migration costs would be borne by the employers. However, the costs would be later deducted from their monthly wages in two years. The selected workers will

be given two months' compulsory training by trainers of the government, the minister said. They will be given train-

ing on Chinese and English speaking, child rearing, preparing Chinese food and housekeeping, said officials of the ministry.

Hong Kong is interested to recruit Bangladeshi housemaids, as its main sources of overseas domestic workers have started curbing the flow of their citizens. Earlier in September last

year, the Hong Kong-based South China Morning Post reported that the country and its employment agencies were looking for new labour markets following a ban on employment from its mainland maids. Around 97.6 percent of

Hong Kong's total housemaids were recruited from the Philippines and Indonesia.

The country is now facing shortage of housemaids as

the Philippines and Indonesia are not sending their women following reports of abuse, added the newspaper.

The recruiting agencies of Hong Kong had earlier held a series of talks with their government about opening a new window of workers from Myanmar and Vietnam in vain.

Expatriates' Welfare Secretary Dr Zafar Ahmed Khan said they had taken the decision to send Bangladeshi housemaids after necessary observations regarding workers' security.

"The Philippines is nar rowing its supply of housemaids as the country's economic condition has improved. We will monitor the entire process and work with the Hong Kong authorities to ensure our women safety," he told The Daily

Hong Kong would recruit the housemaids under an agreement between the Bureau of Manpower Employment and Training and the General Chamber o Hong Kong signed in May of

A Bangladeshi delegation led by Bureau of Manpower, Employment and Training Director General Begum Shamsoon Nahar visited Hong Kong in November last year and held talks with the authorities concerned in this regard.

At least seven workers were killed in a fire at Smart Export on Saturday in the

capital's Mohammadpur. The petitioner, Eunus Ali Akond, also urged the HC to order the government and the two garment factories to pay compensations to the family members of the deceased and the injured.

The garment workers were killed due to the negligence of the owners in taking adequate safety measures, the petition says.

The HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Mahmudul Hoque fixed today for hearing the petition.

## UN agency warns of new global bird flu threat

The UN food agency yesterday warned the world risked a surge in bird flu outbreaks unless countries strengthen their monitoring against dangerous animal diseases despite economic hardship. "The continuing interna-

tional economic downturn means less money is available for prevention of H5N1 bird flu and other threats of animal origin," Juan Lubroth, chief veterinary officer at the Food and Agriculture Organisation (FAO), said in a statement.

"Even though everyone knows that prevention is better than cure, I am worried because in the current climate governments are unable to keep up their guard," he was quoted as saying.

Yesterday, soon after the completion of both sides arguments, accused Sayedee began reading out loud a 10-page speech before the tribunal. During the time he cursed the prosecution, the witnesses against him and the investigation officers.

However, he read out the highlights of his speech ignoring the court's repeated objection. During the time, he swore upon Allah and claimed that the charges brought against him were fabricated.

He termed the hacked Skype conversation between former Tribunal-1 chairman Justice Md Nizamul Huq and an expatriate legal expert as an intervention of Allah. Sayedee, who also

claimed himself as preacher of Islam, said, "I pray to Allah to give the prosecution, investigation officer and the witnesses against me hedayet [to bring someone on the right path]. And if they do not deserve it, burn them and their families in the fire of turmoil physically and mentally, the way my family, I and my followers across the globe have suffered. Be hell their eternal resting place."

The prosecution objected the remark instantly, terming it "hypocrisy". The defence also reacted to the prosecution's objection and chaos brewed up in the tribunal Prosecutor Syed Haidar Ali later pacified the heat.

Chairman of the threemember tribunal Justice ATM Fazle Kabir then said the case was kept CAV (Curia Advisari Vult, a Latin legal term), which according to lawyers means that the verdict could be delivered any time.

He said the prosecution and the defence would be informed prior to the deliverance of the verdict. This was the second time

It, however, did not proceed against Suranjit, a minister without portfolio, since he had offered unconditional apology for his comments on war crimes trial on December 22.

The show-cause notice followed a December 23 report by Bangla daily Amai Desh, in which Suranjit was quoted as saying, "The next year is 2013. Verdicts [in cases] against 14 identified war criminals have already been prepared. Trial of these war criminals would be over anytime in 2013. Their death sentences will also be implemented. None will be able to resist it." Suranjit was asked to

explain his "imaginary comments" on verdicts in the cases pending with the tribunal. During yesterday's hearing, Abdul Baset Majumder,

a counsel for Suranjit, said his client's statements were distorted in the report. Suranjit never meant to lower the image and dignity

of the tribunal, said the

lawyer, adding that the min-

ister offered unconditional

apology if any portion of his speech hurt the administration of justice.

The tribunal, in its order, said the alleged comments did not seem to be prejudicing the cases pending with the court but could cause people to develop a wrong perception about the trial procedure.

"However, a responsible person should be restrained and careful in making any such comment on a subjudice matter...." The court also said, "This

tribunal legally expects that the responsible persons, especially those who are associated with the party in a m o n g power, shall prove their prudence in future restraining themselves from foretelling imaginary result of the case and time limit for disposal of sub-judice matters, in the interest of upholding independence of the tribunal and fair justice."

Earlier, the tribunal made similar observations while disposing of two contempt of court petitions against Awami League leaders Syeda Sajeda Chowdhury and

Matia Chowdhury.

Meanwhile, the tribunal yesterday accepted a petition filed by the prosecution for permission to submit additional evidence in the case against Jamaat leader Muhammad Kamaruzzaman.

The documents are -- two newspaper reports and a list of collaborators arrested in Dhaka after the Liberation

Bangla dailies Purbadesh and Dainik Bangla on December 31, 1971, published reports on arrests of 15 collaborators, naming Kamaruzzaman as one them. Kamaruzzaman's name was also there on the collaborators' list prepared by detectives between 1972 and 1973, the prosecution said.

Meanwhile, the security of the international crimes tribunals has been tightened in the wake of Monday's violence by Jamaat-e-Islami and its student wing Islami Chhatra Shibir to pressure the government to stop the war crimes trial.
