#### Pakistan says India beheaded 12 troops

Pakistan has accused India of decapitating 12 soldiers in cross-border attacks since 1998 and registered a protest with a UN watchdog, a newspaper reported yesterday, after deadly army clashes

earlier this month. The accusations are contained in a series of classified documents presented to the United Nations Military Observer Group in India and Pakistan (UNMOGIP), which monitors the disputed Kashmir border, according to The Hindu newspaper.

The report follows a series of killings of soldiers on both sides earlier this month along the de facto border known as the Line of Control (LoC).

Pakistan says three of its soldiers were killed in firing by Indian troops while India accuses Pakistani troops of killing two of its soldiers on January 8, one of whom was beheaded. Pakistan has denied responsibility.

The situation along the LoC has calmed since the two armies agreed a ceasefire on January 16.

In its complaint before the UNMOGIP, Pakistan is reported to have accused India of beheading 12 soldiers and killing 29 civilians since 1998.

The newspaper quoted an unnamed senior Pakistani army officer stating that they have "sought to downplay these incidents... Each of these incidents has been protested by us on both military and UNMOGIP channels".

# Tibetans in India launch drive against China

The Tibetan government-in-exile in India on Tuesday announced plans for a four-day campaign to bring global pressure on China in a bid to end a string of self-immolations in their Himalayan homeland.

Penpa Tsering, speaker of the exiled Tibetan parliament based in the northern Indian town of Dharamshala, said the drive would include rallies and meetings and begin in New Delhi on Wednesday.

"The situation is getting more and more grim," Tsering said at a joint news conference with Lobsang Sangay, who in 2011 took over political duties from revered Buddhist spiritual leader, the Dalai Lama, and was named prime minister.

The two leaders said 99 Tibetans had set themselves on fire between 2009 and January 22 this year in protest against Chinese rule in Tibet. Of that number, the government-in-exile says 83 have died.

"Instead of trying to address the main causes as to why self-immolations are taking place, as to why Tibetans are protesting in various other forms, the

Chinese government has resorted to a blame game," Sangay said.

"They blame us for the tragedy in Tibet which is absolutely baseless because Tibet has been under China's occupation for the last 50 years," the Harvard-educated scholar said.

Sangay said India, home to tens of thousands of Tibetan exiles, "ought to speak out forcefully on Tibet".

The four-day campaign will call for visits to Tibet by UN fact-finding teams and the publication of details of human rights discussions between Beijing and foreign powers, Sangay said. Both the Dalai Lama and the prime

minister have appealed to Tibetans not to resort to self-immolation.

Many Tibetans in China accuse the government of religious repression and eroding their culture, as the country's majority Han ethnic group increasingly moves into historically Tibetan areas.

China rejects that, saying Tibetans enjoy religious freedom. Beijing also points to huge ongoing investment that it says has brought modernisation and a better standard of living to Tibet.



# Doctors to rebuild Malala's skull

Doctors have revealed how they are going to repair a missing area of the skull of Pakistani schoolgirl activist Malala Yousafzai.

Surgeons at Birmingham's Queen Elizabeth Hospital have been giving details about two procedures due to be carried out on the 15-year-old.

She was discharged from the hospital earlier this month after being shot in the head by the Taliban in October.

The hospital said Malala's surgery would take place in the next 10 days. The first procedure will involve drilling into her skull and inserting a custom-made metal plate.

Doctors said Malala was completely deaf in her left ear after being shot at point blank range. The shockwave destroyed her eardrum and the bones for hearing.

Doctors said her full recovery could take another 15 to 18 months.

## 'I am safe in India'

Bollywood superstar Shah Rukh Khan has insisted he is "safe and happy" in India in a bid to end a controversy sparked by an article he wrote on being Muslim in the Hindu-majority country.

The piece led Pakistan's Interior Minister Rehman Malik to say that India should provide Khan with security. India's Home Secretary RK Singh responded curtly that Pakistan should look after its own citizens.

"Nowhere does the article state or imply directly or indirectly that I feel unsafe, troubled or disturbed in India," Khan said in statement.

Khan has been targeted by the Shiv Sena, a far-right Hindu nationalist party headquartered in Mumbai that has often pushed an anti-Pakistan and anti-Muslim agenda. "I would like to tell all those who are offering me unso-

licited advice that we in India are extremely safe and happy. We have an amazing democratic, free and secular way of life."

Khan emerged last week at the top of Forbes India's first Celebrity 100 list, based on income and popularity, after he raked in an estimated 37.7 million dollars last year.

## Troops enter last Mali bastion

'Most of ancient manuscripts safe'

French troops yesterday entered Kidal, the last Islamist bastion in Mali's north after a whirlwind Paris-led offen sive, as France urged peace talks to douse ethnic tensions targeting Arabs and Tuaregs.

French troops arrived at the Kidal airport just days after the capture of Gao and Timbuktu in a whirlwind three-week campaign that Paris hopes to wind down and hand over to African forces. France swept to Mali's aid on January 11 as the

Islamists advanced south towards Bamako, sparking fears that the whole country could become a haven for terrorists, and now has 3,500 troops on the ground.

But in the longer term, Paris regards a political settlement between the government in Bamako and Tuaregs seeking a degree of self-rule as crucial to Mali's stability.

Meanwhile, after reports fleeing Islamists had torched a building housing priceless ancient manuscripts in the city, an expert said many had been smuggled away before the insurgency. He said more than 90 percent of the manu scripts have been saved.

## Rushdie's Kolkata visit cancelled after protests



British author Salman Rushdie has abandoned plans to attend a publicity event for the film adaptation of his award-winning novel "Midnight's Children" in the Indian city of Kolkata after Muslim groups took to the streets to protest his visit.

Around a hundred protesters congregated outside the city's airport ahead of the Indian-born author's visit or Wednesday, airport officials said, the latest in a string of recent clashes over freedom of expression in India.

Rushdie's 1998 novel "The Satanic Verses" is banned in India due to its depiction of Islam, and the author was forced to abandon a visit to the Jaipur Literature Festival last January after protests and death threats against him.

"We will not allow him here. He is hated by all Muslims in the world. I thank the government of West Bengal for listening to us," said Idris Ali, chief of the All India Minority Forum, referring to the state of which Kolkata is the capital.



## New trouble for Pak PM

Pakistan's fugitive former oil and gas chief has been arrested in Abu Dhabi on suspicion of embezzling \$850 million in a scandal that could spark a criminal case against the prime minister, an official said yesterday.

Tauqir Sadiq was arrested a week after Pakistan's top court ordered a case to be registered against Prime Minister Raja Pervez Ashraf over the matter, raising pressure on the government as it nears the end of its five-year term in

Sadiq is accused of taking \$850 million in kickbacks and commissions while head of Pakistan's oil and gas regulatory authority between 2009 and 2011, at a time when Ashraf was water and power minister. Sadiq fled Pakistan last year.

On January 24, the court ordered a case to be registered against Ashraf, Interior Minister Rehman Malik and another member of the main ruling Pakistan People's Party over Sadiq's appointment in 2009 and absconding in 2012.
