and twin black rotors, stays airborne thanks to a small rechargeable battery. Soldiers can either pilot it

directly or program it to fly to a given set of co-ordinates on the battlefield using GPS, then return to base after spying on enemy positions. The Mail on Sunday was

last week given an exclusive demonstration of Black Hornet in Camp Bastion by soldiers from the Brigade Reconnaissance Force (BRF).

The 'recce' soldiers, who operate the tiny drone from a safe distance, and their commander, Major Adam Foden, explained how they had used Black Hornet with great success on recent missions into Taliban terri-Major Foden, 34, said:

'Black Hornet is a gamechanging piece of kit. Previously we would have sent soldiers forward to see if there were any enemy fighters hiding inside a set of buildings.

'Now we are deploying Black Hornet to look inside compounds and to clear a route through enemy-held spaces.

'It has worked very well and the pictures it delivers back to the monitor are really clear. And Black Hornet is so small and quiet that the locals can't see or hearit.'

On most operations the Black Hornet 'nanocopter' is controlled by a soldier using a computer game-style joystick. As the drone hovers near an enemy position, pictures are beamed back to a monitoring station. It delivers high-resolution still and moving images.

Pressing a button, a soldier can zoom silently on to a

target and the hum from Black Hornet's rotors is scarcely audible even from a distance of a few yards.

When Black Hornet is flown inside Taliban compounds it can barely be heard and is difficult to see against the grey mud walls of village compounds.

Enemy fighters, hiding among civilian populations in villages, would be unaware that the drone was watching them.

One BRF soldier said: 'It's a cool piece of kit. The pictures are amazingly clear and we can see who is a local civilian and who is a Taliban fighter and whether any weapons are being stored there. We can then make our plans accordingly. It saves a lot of time and a lot of mistakes. It can zoom right up to somebody's face and hold that frame for as long as is required without them even knowing it's there. It makes it possible to identify a highvalue target.'

While Black Hornet is a priceless tool in Afghanistan, it is unlikely it could be used on Britain's streets because of civil liberty concerns.

Before soldiers are allowed to use Black Hornet they are required to go on a training course which teaches them not just the drone's capabilities but also how it should be deployed.

The whole package, the helicopter, monitor and stick, fit into a pocket-sized case.

The Black Hornet - properly called a Proxdynamics PD-100 Persona Reconnaissance System - is a joint UK-Norwegian venture and was passed fit for service in Afghanistan after extensive field trials in Cyprus last year.

Damascus has threatened to retaliate, further fuelling fears of a regional spillover of the country's 22month conflict, which the UN says has already left more than 60,000 people dead.

Forty-eight hours after the reported strike, US Defence Secretary Leon Panetta told AFP Washington was increasingly concerned that "chaos" in Syria could allow Lebanon's powerful Hezbollah Shia movement to obtain sophisticated

Ahead of the air raid, Israeli officials cranked up the rhetoric about Syria's arsenal, which includes chemical agents, warning of dire consequences if they end up in the hands of the Iran-allied Hezbollah.

Israel and Hezbollah fought a devastating war in the summer of 2006.

In Damascus, Assad on Sunday accused Israel of seeking to "destabilise" Syria, state news agency SANA reported.

The raid "unmasked the true role Israel is playing, in collaboration with foreign enemy forces and their agents on Syrian soil, to destabilise and weaken Syria," he told Saeed Jalili who heads Iran's Supreme National Security Council.

Iran has joined UN Security Council members Russia and China in consistently backing Assad's regime throughout the almost two year-long conflict which has also forced more than 650,000 people to flee Syria.

After Khatib met Iranian and Russian representatives in Munich, speculation was rife over whether there had been a change in Moscow's position, but Syria's stateowned daily Ath Thawra said there has been no such shift.

"Bets that Russia would change its mind and modify its stance clash with its pol icy, which is commanded by its interests and strategic considerations," the daily wrote in an editorial.

Moscow is one of Assad's last remaining allies, and its support for the fight against rebels seeking to overthrow his regime "is becoming more solid each day," the paper said.

Russia has blocked three UN Security Council resolutions threatening sanctions against Assad over the crackdown in Syria, and has been accused by the armed opposition of being partly responsible for the bloodshed.

This year, a total of 13,03,203 examinees from 27,073 educational institutes registered for the exams across the country.

the global lender and the government had been scrapped.

"As long as the MoU is in place, the World Bank will help us, and we will also take their help in conducting investigation," he added.

The chairman made the remarks in reply to queries from journalists at the ACC office. Asked about the government's withdrawal of the request for WB funding, he said, "The government's schedule and that of the World Bank do not match, as the government wants to implement the project without delay."

Queried if the non-inclusion of former communications minister Syed Abul Hossain in the case had led to the present situation concerning the Padma bridge project, Ghulam said, "It proves the ACC does not yield to any pressure." He went on, "You guys [journalists] wanted to implicate him [Abul Hossain] as the World

Bank wanted to, even though there may or may not be documentary evidence for this. ACC will not give in to it."

The ACC investigation in the case would continue regardless of the latest developments, Ghulam reiterated. After a year-long enquiry into the graft allegation over Padma bridge project, the ACC on

December 17 last year filed the case against seven people for conspiring to commit bribery. The accused include former secretary of the Bridges Division Mosharraf Hossain Bhuiyan. But the anti-graft body did not include in the case Abul Hossain and former state minister for foreign affairs Abul Hasan Chowdhury.

ACC REPLYTOWB PANEL The Daily Star has obtained a copy of the ACC chairman's January 21 letter to Luis Moreno Ocampo, chairman of the WB external panel of experts.

Ghulam Rahman wrote the letter in reply to Ocampo's letter to him on January 9. In his letter, the WB panel chief expressed displeasure at the non-inclusion of Abul Hossain on the list of the accused in the Padma bridge corruption case. The absence of Abul's name on the list showed the ACC was not carrying out a complete and fair probe into the corruption conspiracy, he added.

Below is the ACC chief's letter to Ocampo.

Subject: Padma Multipurpose Bridge Project

I acknowledge with thanks the receipt of your letter of January 9, 2013 on the above subject and would like to reiterate and assure you ACC's told and unconditional commitment to conduct a fair, adequate, transparent, correct and complete investigation of the Banani police station case No. 19, dated December 17, 2012.

The ACC appreciate the Panel's offer or assistance in the fulfillment of its role, in particular to provide training for its staff and technical assistance such as forensic accounting and in investigative planning. ACC would welcome any assistance from the External Panel of Experts and the World Bank compatible with Bangladesh laws, rules and regulations. Visits and dialogue at Panel's convenience may please be considered.

I have asked the ACC's Investigation Team to prepare answers to the questions contained in your above mentioned letter. The Commission has reviewed the replies and annexed them with this letters for your perusal and advice.

In the body of the FIR the names of the former Communication Minister Syed Abul Hossain and former State Minister for Foreign Affairs Mr Abul Hasan Chowdhury have been mentioned as persons who held meetings with SNC Lavalin officials.

Syed Abul Hossain's name came up as the person who was met by the SNC Lavalin officials and Abul Hasan Chowdhury's name came up as a facilitator. Moreover, it was mentioned that their names were written in Ramesh Shah's notebook in reference to percentage allocation in the form of Padma PCC after award of contract. They were not included as accused as during enquiry there was no corroborative evidence, witness statements, etc that they were involved in the criminal conspiracy to take or give bribe.

In any case, in the investigation phase after rigorous scrutiny if Syed Abul Hossain and Mr Abul Hsan Chowdhury or any of them were found involved in the conspiracy, no leniency will be shown or their names will be shown and their names will be included in the charge sheet.

ACC is looking forward to working together with the World Bank's External Panel of Experts to bring to justice all those who were involved in Padma Multipurpose Bridge Project corruption conspiracy through a fair, adequate, transparent, correct and complete investigation.

I am also availing this opportunity to extend to you and to the members of the External Panel of Experts from my own behalf and on behalf of my ACC colleagues best wishes for your good health, great happiness and every success in 2013.

Taliban roadside bombs killed five civilians, including a family of four, and two police officers in the country's troubled south at the weekend, officials said Sunday.

The family -- mother, father and two daughters aged eight and nine -- died along with their driver in Helmand province's Khanishin district when their vehicle hit an improvised bomb late Saturday.

"The blast was so powerful that nothing was left of the bodies, they are shattered in small pieces," district governor Shah Mahmoud said, blaming Taliban insurgents Saturday to the temporary for the attack. Two police officers were
